



Lines of inquiry

This workstream will involve the assessment of the 2016/17 budget. It will seek to answer the following key questions:

- Including assessment of Internally Appropriated Expenses
- Bridging conservatism and realism mitigating the difference between budgetary pessimism and operating surpluses
- Does the proposed budget adequately consider prior recommendations arising from other reviews, including recommendations related to capital asset management?
- How was the balanced budget presented by the District to the VSB formulated to mitigate the impact on the classroom?
- Are there alternative budgetary refinements that may:
- Mitigate the impact on the classroom, or alternatively, displace certain aspects of the District's proposed budgetary constraints that will lessen classroom impacts;
- Be sustainable for future school year budget; and/or
- Not have an adverse impact on future budgets.



Its main points are that BC spends \$1,000 less per student than the provincial average (citing Stats Canada) and that K-12 funding has fallen from 3.3 % of GDP in 2001 to 2.5% in 2016. It also says downloaded costs are not covered by budget increases, naming things like MSP, Hydro, etc., and citing an analysis by BCASBO that says those costs totalled \$192 million between 2012-2013 and 2014-2015.

Request: I would like a comment from the government on those funding points. I will recognize in the article that you did not see the embargoed report.

Self-insurance means the Province does not buy insurance. The Province has an internal group in the risk management branch of MTICs. If a ministry asset is damaged, they go out and act as out claims adjuster. They get estimates and advise the ministry that suffered the loss on the extent of the damage and options / costs to repair (or not). The ministry that suffered the loss (in this case Education) has to decide how to proceed as they pay for it. Education would have to pay for Carelton repairs out of our Capital program. If it was decided the school would be repaired, this could also potentially delay another project we have in our Capital plan. There would probably be a Treasury Board decision as part of this process as well.
