

**Re: MLA First Nations Stakeholder Advisory Committee – Land Transfer
Recommendations**

I write to follow-up on a letter I wrote to you on August 29, 2016 concerning the recent report produced by provincial MLA Pat Pimm's "Stakeholder Advisory Committee".

In that letter, I was clear in conveying Blueberry's firm view that your government's complicity in this Committee process and resulting Report are contrary to the Province's historic and modern commitments to our Nation and to the honour of the Crown. I requested that your government formally disavow the Committee process and resulting Report and that you commit to taking concrete steps in advancing our TLE settlement on an urgent basis. I asked that you meet with Blueberry in person to confirm your government's commitment in this regard. We have yet to hear from you on these important issues.


On September 8, 2016, I met with your Chief of Staff, Steve Carr and Deputy Chief of Staff, Michele Cadario. I reviewed the enclosed briefing package concerning Blueberry's TLE land selections with your Chiefs of Staff. I described the history behind our TLE selections, which were tabled with BC in 2005 because of their fundamental importance to our Nation. I explained that these lands are central to our Nation's history, culture and way of life, and are vital to our community's wellbeing moving forward, in that they will fulfill critical residential and traditional use purposes.

At the September 8 meeting, I requested and was hoping to hear your government's disavowal of the Report; your Chiefs of Staff advised that they would "get back" to me. I also reiterated my request for an in-person meeting with you, but nothing concrete was promised. I haven't heard back from your Chiefs of Staff on either of these requests.

It has now been over a month since I wrote to you regarding the Report and our TLE lands. This matter is of significant urgency to Blueberry. The Province's provision of our TLE lands is the last major obstacle to settlement of this TLE claim that we have been working determinedly at

for over 10 years. We request a response to our concerns about the Report and a commitment from your government to moving forward with our TLE settlement at your earliest convenience.

Recommendation / Response:

- **Our legislation is clear: to provide real estate services in BC, a person must be licensed through the REC of BC. Providing or facilitating the provision of unlicensed real estate**

services is prohibited in BC. It is incorrect to suggest that a person licensed in another jurisdiction, or unlicensed all-together, can provide services in BC.

- Provincial regulators are actively pursuing and disciplining licensees and other individuals who provide real estate services without licenses. The Real Estate Council has the power to take action against real estate licensees who encourage or are engaged in unlicensed activity.
- The Superintendent enforces the prohibitions in the Real Estate Services Act against unlicensed activity, investigating and issuing cease and desist orders against individuals and businesses who provide real estate services without being appropriately licensed.
- Regulators are aware of Vanfun and its activities in the BC real estate market. The real estate council recently fined two licensees for collaborating with Vanfun referrals, and the Superintendent issued a cease and desist order against two other individuals who have been working with the site.
 - Shangren Vancouver Settlement Services Ltd. and its operators Feng ‘Fanny’ Ni and Xiao Wen ‘Wendy’ Ye have been ordered by the Superintendent to immediately cease providing unlicensed services in B.C. The Superintendent found unlicensed services were provided to purchasers of homes and were facilitated through the use of Chinese-language websites www.vanfun.net and www.vanfun.com. A freeze was ordered on a company bank account for further investigation.
 - Parties to the Orders may request a hearing before the Superintendent or otherwise appeal the Superintendent’s Orders to the Financial Services Tribunal.
 - In July 2016, the Real Estate Council issued a related disciplinary order against licensee Xiao Ming ‘Alban’ Wang for facilitating Vanfun’s unlicensed real estate services. Mr. Wang’s real estate licence was suspended for 12 months and he was ordered to pay \$10,000.
 - The Real Estate Council has also taken action against Xin ‘Selena’ Li for encouraging unlicensed activity by providing real estate services and paying referral fees to an unlicensed entity. In August 2016, Ms. Li received a seven-month suspension and was ordered to pay \$10,000.
- Many licensees are reporting that they are being approached by unlicensed entities offering to provide lead generation as a business, which is offside our legislation. Many are reporting this activity to the regulators. RECBC will continue to work closely with the

Superintendent to address unlicensed activity. Licensees need to report this activity – even anonymously – so that the regulators can respond.

- **Real estate licensees must protect consumers, as well as themselves and the integrity of the real estate market, by upholding their professional responsibilities and not facilitating unlicensed and non-exempt real estate services in B.C.**
- **Recent amendments to the Real Estate Services Act significantly increase the penalties against licensees and against unlicensed individuals or companies. Maximum penalties for individuals will rise from \$10,000 to \$250,000 per contravention. Penalties for brokerages or unlicensed companies will rise to \$500,000 per contravention, from the current maximum of \$20,000. In addition, under the amendments licensees can be required to give up any commissions or other remuneration received in respect of a trade for which they have been disciplined.**
