Hi Neil,

The call for appointments for BC's vacant seat is already public – I think it was posted July 7.

For the Background section of the document, I'd recommend something along the following lines:

Background

- Senators are appointed by the Governor General on the advice of the Prime Minister.
- The federal government recently established an Independent Advisory Board for Senate Appointments, to
 provide the Prime Minister with non-binding short-lists of candidates for Senate seats guided by public, meritbased criteria.
- On March 18, 2016, the federal government announced seven Senate appointments made under a transitional appointment process.
- Subsequently, the Board established a permanent process under which individuals may submit applications for the Board to consider in filling vacant Senate seats. An initial application deadline of August 4, 2016 was set for twenty seats (nineteen existing vacancies and one upcoming vacancy), including one vacant BC seat.
- The Advisory Board consists of five members: three federal members plus two ad hoc members from the province or territory of any vacancy to be filled. The federal government has invited provinces and territories to propose names of these ad hoc members. BC's government has declined to put forward any names, and will not participate in the federal appointment process.

- Senate vacancies can occur due to retirement, death or resignation of a sitting Senator. Barring deaths or resignations, the next two BC vacancies due to retirement are expected on May 11, 2018 (Senator Nancy Greene Raine) and November 6, 2019 (Senator Richard Neufeld).
- In the absence of vacancies: ON and QC have 24 seats each; NB and NS have 10 seats each; BC, AB, SK, MB and NL have 6 seats each; PE has 4 seats; and the three territories have one seat each.

I think the Key Messages section should probably stick a bit closer to PCC's December 3 statement, possibly supplemented with some language from a letter she wrote to Minister Monsef on May 10. However, I'm going to double-check this and will try to get back to you tomorrow.
