Geoff,

We have not had the pleasure of meeting. Permit me to introduce myself. I am the President & CEO of TimberWest. We are a proud BC company operating on the coast for over a century. Our team manages Western Canada's largest private timberland on behalf of our shareholders - British Columbia Investment Management Corporation and the PSP Investments (Federal public servants pension fund manager).

As you and Premier Horgan prepare to depart on next week's important visit to Ottawa and Washington, D.C. on the softwood lumber file, we wanted to take the opportunity to provide you with some context and perspective as to how the issue of log export restrictions in BC is intersecting with the overall Canada-US softwood negotiations.

As recently as last week, the Canadian Federation of Woodlot Owners (CFWO) (representing private timberland owned by over 450,000 families across the country including BC) put forward its position regarding how private timberland ought to be treated in the future softwood lumber agreement. In its July 11, 2017 media release (attached), the CFWO set out its demand for an exemption for lumber produced from Canadian private woodlots. One example the CFWO put forward is the free flow of sawlogs from woodlot owners across the border to sawmills in the US; the CFWO highlighted that in the case of BC, which is the single exemption restricting the export of private owner sawlogs to the US, the Americans have made their displeasure very clear.

Specifically, the US Department of Commerce April 24, 2017 report on "Preliminary Determination in Countervailing Duty Investigation" highlighted BC log export restrictions as a significant subsidy.

As the Governments of British Columbia and Canada push forward to reach an acceptable softwood lumber agreement with the US, there's an opportunity for Premier Horgan to address and solve the log export restrictions issue raised by woodlot owners across Canada and identified by the US Department of Commerce.

You will be interested in the May 7, 2017 Globe and Mail article by Barrie McKenna entitled "Angry about US duties on Canadian lumber? Blame BC" where the Globe & Mail makes the point that a significant chunk of the penalty the US is hitting Canada with is due to log export restrictions that exist only in BC. The Globe & Mail suggested in its article that Christy Clark is to blame. So possibly there's an opportunity for Premier Horgan to pivot on this issue and use it as a bargaining chip to secure a broader deal that will be acceptable to both the US Commerce Department and the US Lumber Coalition? (Globe & Mail story attached).

We hope this background is helpful as Premier Horgan initiates his engagement on the softwood discussions in Washington, DC. It may well be a factor in the process to reaching a final agreement. Please do not hesitate contact us if you require any further details or clarifications.

Hi Geoff,

As mentioned, I think it's important to clarify the next steps of the hiring process. Here is what I would like to propose for the following key roles moving forward.

Goal: Professionalize our HR practices and hire diverse, energetic and political people who want to build a better BC.

Roles & Responsibilities:

1. Maura Parte (PSA Contract until September 30th)
 - a. Primary Responsibility would be to support the transitional MA's and create a training guide for the next round of hires
 - b. Write initial draft of MA job description
 - c. Provide a report on all of the positions that we need to hire (including MA's, Admin Coordinators, Outreach Caucus Staff, Issue Managers, and perhaps communications positions within GCPE)
 - d. Maura to meet with all the transitional MA's to understand if people would like to stay on as an MA or other role. If they are interested in being an MA, they would still be required to go through an interview process.
 - e. Participate in interview process
2. Mira Oreck (OIC Appointment)
 - a. Facilitate screening calls and welcoming folks to the opportunity of working with an exciting new government
 - b. Develop a short list of those that should proceed to the next steps of the hiring process
 - c. Participate in interview process
3. Una Walsh (OIC Appointment)
 - a. Developing a ranking system for interviewers to use
 - b. Review job description and format appropriately
 - c. Salary Grid – create simple and clear salary levels based on title (below should be set up based on the band system). This needs to be clear to avoid issues between MA's.
 - i. Senior/Issue Managers: 94,500
 - ii. Junior: 75,000
 - iii. EA: 55,000
 - d. Help set up HR process, job descriptions, etc within the Premier's Office

Interview Process:

1. Maura and Mira create interview questions, with consultation from Una Walsh
2. Once the short list is confirmed, Mira and Maura work together to split up the list of interviews. I would recommend that Una and I also split and act as the secondary person sitting in on these interviews.
 - a. Interviews should be in person unless otherwise unable
3. Everyone MUST use the same ranking system

Slotting:

1. Someone (Admin Support?) take the ranking system and create grids of people accordingly
2. From there, slot people into the appropriate roles as set out by positions available

Confirmation:

1. Take final list and slotting to Geoff, with some ability to move people around, for final sign off.
2. Geoff can decide to take the time to call through Senior folks or more people as needed – potentially meeting if required

Deadlines by Date:

1. Screen calls completed: July 25th
2. Interviews begin: July 27th
3. Deadline for final decision: August 4th
4. Deadline for calling through those that don't get hired: August 11th
5. Start Date: ASAP

Potential Issues for Consideration:

- There is technically no one "in charge." With that said, it will be important for each other to fully understand each other's roles in this process.
- Who leads the slotting exercise? It is unclear to me whether this can be collaborative or not.
- A note needs to come from you regarding the hiring process for MA's. I would imagine that some have been promising jobs and it would be nice to at least understand where some folks may be at. It should not interfere with the process, but someone should at least know for managing purposes.

I will leave it up to you to edit as you see fit and send to relevant individuals.







Dear Geoff and Sage

I am a refugee lawyer practicing in Vancouver. I am the vice-president of the Canadian Association of Refugee Lawyers (CARL). I know that today is a big day for you and your office. I am writing because of an urgent timeline that CARL wants to make sure that your office is aware of – Legal Services Society (LSS) announced last month that, without an increase in funding, as of August 1st they would cut all services for refugee and immigration cases until the next fiscal year (April 2018). It is LSS's position that due to the increase number of refugees seeking LSS funding and the lack of corresponding increase in funding, they have run out of money.

As far as we know, as of today, LSS has not received additional funding from the Federal government. We wanted to give your office a heads up that this deadline is coming up very quickly.

We are deeply concerned about the prospect of cutting legal services for refugee claimants. It is easy to imagine the impacts of these cuts – families who will have just arrived, having escaped trauma, will be navigating complex legal proceedings without counsel. It will also cause chaos among refugee and immigrant serving NGOs in Vancouver, who have already said that they are unable to fill in the gap if lawyers are not funded to do this work.

I am happy to talk to you more about the issue. It is our view that we need some level of government, whether that be Federal or Provincial, to act immediately to at the very least provide bridge funding so that the August 1st deadline can be avoided.

As mentioned, I think it's important to clarify the next steps of the hiring process. Here is what I would like to propose for the following key roles moving forward.

Goal: Professionalize our HR practices and hire diverse, energetic and political people who want to build a better BC.

Roles & Responsibilities:

1. Maura Parte (PSA Contract until September 30th)
 - a. Primary Responsibility would be to support the transitional MA's and create a training guide for the next round of hires
 - b. Write initial draft of MA job description
 - c. Provide a report on all of the positions that we need to hire (including MA's, Admin Coordinators, Outreach Caucus Staff, Issue Managers, and perhaps communications positions within GCPE)
 - d. Maura to meet with all the transitional MA's to understand if people would like to stay on as an MA or other role. If they are interested in being an MA, they would still be required to go through an interview process.
 - e. Participate in interview process
2. Mira Oreck (OIC Appointment)
 - a. Facilitate screening calls and welcoming folks to the opportunity of working with an exciting new government

 - c. Participate in interview process
3. Una Walsh (OIC Appointment)
 - a. Developing a ranking system for interviewers to use
 - b. Review job description and format appropriately
 - c. Salary Grid – create simple and clear salary levels based on title (below should be set up based on the band system). This needs to be clear to avoid issues between MA's.
 - i. Senior/Issue Managers: 94,500
 - ii. Junior: 75,000
 - iii. EA: 55,000
 - d. Help set up HR process, job descriptions, etc within the Premier's Office

Interview Process:

1. Maura and Mira create interview questions, with consultation from Una Walsh
2. Once the short list is confirmed, Mira and Maura work together to split up the list of interviews. I would recommend that Una and I also split and act as the secondary person sitting in on these interviews.
 - a. Interviews should be in person unless otherwise unable
3. Everyone MUST use the same ranking system

Slotting:

1. Someone (Admin Support?) take the ranking system and create grids of people accordingly
2. From there, slot people into the appropriate roles as set out by positions available

Confirmation:

1. Take final list and slotting to Geoff, with some ability to move people around, for final sign off.
2. Geoff can decide to take the time to call through Senior folks or more people as needed – potentially meeting if required

Deadlines by Date:

1. Screen calls completed: July 25th
2. Interviews begin: July 27th
3. Deadline for final decision: August 4th
