## Province moves to defend B.C. from pipeline expansion and increased tanker traffic

VICTORIA – The province is moving forward with three important steps to defend British Columbia's interests in the face of the expansion of the Kinder Morgan pipeline, Environment and Climate Change Strategy Minister George Heyman and Attorney General David Eby announced today.

"A sevenfold increase in bitumen tankers in the Vancouver harbour is not in the best interests of B.C's economy or our environment," said Heyman. "We will use all available tools to protect our coastal waters."

First, the Province has secured the services of Thomas Berger, QC, OC, OBC. Mr. Berger will serve as external counsel and advisor to the government on the Trans Mountain Expansion pipeline project, and will review current legal action taken by the Squamish Nation against the federal government and Trans Mountain.

Second, the Province will be seeking intervenor status to allow British Columbia to participate in legal challenges to the federal government's approval of the pipeline expansion. Hearings are scheduled to begin in federal court later this fall.

Third, the Province will fulfill its duty of meaningful consultation with Indigenous people, including consultations that meet the requirements regarding Aboriginal rights and title — as identified in a number of court cases — and those relating to provincial permits and environmental assessment certificate (EAC) requirements. Until these consultations are completed in a way that meets the Province's legal obligations, work on the project on public lands cannot proceed.

"With the appointment of Thomas Berger, B.C. has brought in the finest legal talent to advise the government on the Squamish Nation's claims, Indigenous relations and the specifics of this case," said Eby.

"In the coming weeks we will be reviewing policies to outline how our government expects to further meet our commitments to First Nations as well as to all British Columbians with regard to defending our air, land and water," said Heyman. "This policy review will help clarify government policy for decision-makers as they evaluate future permits and work plans."

The Province is continuing to explore other mechanisms to hold Kinder Morgan's project plans to the high standards of environmental protection and Indigenous consultation British Columbians expect.
