#### A. <u>ITEMS FOR DISCUSSION/DECISION</u>

#### 1. Premier's Opening Remarks

The Premier reviewed the agenda and referred to significant national reports upcoming on Health care Reform. He noted the requests of the Annual Premiers' Conference in Halifax for the Prime Minister to meet with Premiers before responding to the Romanow report, tabling the federal budget and prior to a final decision on ratification of Kyoto.

#### 2. For Decision: Graduation Requirements

Cabinet reviewed a submission "Proposed Changes to High School Graduation Program and Graduation Requirements", dated September 4, 2002.

Cabinet approved Option 3 of Graduation renewal aimed at increasing student choice and flexibility in earning credits in grades 10-12, in permitting locally developed courses, broader measures of student achievement, focus on education and employment planning and in changing the Grade 12 exam system for key subject areas and optional academic choices.

Consultation on this option will commence this Fall, with final changes to be announced in early 2003 for staged implementation beginning in September 2003.

#### 3. For Information: Community Charter Update

Cabinet received a briefing on the extensive consultations on the Community Charter, which will continue over the winter of 2002. The term of the Community Council was approved to be extended to February 28, 2003 and legislation for the Community Charter will be introduced in the Spring session 2003.

## 4. For Information: Progress Report on BC Employment and Assistance Program

Cabinet received a presentation noting the trends of income assistance for 2001/02, and the increase in numbers of jobs created, and the success of placing people into jobs.

## For Information: Update on Pharmacare Pressures

Cabinet received an update on the general principles to an income-based Pharmacare system that is to be effective January 1, 2003.

The Minister of Health Services outlined the principles that will ensure fair access to medications based on ability to pay. The plan will be comparable in terms of its benefits to other plans in Canada, and will maintain universal catastrophic insurance coverage. Health Ministers and Premiers across Canada have been developing a common formula for scientific review and cost-effective management of Pharmacare-type programs.

#### 6. For Information: Update on the Health Professions Act

Cabinet received an update on the consultation paper on the amendments to the *Health Professions Act*.

In view of input from the 21 self-regulating health professional colleges and other interested parties, the Minister of Health Planning has extended the consultation period through the fall, with legislation planned for the spring.
