## **Creating jobs in BC & celebrating our cultural ties**

I recently returned from my sixth international trade mission, third to China, since becoming Premier. Trade missions are primarily about helping connect BC businesses to new opportunities in growing markets abroad – but this mission was also about something else: celebrating cultural connections.

For 20 years, British Columbia has been a sister province of Guangdong, China's most populous province. The ties between us run deep; many British Columbians of Chinese descent trace their heritage back to Guangdong.

Make no mistake: those cultural connections are a competitive advantage, one that directly lead to jobs in BC. For example, I met with the leaders of Poly Culture, China's largest arts and culture company, where they announced their North American headquarters will be coming here.

Trade missions are also about looking to the future. That's why we signed significant agreements with Guangdong to work together on clean energy, clean tech and climate change.

The pace and scope of the economic transformation taking place in China almost beggars belief. In the next 15 years, China's middle class is expected to grow by 326 million; more than the total population of the United States. Lifting hundreds of millions of people out of poverty will take a lot of energy – which in China, currently means burning coal.

If China switched even a fraction of that to natural gas, it would mean a reduction in emissions equivalent to all greenhouse gas emissions in B.C. – every car, school, house, and factory in the province – for 18 months.

In BC, we've proven it's possible to grow our economy while reducing emissions. The biggest difference we can make against climate change would be to help large emitters like China do the same.

And we made progress on just that – Woodfibre LNG, one of 20 proposed projects in BC, signed initial agreements with Beijing Gas Group and Guangdong Yudean Natural Gas Co. to supply LNG for decades to come.

Natural gas is just one way we can help China clean their air and environment. We were also joined by companies from around the province to sign significant clean tech agreements.



Istuary Innovation, Canada's largest technology incubator, signed eight agreements to establish more than \$100 million worth of venture capital funds to bring ideas from BC tech companies to China.

Bradley Pacific Enterprises, signed an agreement with the City of Wuxi to establish a clean and environmental technology investment company, headquartered in BC, to invest in water treatment, waste recycling and air pollution control.

Representatives from the China Canada Clean-Tech Innovation Center, a BC-based joint venture, also joined us. They'll invest millions in clean technology and connect BC businesses with Chinese investors.

Nearly a decade ago, we began the hard work to expand our export markets in the growing economies of Asia. We knocked hard on doors in China, knowing that our longstanding cultural and trade relationship would pay dividends – and it has. Exports have increased 375 per cent – but that's just a number. Ask the people at Woodfibre, Istuary Innovation, or Bradley Pacific...or better yet, ask the people they're going to need to hire.

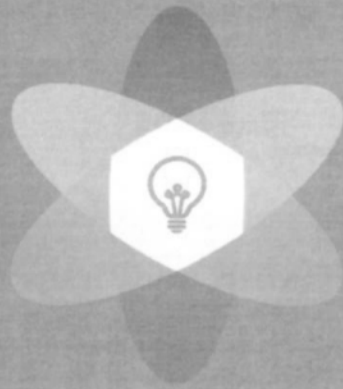

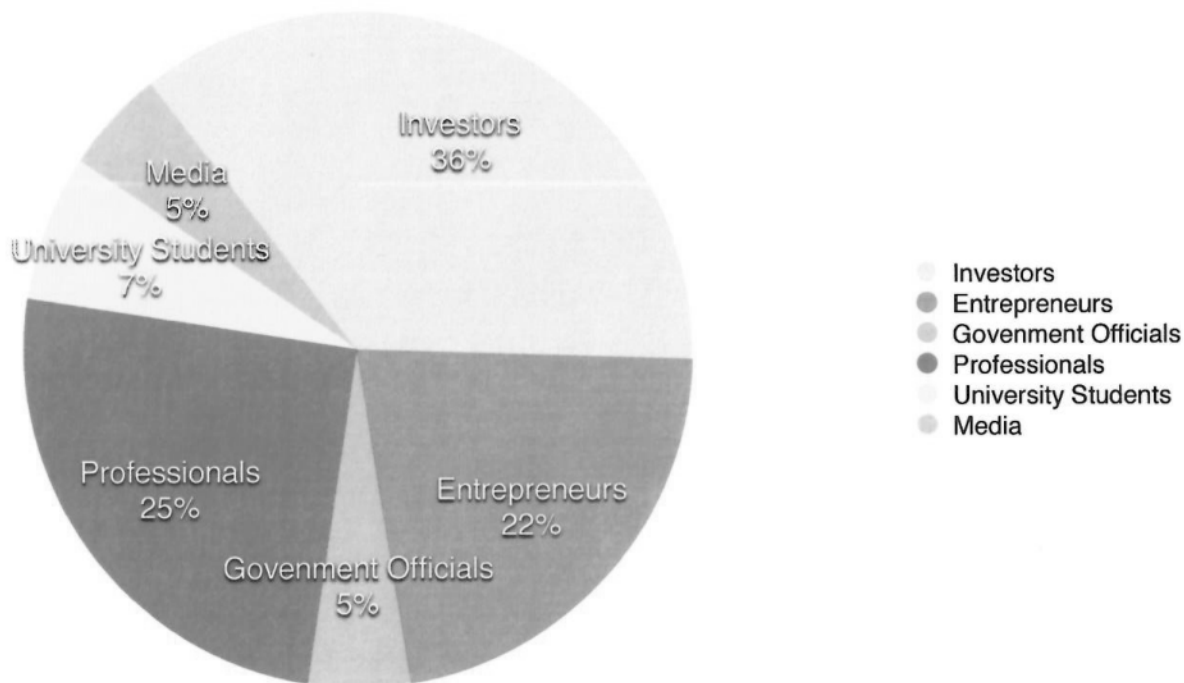

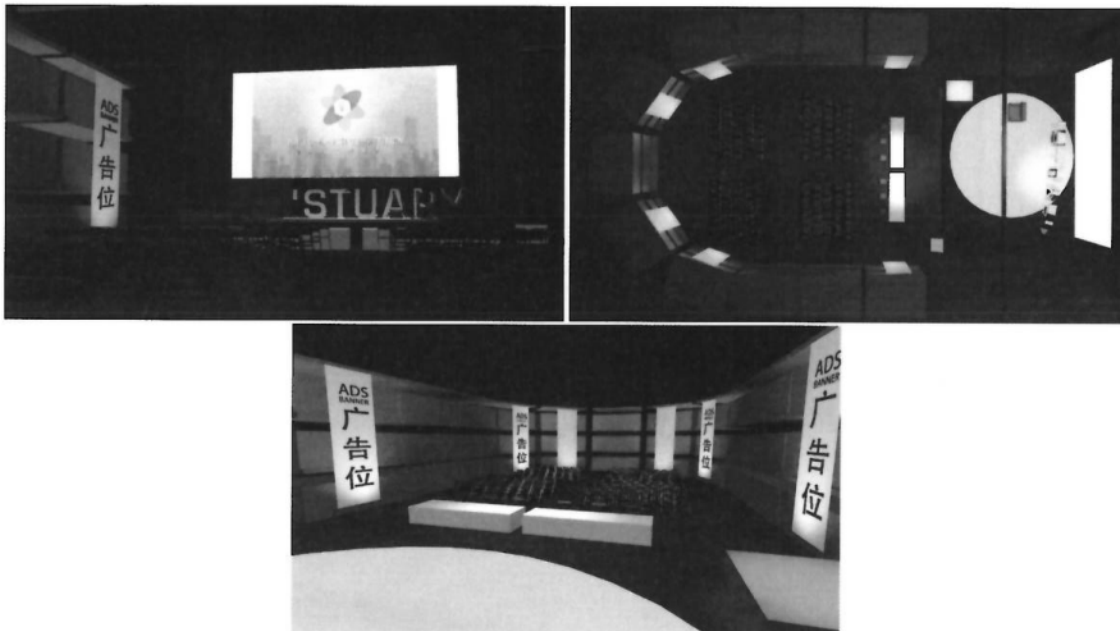

Like British Columbia, Shenzhen is known for innovation and entrepreneurs. And like BC, home to many successful information and communication tech companies like Huawei, who I met with this morning.

That starts with the MOUs Governor Zhu and I have already signed:

- To cooperate on low-carbon development, and energy efficient construction.

- And to expand and strengthen trade and two-way investment, in areas such as clean technology, ICT/digital media and natural resources.

We anticipate many more such agreements. Because Shenzhen's priorities align perfectly with BC's strengths:

- Environmental technology
- Life sciences
- Information and communication tech
- Financial services
- Education
- Advanced manufacturing
- Agriculture
- And clean energy

Let me touch on three of those examples.

## **CLEAN ENERGY**

First, clean energy. As China's demand for natural gas doubles in the next 6 years, BC's emerging LNG export industry is poised to be a partner with Shenzhen.

We plan on becoming one of the world's leading LNG exporters. And Dapeng Bay is about to become the 2nd largest LNG receiving area in the world.

Right now, there are 20 active projects at various stages of development in BC.

Over 30 investment partners are involved, and between them, they have invested some \$12.5 billion. They include CNOOC, PetroChina, and Sinopec. And Shenzhen Gas has also expressed interest in LNG opportunities in BC.

## **CLEAN TECH**

Second, another area Shenzhen and BC have in common is a focus on clean tech.

I mentioned the MOUs I have signed with Governor Zhu. But it's not just governments signing deals.

Ballard Power Systems is BC firm – you may be familiar with them, as they have an office here.

They have signed deals to provide the City of Foshan with prototype fuel cells for urban transit trams, and both Foshan and Yunfu with fuel cells for buses.

### **ICT**

Finally, Information and Communication Technology are blooming in both Shenzhen and British Columbia – and we both have a plan to further develop the industry.

I've just come from Huawei, which signed a smart city initiative with one of Canada's largest telecommunications firm, Telus, and announced they will test and deploy new "5G Oriented" wireless technologies in Vancouver.

A number of B.C. companies are active in Shenzhen, including Fireswirl, Sierra Wireless, Epic Data and Incognito Software, who is here today.

I want to mention one in particular – Istuary Innovation, which is Canada's largest technology incubation platform.

Istuary decided to place their China head office in Nanshan District. They're working with China General Nuclear here in Shenzhen...

And with its Chinese partners, is establishing a RMB 100 million venture capital fund.

Agreements like these are the reason we are here. To build on the old cultural and ancestral ties between our peoples....

And turn them into opportunities that benefit us both.

For example, my government has a goal of attracting \$100 million in investment to Vancouver by enticing Asian companies to move their head offices to the world's most Asian city outside of Asia.

HQ Vancouver has been instrumental in helping a number of Chinese companies.

For example, China Fiber Optic has started a project in B.C. to produce ceramic ferrules for its fiber optic patch cords.

They expect to enter into large-scale production this year: 72 million ferrules every year – worth \$100 million.

This is great news, and a perfect example of how a major Chinese company is capitalizing on the growth potential in our province.

They're coming to Vancouver because BC is a smart investment.

- BC is Canada's Pacific Gateway and transportation hub
- BC was the first subnational government to issue RMB bonds
- Our tax competitiveness is the best in North America with a corporate income tax rate of only 11%.
- And B.C.'s workforce is multicultural, multilingual, and among the best educated in the world.

## **CONCLUSION**

In BC, we have a unique view on China. We have long ancestral ties, as well as fast-growing trade and business connections.

But it's more than that.

When we look at China, we see our future. Our mutual strengths compliment each other perfectly.  
That's what we see from British Columbia.

And as Mr. Ma discovered when he flew with Viking Air...the view is beautiful.
