<b>ISSUES:</b>	<b>Proposed federal tax changes for private corporations</b>
<b>SUGGESTED MESSAGES:</b>	s.13,s.16
<b>BACKGROUND:</b>	<p>The 2017 federal budget pledged to address specific tax planning strategies that are used by private corporations.</p> <p>In response to the increased use of private corporations compared to other business entities, on July 18, 2017, the Department of Finance released a consultation paper discussing three specific advantages for private corporations and the proposed solutions to the identified problems: income sprinkling, passive investments and converting business income to capital gains. The consultation period is open until October 2, 2017.</p> <p>These tax planning mechanisms are only available to incorporated business with very high incomes.</p> <p>Business owners that use these tax planning mechanisms have been vocal about their opposition to the proposed changes. s.13,s.16</p> <p>s.13,s.16</p> <p>Media reports of public reaction to the proposed changes have largely been negative s.13,s.16</p> <p>s.13,s.16</p>

Doctors are split in their support or opposition to the changes. Those who support the proposed changes argue that they are not in a position to take advantage of the tax planning mechanisms and the tax system should not be used to indirectly address things like paid leave for maternity.

**C. Oakes:** Small businesses, across this country and here in British Columbia, have expressed alarm about the proposed federal tax changes and the affects it will have on middle-class small business owners.

Today in Ottawa, the Premier chose not to stand up for British Columbians, saying this came out of the blue. A disappointing defense of job creators here in British Columbia. To be clear, this has not been out of the blue. In fact, the consultation period ended just yesterday.

I would ask the minister of small business, but since this government doesn't have a minister of small business.... To the minister of job loss: can he table the letter or submission from his government to the federal government about the impact these tax changes will have on middle-class small business owners?

**Hon. C. James:** Thank you to the member for raising the issue. Certainly, all of us have heard the concerns of small businesses. As the member knows, this is a matter of federal jurisdiction. Perhaps she and her colleagues would also like to talk to their federal colleagues and express the views of small businesses — that small businesses would like a longer consultation process, would like more information on the federal tax.

In the meantime, we will continue to do our good work to support small businesses, including lowering the small business corporate tax rate in this province.

**C. Oakes:** I will take it from the Minister of Finance that the government has not put forward a submission or a letter into the federal government.

You know, this government is already making it difficult enough for small businesses. They're raising taxes, reducing business competitiveness, all the while opposing job generators like Site C and the George Massey replacement project, just to name a few. Projects that, I would remind members on both sides of this House, are important in every part of this province. British Columbians need somebody in their corner now.

Will the minister write to Ottawa and make it clear these proposed changes will have a devastating impact?

**Hon. C. James:** I can tell the member across that small businesses have expressed that they are thrilled to have someone standing up for them once again in British Columbia. Because, member whether it is our investments in education to ensure a well-trained workforce, whether it's our investment in housing to ensure that employees have housing, whether it's our investment in dropping the corporate tax rate for small businesses or the PST on electricity, we are standing up for small businesses, and we will continue to do that, member.

CBC – Premiers want federal tax proposals on agenda at first ministers' meeting / Some provinces have publicly expressed concerns recently with corporate tax changes

- Premiers have publicly expressed concerns with changes recently, including leaders from Nova Scotia, Newfoundland and Labrador, and British Columbia
- PMO says there will be a discussion around tax reform and federal finance minister Morneau will be part of it.
- Morning devoted to Indigenous issues. Afternoon devoted to an economic update and a debrief on Canada-US relations (NAFTA) / lunchtime presentation on economic growth and job creation

Comments made on federal tax proposal & FMM today and in the past week:

- **NOVA SCOTIA** – Premier McNeil is concerned about the impact the tax changes could have on health care recruitment (NS is dealing with a family doctor shortage)...and says it's an important tool for small business owners, allowing them to reinvest in their business or weather a change in the economy. On NAFTA – McNeil says issue of point of origin is important for province in terms of exports. Looking at the dispute mechanism is an important piece (CBC, Sep 28)
- **NEWFOUNDLAND** – Premier Ball says federal government needs to do a better job explaining the consequences of its tax proposals (CBC, Sep 28)
- **BRITISH COLUMBIA** – Premier Horgan said he expects tax reforms will be "topical at FMM" (Ian Bailey/G&M tweet, Sep 24) / Finance Minister Carole James said she didn't think Ottawa had consulted enough on an issue that has spread fears of the 'unintended consequences' for small business owners. James told business leaders after a speech that she believes in closing what Ottawa has described as 'tax loopholes', but "I also believe that there wasn't good consultation done. I have heard from many people, including many small business owners that this doesn't close loopholes. In fact, it causes unintended consequences for many business owners (CBC, Sep 22)
- **MANITOBA** – Premier Pallister: "There is no room here for class warfare. The communications department in Ottawa have chosen to use language like 'loopholes, tax evasion' – recriminatory and accusation language that has no place in this discussion. These proposed changes will take millions of dollars out of the hands of Manitobans and deliver them straight to Ottawa." (CBC, Sep 22)

- **ALBERTA** – Premier Notley hopes the feds strike a balance by ensuring tax fairness without stifling economic growth. “Everything that the federal government does should be very sensitive to the fact that we are in the beginning of a recovery here in AB” (National Post, Sep 23)
- **YUKON** – Premier Silver says he agrees with Yukon business organizations and wants to see a longer consultation period before the federal Liberal’s impose proposed new tax rules Yukon. “75 days for a review, that might not be enough time. You really need to consider the reactions here.” Yukon News, Sep 27)

ANGUS REID POLL: Liberal government’s proposed changes to small business taxation appears to be affecting public opinion. New poll released today – 45 percent say it’s time for a change in government. Trudeau still seen as best PM (33% to Sheer’s 18%), but Conservatives ‘best to form government’ (36% to Lib 33%)



The consultation process on the proposed changes to private corporation tax laws has shown there is significant concern and confusion in the business community as to the effects of these changes. While proposed changes to tax systems always promote debate and discussion, my government has received a substantial number of enquiries from business owners who remain unsure as to the scope and impact of the proposed changes.

Prince Edward Island is experiencing tremendous growth - leading the Atlantic region and other provinces according to many key economic indicators. Much of this growth is thanks to the entrepreneurial spirit, risk-taking and confidence exhibited by our small and medium-sized business leaders. For these economic leaders to remain confident and continue to invest and drive growth, they need to clearly understand the tax regime in which they will operate. Any confusion or unintended consequences of the changes will have a significant dampening effect on future growth of our economy.

Prince Edward Island's economy is almost exclusively of small and medium sized businesses. For example, agriculture and fisheries are cornerstones of the Prince Edward Island economy. Farmers and fishers have been investing and growing their businesses. These businesses have been increasing in size and evolving in complexity. Approximately 25% of family farm businesses are incorporated and many fishing businesses are now moving to incorporate. Concern has been voiced that the proposed changes to capital gains rules could be an impediment to intergenerational succession of these businesses. Questions also remain as to how rented farmland and AgrilInvest funds will be treated in the new proposals.

The concerns or questions raised in the context of agriculture and the fishery extend to other economic sectors. For example, the issue of intergenerational business succession has broad application. As you are aware, the Chambers of Commerce have raised a number of concerns. My greatest overall concern is for business confidence, a measure on which Prince Edward Island has been among the leading provinces for an extended period.

In light of this concern and the need for greater clarity, I encourage you to extend the consultation period and defer implementation of any changes until there has been time to provide future detail on these matters to business owners and the provinces.













# Passive Investment Income

---

## *Key facts:*

There are currently around **1.8 million** Canadian Controlled private corporations (CCPC). Some individuals hold multiple CCPCs. In 2015, **280,000 CCPCs earned passive investment income** that may have benefitted from tax deferral advantages.

What we know is that of the pool of passive investment income we are focused on, **80% of it was earned by 29,339 corporations—less than 2% of all private corporations.**

83.3% of the pool of passive investment income we are looking at is earned by owners **who earn \$250,000.**

# **First Ministers Meet to Discuss Shared Priorities for Canadians**

Ottawa, Ontario – October 3, 2017

Prime Minister Justin Trudeau today hosted a First Ministers' Meeting with provincial and territorial premiers.

First ministers took stock of the economy and discussed measures to grow the economy and create well paying jobs for the middle class and those working hard to join it. The discussion was informed by presentations by the Governor of the Bank of Canada, Stephen S. Poloz, and the Government of Canada's Chief Statistician, Anil Anora, who gave updates to first ministers on trends in the Canadian economy. The Prime Minister and Premiers emphasized their shared objective of promoting jobs and growth for Canadians and had a collaborative discussion on trade promotion and investment, interprovincial trade, innovation, supporting skills and labour market development, and increasing access to data and evidence-based decision making. Canada's Finance Minister, the Honourable Bill Morneau, also spoke to premiers about the Government's plan to change a tax system where wealthy and high income individuals can use their corporations to pay lower rates of taxation than hard working middle class Canadians. Minister Morneau also noted that the Government has conducted consultations to listen to small business owners, professionals and experts to ensure a fair approach.

The Prime Minister and premiers also had a discussion on Canada-U.S. relations, including the modernization of the North American Free Trade Agreement (NAFTA). Canada's Minister of Foreign Affairs, the Honourable Chrystia Freeland, and Canada's Ambassador to the United States, David MacNaughton, provided an update to first ministers on the state of the trade negotiations and the Government of Canada's collaboration with provinces and territories on broader issues concerning Canada-U.S. relations. The Prime Minister thanked the premiers for their work on ensuring a coordinated approach to Canada-U.S. relations. First ministers agreed to continue to work together to ensure that the message about the value of NAFTA and the trade relationship with Canada is understood by key U.S. decision makers.

First ministers also discussed the federal government's commitment to legalize and regulate access to cannabis, recognizing the federal government's plan to implement these changes by July 2018. Bill Blair, Parliamentary Secretary to the Minister of Justice and Attorney General of Canada and to the Minister of Health, provided an update to premiers on the federal government's collaboration with provinces and territories to legalize, strictly regulate, and restrict access to cannabis.

Prior to the First Ministers' Meeting, the Prime Minister met with national Indigenous leaders and Premiers to discuss the inclusion of Indigenous Peoples in an economic growth agenda.

This was the fourth First Ministers' Meeting hosted by Prime Minister Justin Trudeau, which reflects the federal government's collaborative approach to intergovernmental relations.

# **Les premiers ministres se réunissent autour de leurs priorités communes pour les Canadiens**

Ottawa (Ontario) – Le 3 octobre 2017

Le premier ministre Justin Trudeau a tenu aujourd’hui une réunion avec les premiers ministres des provinces et territoires.

Les premiers ministres ont fait le point sur la situation économique et discuté des mesures à prendre pour stimuler l’économie et créer de bons emplois bien rémunérés pour la classe moyenne et ceux qui travaillent fort pour en faire partie. Le gouverneur de la Banque du Canada, Stephen S. Poloz, et le statisticien en chef du gouvernement du Canada, Anil Anora, ont éclairé la discussion en dégageant les dernières tendances dans l’économie canadienne. Le premier ministre du Canada et les premiers ministres des provinces et territoires ont insisté sur leur objectif commun de promouvoir l’emploi et la croissance au profit des Canadiens et, dans un climat de collaboration, ils ont discuté de la promotion du commerce et de l’investissement, de l’innovation, du commerce intérieur, du soutien au perfectionnement des compétences et au marché du travail et d’un meilleur accès aux données et la prise de décision fondée sur les données probantes. Le ministre canadien des Finances, l’honorable Bill Morneau, a également parlé aux premiers ministres. Le ministre canadien des Finances, l’honorable Bill Morneau, a également parlé aux premiers ministres du plan du gouvernement qui vise à modifier un régime fiscal permettant aux personnes riches ou à revenu élevé de se servir de leurs sociétés privées pour obtenir des taux d'imposition plus faibles que ceux des membres de la classe moyenne qui travaillent fort. De plus, le ministre Morneau a aussi mentionné que le gouvernement a effectué des consultations afin d’écouter des propriétaires de petites entreprises, des professionnels et des experts afin de s’assurer d’adopter une approche équitable.

Le premier ministre du Canada et les premiers ministres des provinces et territoires ont en outre discuté des relations canado-américaines, notamment de la modernisation de l’Accord de libre-échange nord-américain (ALENA). La ministre canadienne des Affaires étrangères, l’honorable Chrystia Freeland, et l’ambassadeur du Canada aux États-Unis, David MacNaughton, ont informé les premiers ministres de l’état des négociations commerciales et de la collaboration entre le gouvernement du Canada et les provinces et territoires sur des enjeux généraux concernant les relations canado-américaines. Le premier ministre Trudeau a remercié les premiers ministres du travail qu’ils font pour coordonner leur approche en ce qui concerne les relations entre les deux pays. Les premiers ministres des provinces et territoires ont convié de poursuivre leur collaboration afin de s’assurer que les principaux décideurs américains comprennent bien l’importance de l’ALENA et de la relation commerciale avec le Canada.

Les premiers ministres des provinces et territoires ont aussi parlé de l’engagement du gouvernement fédéral à légaliser et à réglementer l’accès au cannabis, sachant que le gouvernement fédéral prévoit mettre en œuvre ces changements d’ici juillet 2018. Bill Blair, secrétaire parlementaire auprès de la ministre de la Justice et procureure générale du Canada et auprès de la ministre de la Santé, a fait le point sur la collaboration entre le gouvernement fédéral

et les provinces et territoires pour légaliser et réglementer de manière stricte le cannabis ainsi qu'en restreindre l'accès.

Avant la tenue de la réunion des premiers ministres des provinces et territoires, le premier ministre Trudeau a rencontré des dirigeants autochtones nationaux et les premiers ministres des provinces et territoires pour discuter de l'intégration des Autochtones dans le programme de croissance économique.

C'est la quatrième rencontre des premiers ministres que tient le premier ministre Justin Trudeau, ce qui traduit l'esprit de collaboration du gouvernement fédéral dans les relations intergouvernementales.
