Hello Don,

We are in the final stages of completing our submission to the BCUC on Site C which is due on Wednesday the 30th of August. It represents a massive amount of work in an incredibly compressed time frame by a team of experts who simultaneously were ensuring that Deloitte, BCUC's consultant, had access to everything they needed. Over 1,000 requested documents were provided through a secure portal and full access was given to Hydro personnel .

We prepared our submission to be as compact as possible with supporting details in Appendices ^{s.13}

^{s.13} Everything provided to Deloitte was in response to their specific requests.

The report has been reviewed thoroughly and endorsed by Management and a Board Oversight Committee which has been in place since the onset of construction. The conclusion is that a decision to complete is the least cost option for ratepayers over a wide range of cost and load scenarios. I bring this to your attention now because the report will be public on the 30th and will attract a lot of media and intervenor attention.

Of course, this is just the first, albeit significant, step in the process outlined by Government on August 2. No official response will be required other than "We're waiting for the BCUC's report". I'll leave it to you whether to share this note with PJH and MMM given their need to stay at arms length from any of the submissions.

On a related note we received late Friday a ^{s.22} notice of claim from our main civil works contractor. We have shared this with Deloitte under confidentiality rules set out by the BCUC. ^{s.13,s.17}
