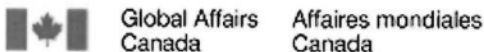

Hope you are well and congratulations on your new position with Premier Horgan. The Pacific Salmon Foundation leadership would welcome the opportunity to brief the new government on our activities at your earliest convenience.

I want to give you a 'heads up' that the Pacific Salmon Foundation has signed a Memorandum of Understanding (MOU) with Trans Mountain for Multi Year Salmon Programs. The agreement is the culmination of more than three years of consultation and includes funding for a third party assessment of sensitive salmon river/stream crossings within the Trans Mountain Expansion Project. PSF's management and board deliberated long and hard on this and we believe it is critical that PSF should have an independent monitoring and public reporting role if the project proceeds. The agreement also includes contributions to PSF's Community Salmon Program, Salish Sea Marine Survival Project and student bursary programs.

More details on the MOU will be in a joint media release that will be sent out by Trans Mountain this Thursday, July 27, 11:00 a.m. We will be posting the release on our website once it is public.
