Here is some information on DM/Associate DM leased vehicles or Vehicle Allowance-

Executive vehicles (Schedule 6 - Terms and conditions for excluded employees / appointees)

1. Deputy minister and associate deputy minister leased vehicles

Deputy ministers and associate deputy ministers will be provided with a government leased vehicle as follows:

- 1. The maximum monthly lease payment exclusive of tax will not exceed \$625 per month.
- 2. The amount of the lease is not to be augmented by personal payment.
- 3. The insurance and operating costs of the leased vehicle will be paid by the province.
- 4.The lease will provide for buy out at fair market value (should either the province or the deputy minister or associate deputy minister wish to do so).
 - 5. The maximum lease period will not exceed 48 months.
 - 6. The deputy minister or associate deputy minister may elect to receive a vehicle allowance in lieu of taking a leased vehicle. The allowance is equivalent to the average lease and vehicle operating costs noted above and is equal to \$580 per month.
 - 7. Where the employee leaves the position of deputy minister or associate deputy minister:
 - 1.and foregoes the option of buying out the lease, the leased vehicle will be surrendered on the employee's last working day (inclusive of any paid leave not to exceed an amount equivalent to the current year's vacation balance); OR
 - 2.the payment of the allowance in lieu of a vehicle will cease on the employee's last working day (inclusive of any paid leave not to exceed an amount equivalent to the current year's vacation balance).

Brian Sugrue, Fleet Procurement is the contact for information on leasing a vehicle.

If folks decide on the allowance, the amount is \$580.00/month (shown as \$266.78 bi-weekly). This amount is set up by your Chief Financial Officer and will be added to the T4 as a taxable benefit.

Thank you again for your participation and contributions that have helped to shape the opportunity for the supercluster initiative in BC.

As you may already be aware, the Government of Canada released the details of the Innovation Supercluster Initiative<https://www.canada.ca/en/innovation-science-economic-development/programs/small-business-financing-growth/innovation-superclusters/funding-superclusters.html earlier this week and will be hosting an information session in Vancouver on Tuesday May 30th at 1:30pm. I've attached the invitation email in case you hadn't already received it.

In collaboration with the Province, the Premiers Technology Council, RUCBC, BC Business Council and Dr. Santa Ono, Chief Advisor to the Innovation Network, we wanted to share a brief timeline of the anticipated activities over the next several weeks.

- 1. A Supercluster Primer for British Columbia. Similar to the effort that was undertaken by McKinsey to promote the Toronto-Waterloo supercluster, we have engaged Monitor Deloitte to prepare a positioning document on BC's unique and globally competitive strengths and capabilities in digital technology (data, analytics and visualization platforms) and applications across BC's foundational industry sectors (natural resources, health, digital entertainment, transportation). 





- Failure to abide by the Wildfire Act, including open burning restrictions, can result in a \$1,150 fine. Anyone who causes damage to a Crown forest or grassland through arson or recklessness can be fined up to \$1 million and/or spend up to three years in prison. Such a person could also be held responsible for all firefighting and associated costs.
- More than 1,600 firefighters and support staff are available for the 2017 wildfire season. The
 B.C. government is also able to call on over 2,500 private contractor firefighting resources and a
 multitude of contingency resources (including those in other provinces).

EMBC UPDATE - July 20, 2017 AS OF 0700 HRS - ASSESSMENT

Overnight a new Interface Fire was reported in the District of Lillooet. The local Fire Department, along with RCMP and BCWS were at the site where a fast moving brush fire involved at least two structures. RCMP, with assistance from Conservation Officers and local authority conducted a tactical evacuation of adjacent properties.

The Cariboo Regional District reported that 41 homes within its boundaries have been lost to the wildfires. The CRD is conducting comprehensive assessments of how many structures have been affected, and attempting to contact the owners.

The Provincial Emergency Coordination Centre (PECC) will activate at Level 3 to support active EMBC regions.

As of noon yesterday there are currently 140 wildfires burning across the province. There continues to be active and occasionally extreme fire behaviour. Yesterday saw 4 new fire starts which brings the current to date fire number to 673 fires burning 353,548 hectares. There are now an estimated 43,325 individuals under evacuation orders and a further 24,519 on evacuation alert. Continued interagency efforts remain focused on supporting evacuees and impacted residents as well as protecting critical infrastructure and properties from the interface fires.

PROVINCIAL WEATHER

Today, the upper low has finally arrived. It will move through the southern half of the province, bringing showers and thunderstorms to all regions. Many areas of the southern and central interior will see some welcome rainfall with the showers. However, it is a double edged sword, as thunderstorms are also forecast with the threat of lightning, gusty winds, and heavy downpours. General rainfall amounts of 2 to 10 mm for the southern interior and south coast, and 10 to 15 mm over the central interior. Widespread smoke from numerous forest fires continues to plague the interior with a Smoky Skies Air Quality Advisory being in effect for many areas.

Tomorrow, some lingering showers will continue over eastern sections of the province in the morning before drying out Friday afternoon. A new front approaches the coast spreading showers to north and south coastal communities during the day.

Looking forward to the weekend, things have changed a little from yesterday's weather narrative. The latest computer models are indicating that the upper ridge has flattened out with more of a westerly onshore flow expected. In addition, an upper low is expected to move from west to east across the northern half of the province. This will result in a showery weekend for the north and central coasts. The south coast may have an early morning shower on Saturday before the skies clear with mainly sunny weather expected for the remainder of the weekend. Conditions over the southern and central interior will be mostly dry over the weekend with mainly sunny skies. Williams Lake northwards will see a chance of some precipitation over the weekend.

A Special Air Quality Statement remains in place for southern and central BC (see map below) advising of smoke causing poor air quality and reduced visibility.





A weather system will bring moist air and instability to central BC and showers and thunderstorms are expected over these regions on Thursday and Friday. This weekend will see the surface ridge should build again with hot and dry conditions returning.

There are no weather alerts for BC at this time but there are Air Quality Statements related to the presence of fire smoke in 25 interior BC locations.






