I'm writing to you because I'm becoming concerned about Facebook posts by MLA

John Rustad which are critical of our new government's handling of the forest fire situation, as well as complaints from his followers and constituents in comments on his page, saying that they're not getting updated as well now that he's not the point person and posting regular updates. I'm particularly concerned that a part of one post from today (Aug. 7/17) appears intended to stir up a bit of trouble.

The last sentence of this paragraph is what concerns me, "The Ashcroft fire started and on the first day they thought they had it contained. Then the winds picked up and it raced up the hill and into the Ashcroft Indian Band's reserve destroying much of the community. Thankfully everyone got out safe. To date, no NDP minister has contacted the chief and the Federal ministry seems to be backing away from it's promise of completely rebuilding. The chief is getting very frustrated."

What I'm hoping is that your communications department is monitoring this and someone will be able to formulate some kind of response to his claims quickly before it gets festering in the public's mind.

Thank you for speaking with me this morning. As I indicated when we spoke, with the Pacific North West LNG announcement this week, it is somewhat more urgent to set up this meeting with Bob and John, as soon as that might be practical. I can understand how consumed John must be, but it is more pressing than ever for him to understand what is possible, and what is deliverable, to make some early impacts for the benefit of British Columbians. Also, with the recent appointment of Don Wright, it might be of significant value to have him there as well. I am sure that John would know instinctively whether that would be appropriate, or whether that might make more sense as a subsequent meeting. Perhaps it would be possible to get his guidance on this. Please note for context, that I was also the Chief Engineer Power Generation and Head of Technology for Syncrude Canada Ltd. for over 15 years, and can provide some very significant insights re BC Hydro organization effectiveness. BC Hydro needs to Reform, Perform and Transform to benefit British Columbians, and I will provide very practical ways and means, how this can be achieved in short order to benefit BC.
