Subject: First Nations Food Support

Suzanne you had mentioned last week that some Ministers had received questions from First Nations communities about what government was doing regarding food support. I'm not sure which Ministers had received this question, so maybe you or Stephanie could pass the following information from EMBC on to whoever needs it.

Through the Ministry of Indigenous Relations and Reconciliation: MIRR staff will be meeting with First Nations Health Authority and the Canadian Red Cross in the next week to help identify priority areas to provide support relating to food recovery.

Through the Red Cross Community Partnerships Program:

- The Red Cross Community Partnerships Program has been established to support communities throughout the recovery and rebuilding process. The program has 5 streams, one of which is Indigenous programming.
- **First Nations can apply to this program for funding to help them with their traditional ways of sourcing food such as hunting, fishing and trapping.**
 - **As an example, as the fire has caused some wildlife to migrate, Red Cross can assist with related transportation costs, such as gas.**
- **This is in addition to providing individuals and families with financial assistance to buy food to stock their refrigerators, and replace refrigerators where power was out for more than 3 days.**

Through the Red Cross Small Business Support Program:

- Additional support is available for First Nations whose primary income is through cultural livelihood, which may include:
 - Artist / Artisan
 - Carver
 - Creates beadwork, quillwork, jewelry, regalia, and/or ceremonial goods
 - Hunter, trapper, fisher
 - Community wellness (example: conducting circles)
 - Ceremony: Individual whose livelihood is based on conducting cultural ceremonies and/or the passing of traditional knowledge through cultural practices
 - Helper: Individual whose livelihood is based on learning to conduct ceremonies or using medicines and acting as a helper to the individuals conducting the ceremony

- Medicine holders: Individual whose livelihood is based on being knowledge keepers around medicines and who share this knowledge for the benefit of community
- **The Small Business Support program provides emergency assistance of \$1,500 to each eligible small business, not-for-profit organization or First Nations cultural livelihood directly impacted by the wildfires through an application and validation process administered by Marsh Canada.**
