I am also Cc ing this email to $^{s.22}$ who I mentioned in my first letter to you. Both were involved in writing the draft resolution to the NDP convention attached to this email. $^{s.22}$

Thank you for taking time to respond and talk with me about the letter I sent you on March 16, 2017 about the inequities between urban and rural areas in how improvements in our water services are financed.

First of all, Selina and John, I have to say a big thank you for acting on this cry from a B.C. rural water district prior to the last election. Selina, it was good talking with you about this issue before the presentations at \$.22 Rick, thanks for hearing me out on this at \$.22

Jodi, we need your counsel and, as the leader in your constituency, to help inform them of this inequity. s.22 thanks for the visit to our Kaleden neighbourhood where we chatted about this topic. Thanks also for reading over my first draft of this letter and for your ideas.

I am writing today to give you all an early heads up on where this issue is moving provincially in these areas: the Water Supply Association of B.C. and, on the local level, at the Kaleden Irrigation District and at the Boundary-Similkameen Constituency Association.

We are going to be distributing this information more widely and would like your feed back in two ares before we do so. We are welcoming your comments on how the contents could be improved. Secondly, how could we effectively get the message out and gain support within the party? When I have your responses it is my intention to send this information to a wider audience.

Our RDOS (Regional District of Okanagan-Similkameen) Area D Director, Tom Siddon, is planning to attend the UBCM convention later this month to speak about the proposed division of Area D into two parts. If you are there, Selina, we have asked him to try to find an opportunity to talk to you about the Kaleden Irrigation District situation as well.

As a very short summary, the issue is the inequities between urban and rural areas when it comes to funding water works. Both urban and rural areas have to meet water quality standards set by the ministry of health - but unlike their urban cousins, rural improvement districts cannot get federal or provincial grants for upgrades and improvements. As a s.22 resident who pays land taxes in both an urban and rural area, I am very aware of inequities and the services I get in each area. When s.22 makes improvements, my urban community can apply for grants from both the provincial and federal governments. Those grants are made up from personal income taxes, PST, GST, business taxes to which I have contributed to.

When the Kaleden Irrigation District made improvements by extending the intake further into the depths of the lake, there was a town hall meeting and the project was approved. Money for the project was borrowed and repaid over a ten year period through increased land taxes. Here is the inequity - unlike their urban cousins \$.22 Kaleden citizens bear the whole burden with no help from grants that they have contributed to through direct and indirect taxation at the provincial and federal levels. Probably, the interest on loans for these rural projects are more expensive too.

By reading the letter to the Kaleden Irrigation Board from one of the Board members, you will understand the exasperation the Board has experienced over the past years trying to deal with a government that simply wanted the problem to disappear by folding improvement districts into the regional districts. s.22 were invited to speak at the September 11 meeting of the Kaleden Irrigation District (KID) to bring the Board up to date on what the two of them had been doing.

Kevin Huey, the KID superintendent, is also the Chair of the Water Supply Association of BC and informed the meeting that this situation would be brought up again at the Association's AGM. The Association will be working towards securing regulatory change from this government after years of frustration trying to deal with the former government. So we expect that all other improvement districts will get on board as well. The Water Supply Association's 23rd Annual General Meeting / Conference / Trade Show is being held on October 26 & 27th, 2017 at the Prestige Harbourfront Resort in Salmon Arm, BC. We believe a representative from our NDP government should be in attendance.

I suspect that there will be town hall meetings on this issue in Kaleden and other improvement districts. To be fair, all parties will probably be invited just like the Coalition for a Healthy River View rally before the last election. It would be in the best interests of our party to make sure an NDP MLA is in attendance at any public meeting.

So to get to the crux of the matter - we must rely on support from NDP MLAs who primarily represent urban constituencies. We need their (your) support to do away with the inequities of the present system. One of our problems is that almost all improvement districts are in rural areas represented by opposition MPs who did nothing to remedy this situation while they were in power.

I've attached the emails that have gone back and forth so everyone understands the history of this discussion: the original March e-mails from \$.22 and me and Selina's reply regarding the inequities built into the present system and several other attachments which give more background information.

Irrigation and Improvement Districts

Whereas all BC residents pay taxes, most rural residents don't get the same bang for the buck. They get less policing, fewer amenities such as civic / sports centres and seniors centres, poor highway maintenance, fire departments manned only by volunteers. In addition, many rural residents are faced with the financial problems brought about by more stringent provincial health regulations without being able to access the funding to put them into place.

Resolved:

that the government change the necessary policies to allow irrigation districts and improvement districts to apply for provincial and federal grants without having to apply through a regional district.

Supporting statement:

- 1 a. BC government regulation has increased requirements for some water suppliers. However these policies are inconsistent and do not cover all water suppliers. Only systems with 500 or more subscribers are required to upgrade. If it is really a health issue, then all water suppliers should conform to new regulations.
 - b. Regulations are province wide and not necessarily based on need. Projects are being required when need has not been proven. As mandated by provincial regulations, Health Authorities are requiring more and better equipment but there is no money available to help small water suppliers purchase install the equipment.
- Both urban and rural ratepayers pay taxes according to their provincial tax assessment.
 However, the rural homeowner must shoulder the burden of new water infrastructure
 without any help from senior levels of government. All homeowners pay taxes, but only
 projects authorized by municipalities or regional districts are eligible for grants.
- 3. Irrigation districts are legal entities distinct from regional districts, not junior partners of regional districts. As such, they should be able to apply for infrastructure grants without having to petition another organization for permission. Irrigation districts need to be able to access provincial and federal grants which they cannot cannot easily acquire through regional districts even if the regional districts looked favourably on the projects.

Well run water districts should be able to apply for grants to help them improve their infrastructure. If communities are required to upgrade infrastructure, the burden should not fall on the local homeowner alone. The provincial and federal governments have a part to play.

approached me recently to identify a potential opportunity for the KID, and Improvement Districts more generally, to request that the incoming Provincial Government reconsider the exclusion of Improvement Districts from federal and provincial funding and grant processes.

While this is an initiative that I (and others) had contemplated since first joining the KID Board, there seemed to be little hope that such a request would be considered by the government of the day. With a new provincial government now in power, s.22 s.22 are of the opinion that the time is right to request that the new Provincial Government review this situation and revise the legislation via OIC to include Improvement Districts as eligible to be considered for funding and/or grant programs currently available only to Regional Districts and municipalities.

While we as an individual District could approach the new powers-that-be with such a request, we potentially would garner far more political attention if a petition was presented that included signatories from (hopefully) all Improvement Districts and identified the numbers of ratepayers represented by each District. We are in the enviable position of having both the Chairman and Secretary/Treasurer of the Water Supply Association of BC as KID staff members. Their assistance would undoubtedly expedite the distribution of such a petition to the appropriate WSABC members.

s.22 feels that, while the time for this is right, the timing is also tight. We need to get this onto the radar of the new cabinet ASAP! Unfortunately as previously indicated, I will not be able to attend the September 11th Board meeting, but am requesting that s.22 be invited to give a presentation on this matter to the Board at that meeting.

It would be very much appreciated if s.22 receive confirmation ASAP that they have been included on the agenda for the September KID Board Meeting. Wish I could be there, but England is calling!

Thank you for the response to my Dec 2016 note. I am familiar with KM's rationale on twinning the pipeline along with government's explanation for foregoing the NEB process corrections and pre-emptive pipeline approval by the PM. The government did not fulfill its commitment to a

fuller NEB process involving cross examining evidence and a commitment to informed consent with first nations.

I challenge you to listen to the NEB Expansion submissions by West Vancouver and Squamish Nation (URL attached) and answer these questions for yourself:

- Is the KM TM Expansion safe?
- Were first nations consulted in the spirit of nation to nation reconciliation and UN resolution on informed consent? If this pipeline is forced on the people of British Columbia what is going to be left of the relationship?
- Will the operational noise from tugs and tankers through the second narrows extinguish the fish and killer whale population in Burrard Inlet and Indian Arm?
- Considering that the diluting mixture in Dibit oil is toxic and vaporizes heavier than air would you feel safe living in the shadow of the tank farm and sending your kids to the elementary school close by?
- Does the NEB conduct in question period for these two segments lead you to believe that NEB representatives would render and unbiased, objective decision in the best interest of all Canadians?

I responded to the NEB call for commenters and submitted a paper on the impacts to the Shoreline Trail in Port Moody(attached). I followed the hearing process listening to many submissions by West Van, Squamish Nation, North Van, Burnaby, Port Moody, New West, Cheam Nation and Washington State.

The points made in these submissions are compelling: poor communication, logistics, coordination and standards for oil spill response, dangerous toxic nature of Dilbit oil, health and fire hazard of the tank farm design, flawed NEB process (no cross examination of evidence), biased ruling, proponent and federal government failed in its duty to First Nations of informed consent, devastating impact to fish and whales because of tanker and tug boat noise. How anyone can come up with the decision that this pipeline is in the public interest after listening to these submissions is beyond me.

I also found that Kinder Morgan's impact submission apparently did not look beyond the Westridge terminal as they missed several spawning stocks in the streams and creeks that traverse Shoreline Trail. The concept of compensation for loss of recreational use is moot if you do not have a proper inventory and valuation of wildlife and recreational use. For example: Compensation for loss of recreational use claims for the Exxon Valdes oil spill in Prince William Sound are still outstanding.

Your response letter leads me to think that you believe opposition to the KM Trans Mountain Expansion is due to insufficient knowledge of the proposal. I believe the opposite is true. Please take the time to listen to the West Vancouver and Squamish Nation NEB hearing submission and see if your opinion changes.
