Dear Premier,

Congratulations on forming the new government of British Columbia. We are thrilled your government is so deeply committed to protecting and advancing the public health of all British Columbians.

I'm grateful for the opportunity to have met with you prior to the provincial election. As we discussed then, as the Director of the BC Centre on Substance Use, I'm intimately aware of the challenges ahead in the midst of a public health emergency in response to the province's opioid overdose epidemic.

While only launched in April, the BCCSU was developed on a foundation of many years of work in the area of addiction medicine and substance use care, and our large staff of over 100 persons is eager to support your ministry in addressing the overdose crisis.

The BCCSU's mandate is to develop, help implement, and evaluate evidence-based approaches to substance use and addiction in British Columbia. The BCCSU is also host to the federally funded BC Node of the Canadian Research Initiative on Substance Misuse (CRISM) and we are further supported by a range of U.S. National Institutes of Health funding.

With these resources, we are actively addressing structural reasons for the overdose crisis. Since our operational launch, we've worked with community leaders, health care providers, people in recovery, and families affected by overdose and addiction to develop and implement the province's new clinical guidelines for the clinical management of opioid use disorder. We've also led the clinical care training and education of over 1800 health care providers in these new guidelines, as well as the provincial buprenorphine/naloxone and methadone training programs. Our team has also recently completed guidelines for the expansion of injectable opioid agonist treatments (iOAT) as well as a document outlining required improvements to addiction recovery services.

In addition to our leadership role in responding to the public health emergency, the BCCSU will continue to create word-leading evidence based clinical guidelines to fill the gap

between science and clinical practice in addiction medicine, including alcohol withdrawal and relapse prevention, nicotine use disorder and tobacco cessation, cannabis, and safe drug consumption guidelines.

While we recognize we will be working most closely with the Ministry of Mental Health and Addictions, improving substance use care has implications for the health care system more broadly. As such, we look forward to the opportunity to work with you and your team to develop solutions to addressing the opioid overdose crisis, as well as advancing strategies for creating a sustainable addiction system of care that benefits all British Columbians.

Please let me know when you and your team are available for a meeting to discuss how the BCCSU can put all of our resources towards supporting the work you are undertaking and all of the efforts required to effectively respond to the overdose crisis.
