Hi Suzanne,

I wanted to send you a short summary of what's happening with the federal government and UNDRIP:

- April 21, 2016: Romeo Saganash, NDP MP, introduced Bill C-262. This bill called on the federal government to ensure all Canadian laws were aligned with the principles set out in UNDRIP. It also called for the development of a "national action plan" to implement UNDRIP and annual reporting to Parliament on progress.

- November 20, 2017: Jody Wilson-Raybould, federal Justice Minister, announced government's support for Bill C-262. She says this bill represents one piece of the government's broader plan to implement UNDRIP.
