For the second phase, the province will be looking for feedback in five areas:

- Response times, to ensure timely responses following a spill;
- Geographic response plans, to ensure resources are available to support an immediate response that take into account unique characteristics of a given sensitive area;
- Compensation for loss of public and cultural use of land, resources or public amenities in the case of spills;
- Maximizing application of regulations to marine spills; and,
- Restrictions on the increase of diluted bitumen transportation until the behaviour of spilled bitumen can be better understood and there is certainty regarding the ability to adequately mitigate spills.

## Premier Notley: Further measures to defend Alberta

February 09, 2018 Media inquiries

Premier Rachel Notley has established a task force of prominent Canadians to respond to B.C.'s unconstitutional attack on the Trans Mountain Pipeline and the jobs that go with it.

The task force will work closely with business, labour and community leaders and provide the Premier and cabinet with their best advice to further defend Albertans.

Task force members include former New Brunswick Premier Frank McKenna, Former Deputy Prime Minister Anne McLellan, former Syncrude Canada president Jim Carter and noted legal scholar Peter Hogg.

“In response to British Columbia’s unconstitutional attack on our energy industry and the Canadian economy, Alberta is preparing retaliatory measures. The new task force is made up of leaders with deep connections throughout the country and expertise on these matters. It will help ensure Alberta’s response gets Ottawa’s and B.C.’s attention.”

The Premier said Ottawa needs to step up and assert its authority to build approved intra-provincial economic infrastructure such as Trans Mountain.

“This is not a fight between Alberta and B.C. This is B.C. trying to usurp the authority of the federal government and undermine the basis of our Confederation. Ottawa needs to say clearly and unequivocally that B.C.’s actions won’t stand. Sadly, B.C. decided to pick this fight with the country. No one wants it and it could end tomorrow, but as long as B.C. continues, Alberta will fight for jobs in Alberta and speak up for a Canada that works.”

**Context**

Premier Rachel Notley has phoned Premier John Horgan to underline her concerns about proposed regulations to manage petroleum spills, especially dilbit. Her concern focuses on point 5 in the five-point plan released yesterday.

**Communications frame**

BC is taking prudent, thoughtful steps to ensure we are able to protect our environment in the event of a petroleum spill.

These are proposals which are going out for consultation. We expect to take action, based on that feedback, as we do routinely under environmental protection legislation. – but not before we finished consultation.

**Communications actions**

- Minister Heyman to call his Alberta counterpart and perhaps his Ottawa counterpart to convey these messages.
- Incorporate these messages in media commentary from the Minister and the Premier
