Good morning Geoff,

I appreciated the opportunity to meet with you on November 10, 2017. During that meeting, you indicated that the Premier is interested in meeting the FNHC.

The Hon. Jane Philpott, Minister of Indigenous Services, called an emergency meeting of provincial Ministers of Children and Family with Indigenous leaders in late January 2018. Given the partnership between the Province of BC and the FNHC MOU and the FNHA and MOHS, we believe that we have an opportunity to exercise leadership in the lead up and the conduct of that National Emergency meeting.

During a recent teleconference with Minister Katrine Conroy, it became clear that the MCFD Minister and Deputy Minister did not fully appreciate nor understand the opportunity for developing a strategy for the national emergency meeting.

To address this concern, I spoke with Minister Adrian Dix and Deputy Minister Stephen Brown. Later this week, Stephen Brown is meeting with his colleague Deputy Ministers to brief them about the Province of BC and the FNHC MOU. I hope that this helps the MCFD Deputy Minister to understand and appreciate the opportunity to exercise leadership

nationally.

I'm hopeful for a meeting with the Premier soon. The FNHC is meeting with the BC Deputy Ministers on December 20th. I prefer that we meet before December 20th.
