Here are proposed materials for the Modular Housing announcement on Friday. Sorry this is so late. My laptop has been an epic disaster this evening. In addition to the Ministry's News Release, Q&A's and Event Plan, there are photos of the venue:

- "Modular Media Shot" is roughly the backdrop that I think should be behind the speakers on Friday, looking at the short side of the unit with the long side visible.

And of course we could not have a scrum at all, since he will have just come from doing one, but BC Housing and the City are in favour.
