Hey Sage,
Woke up thinking about this ... a few thought to try and shape the narrative some more.

Thought about these as commentary for PJH. Needs support from Eric's shop, too. We need to be talking about what the **old way** and what **big money politics cost you** - tax breaks for millionaires instead of making life more affordable for you generally ... but also specifically.

It cost taxpayers millions in tax write offs for corporations that bought them access and influence on the Liberal government. Some people got favours using money they didn't have to pay taxes on.

Here are some other ways to say that same thing (I'll work some of this into John's speech on Friday but I think he needs to be prepped to say it before then!)

With the old way way - it worked for **them** - corporations got to avoid paying taxes on money they used to donate ... to influence the Liberal government to make decisions that favoured corporations, that was clearly happening all the time from the choices we saw the Liberals making - tax breaks for corporations and the top 2 percent, 100% hikes to MSP fees for you. (use a few examples, this for them/that for you can be tax breaks for the top 2% or big profitable corporations everytime)

But from stuff we've seen and heard anecdotally (and reported... see the tyee piece and others) sometimes the corporate donations benefited the donors specifically. Think about that problem for a minute. They got a tax write off to buy favours. That's a lose lose for ordinary voters. And for those who don't have the money or the inclination to play that game.

New way works for people - corporations have to pay their taxes on money the used to use to try and make sure they got a worked for them. With the old way: the government was bought and paid for by corporations! That didn't work for people. Now they are barred from using their money to buy influence in politics.

That's saving you - the taxpayer - X in unpaid taxes from corporations - conservatively estimated. That's a number we didn't know about until we got here.

(Eric had this number before. We need to be pushing it. Can we legitimately say it's 'better information' not that we are in government and digging around? I think we did

No more tax breaks for corporation to use money to buy influence - people now have the power and the opportunity to participate.

Voters - not money - decides elections.

People have the power again - ***and that's a better deal and more affordable for people in the long run*** (we have to be able to say this - make the gallery see the costs of the old way, rather than just focus on the costs of the new way)

And we are going to prove it.

With everything we do.

A premier shouldn't work for the rich. I'm in it for people. And we want to make sure that we don't ever go back to that old way. This is how we change it for good.

Let's think about our frame and branding this. MLAs and ministers can say

People rejected the 'buying favours big money' approach of the BC Liberals - it costs taxpayers in many many, many ways - lost taxes & policies that benefited the wealthy and well connected - in tax breaks for the top 2 percent, AND in tax breaks for the corporations who donated for access.

Instead we're making sure voters decide elections and making sure they get government free from the influence of big money donations, for good.

EXTRA NOTE: **no one** should talk about what we did or didn't promise in the election. This is about values and principles and what was wrong with the old way and what's better about the new way. Stick to that and don't discuss the process story.
