Hi Suzanne,

Further to our discussion this morning, for consideration, implementing the Truth and Reconciliation Commission Calls to Actions by instructing the new Minister Advisory Committee's to take cultural competency training.

TRC Calls to Action - "receive appropriate cultural competency training, which includes the history and legacy of residential schools, the United Nations Declaration on the Rights of Indigenous Peoples, Treaties and Aboriginal rights, Indigenous law, and Aboriginal– Crown relations. This will require skills-based training in intercultural competency, conflict resolution, human rights, and anti-racism."

This training could be the one-day training – the Village exercise, a one day experiential workshop developed by Kathi Camilleri. The workshop helps people to understand traditional Aboriginal ways and values. Together participants explore their personal role in supporting the revival of those values, used for thousands of years, which worked so beautifully. We will also explore, in-depth, the effects of residential schools and Canada's Policy of Assimilation.

Learning outcomes:

- A cognitive and emotional understanding of traditional First Nations values
- A deep and emotional insight into the depth of and the intergenerational effects of Colonization
- Methods for creating supportive relationships in a positive way

The Village exercise is being used widely across the BC Provincial government as a means to begin to build cultural competency. Both ADMs and DMs will be receiving this training at the end of November and early December.
