*By leave, I move –*

That this House authorize the Standing Committee on \_\_\_\_\_ to examine, inquire into and engage relevant expert witnesses concerning the subject matter of Bill M203, *the Rideshare Enabling and Increased Taxi Occupancy Act, 2017 that has been referred to the committee.*

That the committee shall be able to call expert witnesses to assist in the committee's examination of the impact of transportation network companies on British Columbia and shall produce a report that includes and is limited to:

- Investigating how province's with public insurance companies have provided insurance to both transportation network companies and the taxi industry

- Assessing what impact transportation network companies would have smaller communities (different communities across the province?)

That the Committee, in consultation with the Committee Chair, be authorized to arrange the following:

- That the Committee meet for two days of expert witness hearings to answer technical questions, on Monday, January 15, 2018, and Tuesday, January 16, 2018, from \_\_\_\_ time to \_\_\_\_ time, or at the call of the chair;
- That committee members provide the committee clerk with requests to appear as an expert witness by 12:00 noon on Thursday, January x, 2018;
- That a sub-committee be formed consisting of one member from each of the New Democrat Caucus, Liberal Caucus, and Green Caucus;
- That following the deadline, the Clerk of the Committee provide the members of the sub-committee with a list of requests to appear;
- That the members of the sub-committee prioritize and return the list by 4:00 p.m. on x date;
- That the Clerk of the Committee schedule witnesses from these prioritized lists;
- Each witness will receive up to 15 minutes for their presentation, followed two rounds of questions consisting of 4 minutes for questions for each party per round from committee members.

That the Standing Committee on \_\_\_\_\_ shall conclude its work by February 15, 2018 and report to the House as soon as possible, or following any adjournment, or at the next following Session, as the case may be; to deposit the original of its reports with the Clerk of the Legislative Assembly during a period of adjournment and upon resumption of the sittings of the House, the Chair shall present all reports to the Legislative Assembly.

George, if I've understood the concern correctly, it's that candidates (or parties) are the ones who obtain loans but the reimbursement for election expenses, under the bill, would be paid to the financial agent. We've looked more closely at the section. It includes the following (section 20 of the bill):

### Use of reimbursement

215.05 (1) The financial agent of a candidate must use a reimbursement paid under section 215.04 to fully satisfy any loan, debt or other financial obligation of the candidate in relation to the candidate's candidacy.

(2) If, after any required payment under subsection (1) of this section, there is a remainder of the reimbursement, the remainder must be treated in the same manner as a balance remaining in an account referred to in section 177 (2) (b) is treated under section 205.

(3) The financial agent of a registered political party must use a reimbursement paid under section 215.04 to fully satisfy any loan, debt or other financial obligation of the political party.

Does that satisfy the concern? A candidate/party seeking a loan can point to this section to reassure a potential lender that there is a requirement for the reimbursement to be used for this purpose first, regardless of the fact that it is initially given to the financial agent.

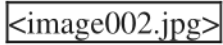

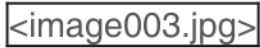
