Chinese-Canadian Community Advisory Committee

Shirley Chan 陳雪英, Vancouver Chinatown activist

Shirley Chan retired in 2012 as CEO of the non-profit economic development agency in Vancouver's Downtown Eastside. Previously she was Regional Director BC/Yukon for Health Canada then Director of Sustainable Development in Ottawa. She was the City of Vancouver's Director of Non-market Housing and Chief of Staff for Mayor Mike Harcourt. She also held various Federal Public Service positions in Ottawa and Toronto.

In the 60s and 70s, Shirley helped organize her community of largely non-English speaking Chinese Canadians and founded the Strathcona Property Owners and Tenants Association (SPOTA) that stopped demolition of Strathcona and Chinatown; thus putting an end to the proposed freeway system in Vancouver.

Shirley serves on the Vancouver Chinatown Revitalization Committee and the Chinatown Working Group for North East False Creek. She held leadership roles with boards of UBC, BC Hydro, Vancity Credit Union, Citizen's Bank, Dr. Sun Yat-Sen Classical Chinese Garden and Learning for a Sustainable Future. She received an Honourary Doctorate (UBC); Outstanding Alumni Award (SFU); YWCA Woman of Distinction and Queen's Jubilee Medal. She has a BA from SFU; Masters in Environmental Studies from York.

Christina Chang 張健理, president, Taiwan Chamber of Commerce in Canada

Even before receiving the Outstanding Chinese-Canadian Woman Award back in 2012, Christina Chang has always been an upstanding Canadian citizen who is an active member in her community. A graduate from Chinese Culture University with a degree in French Language and Literature in 1985, Christina immigrated to Canada a decade later and successfully established an education consulting company, Hanyin Education Consulting Inc., providing proper education guidance for international students. Some of her early students are now receiving their PhDs from renowned Canadian universities.

Since 2009, Christina has been heavily involved in the Taiwan Chamber of Commerce, which promotes healthy business exchange between Taiwan and Canada. Starting as the 18th president of this organization at the provincial level in BC, she is now the President of Taiwan Chambers of Commerce in Canada (TCCCA) as well as an advisor to the Taiwanese Chambers of Commerce in North America and the World Taiwanese Chambers of Commerce seven years later till now.

As a strong believer of giving back to society, she rewarded a total of \$5,000 in scholarships to outstanding students and raised \$270,000 for the Typhoon Morakot disaster in Taiwan in 2009. Her contributions were recognized by being awarded as the finalist of the New Canadian Entrepreneur in 2014 and receiving the Outstanding Entrepreneur in BC Canada Award just a year later.

In addition to her hefty contributions as the president of both the Hanyin Education Group and Taiwan Chambers of Commerce in Canada, she also works as the President of the Taiwan Association for Future Leaders (TAFL) to provide a platform where teenagers are giving opportunity to communicate and connect with leaders from the East and West, as well as the Advisor for the Overseas Compatriot Affairs Commission, ROC.

Debbie Chen 陳儀芬, journalist

Debbie Chen is a journalist in Sing Tao Daily. After completing her master degree of telecommunication in San Diego States University, she worked at TVBS and Unique TV in Taiwan for over 10 years. After immigrating to Canada in 2005, she became a radio host for "News Frontline" and also served a role as Mandarin news team leader in Fairchild Radio.

Apart from working hard, she dedicates herself to community volunteer work such as Youth Initiative, Tzu Chi Foundation and Breakfast Club in Anderson Elementary School.

Debbie has a passion for life-long learning and loves to communicate with people. She and her husband have two children.

Queenie Choo 周潘坤玲, CEO, S.U.C.C.E.S.S.

Queenie Choo immigrated to Canada in 1980. Since then, she has made significant achievements both in her career and in the community. She was appointed as the first CEO to commission the Chinese care home in Edmonton Alberta and has held senior leadership positions within Alberta Health Services.

In 2012 Queenie was appointed as the CEO of S.U.C.C.E.S.S., the largest non-profit social service organization in BC. Queenie's passion to serve the community has extended her volunteering on many boards including Omni TV advisory council to ensure diversity and inclusion in media programming, RCMP Commanding Officer's Cultural Diversity Inclusion Board and the Poverty Reduction Advisory Council for the provincial government. She is also engaged on the advisory council for the "Apology for Chinese Canadians for the Historical Wrong" project at both the provincial level and municipal level in Vancouver.

Internationally, Queenie is instrumental in providing pre-arrival services in Beijing China, Seoul South Korea and Taipei Taiwan to strengthen the cultural, economic and social integration of newcomers before arriving in BC. Fostering business entrepreneurship, employment, economic and social development opportunities in local communities remains her advocacy and passion.

Queenie is the recipient of the Queen Elizabeth II Diamond Jubilee medal for her significant contributions to the community. She is recognized as one of the 35 most influential women in BC, top 25 Canadian Immigrants. In 2016, Queenie was named as the 50 most powerful people in Vancouver.

June Chow 周慕慈, co-founder, Youth Collaborative for Chinatown

June Chow is a co-founder of the Youth Collaborative for Chinatown 青心在唐人街 that advocates for cultural revitalization as key to (re)building community within the rapidly changing neighbourhood. The group's monthly, community free-play mahjong socials and new Cantonese school program offer opportunities to actively learn and practice the intangible cultural heritage of the historic area, and for their knowledge transfer across generations and cultures. Previous to dedicating herself full-time to Chinatown, June worked at UBC in fundraising and alumni engagement for over ten years, most recently, to articulate a community case for support for a renewed Asian Library within the university's historic Asian Centre. She is a Lifetime Member and Director (since 2013) of the Hoy Ping Benevolent Association, one of the 80+ Chinese family and clan societies that call Vancouver Chinatown home.

Alex Fan 范偉銘, vice-president, CIBC

Alex immigrated to Canada in 1989 from Taiwan. He is married to his wife, Samantha, and has two children Stephanie and Christopher, who is an avid figure skater, inspired to represent Canada in the Winter Olympic in Beijing in 2022. Alex received his MBA degree from Claremont Graduate University in Los Angeles in 1994. He is the Vice President in charge of CIBC Retail Asian Banking (therefore 3 business trips to China every year), also Board of Director for the SUCCESS Foundation. He is very engaged with local community and a volunteer for BC Children's Hospital since mid 1990's for its fundraising effort. Alex is Chair of Banks Division for BC Children's Hospital Foundation 2011-2012. He received Queen Elizabeth II Diamond Jubilee Medal in 2013 and was President for Taiwan Chamber of Commerce in B.C. 2003, and Vice Chair for Taiwan Chamber of Commerce in North America in 2003.

Ding Guo丁果, journalist and TV commentator

Ding Guo was born and grew up in Shanghai. He received his BA of History in China and MA of international relations in Japan. He became a Canadian citizen in 1990s.

Ding Guo is one of the most reputable and respected current affairs commentators in the Chinese community in Canada. His commentaries and articles are published in major newspapers in Mainland China, Taiwan, Hong Kong, and North America. He is also the author of several books covering modern history, politics, immigration, and international affairs.

Ding has been working in a variety of reputable media organizations since the 1990s. He is a winner of the Jack Webster Award for Best Chinese Reporting. He was also voted the best non-English TV commentator by the Georgia Strait Newspaper. He is a recipient of the Queen Elizabeth II Diamond Jubilee medal.

The community also has benefitted from Ding's involvement and work. He was a past board member of SUCCESS, and an Advisor to a number of associations in the community. He has also been appointed as a board member of CTCMA since December 2017.

Sunny Ho 何強新, president, Richmond Business Association

Sunny Ho is 61, born in Hong Kong. For over ten years Sunny was engaged with his family restaurant business before he sought his further study. In 1989 Sunny graduated from Northern Ireland University with an accounting degree. Then he was employed as a teacher in secondary school for three years.

Carol Lee, chair, Vancouver Chinatown Foundation

Carol Anne Lee is CEO and co-founder of Linacare Cosmetherapy Inc., a company that manufactures and sells therapeutic skincare products. Linacare is headquartered in Vancouver's historic Chinatown district. With long standing family ties to the history of Chinatown, she is strongly committed to the revitalization of the area and is the Chair of the Vancouver Chinatown Foundation, Chair of the Vancouver Chinatown Revitalization Committee and Honorary Patron of the Chinese Canadian Military Museum.

She serves on several other boards and organizations including the Harvard Business School Canadian Advisory Board, the Leadership Council of the Perimeter Institute of Theoretical Physics in Waterloo, a board member of Governor General David Johnston's Rideau Hall Foundation and co-chair of the Rideau Hall Foundation Innovation Committee. She was also a member of federal Finance Minister Morneau's Advisory Council on Economic Growth.

Imogene Lim 林慕珍, professor of Anthropology, Vancouver Island University

Dr. Imogene Lim is an anthropologist (BA Hons, Simon Fraser University; AM & PhD, Brown University) and past Chair of Anthropology at Vancouver Island University. She has worked with diverse communities in BC and abroad, and more specifically, for the past two decades those on Vancouver Island. Among her research interests are ethnicity in Canada and Asian Canadian history. Her community contributions include appointments to the Editorial Board of BC Studies, the Coal Creek Historic Park Advisory Committee (Cumberland, Vancouver Island), the Laurier Institution, and BC Legacy Initiatives Advisory Council, as well as, being a founding member and former Board Director of the Chinese Canadian Historical Society of BC. Like many other multi-generational Canadians of Chinese descent, she is reminded that her grandparents and parents were the ones who pushed against barriers to make a better life for their descendants and, ultimately, for all Canadians. As an educator, she continues to do the same.

David Lin 林大誠, radio host

David was born and raised in Taipei, Taiwan. He came to Vancouver B.C. as a student in 1985. In 1989, he became a landed immigrant and obtained his Canadian citizenship in 1992. David was known as one of the youngest entrepreneur who studied and worked in business during his university days. He has successfully marketed and promoted the Canadian tourism industry to the Far East market for 30 years.

Since 2016, David was elected as Director of CITAP(Canadian Inbound Tour of Asia Pacific) and being a Mandarin speaking host in AM1320 which was established in 1976, first Chinese Radio station in North America, talking about Taiwan and Canadian political issue and Tourism program.

David as a partner and General Manager of successful Dominion Pacific Travel and Bonus Holidays & Tour since 1988, both companies were sold to a Hong Kong public listing company in 2000. Prior to that, David was General Sales Agent in Taiwan of Holland America Cruises Lines and promoted Canadian Rocky Mountain tours to Asia market since 1988. David was handling both Eva and Canadian Airlines' ground tours and transportation in 1999.

David was one of the original founders of TCCBC and TCCCA since 1992, elected as 9th President of TCCBC (2000)and 16 & 17th Preside of TCCCA (2010 & 2011).

Fred Mah, chair, Chinatown Society Heritage Buildings Association

For four decades, Fred Mah has been one of Chinatown's strongest advocates playing a role in countless community associations and civic committees.

Fred served as an active member of numerous community organizations, and trade delegations. He was a founding member of the Vancouver-Guangzhou Friendship Society and the BC-Guandong Business Council and served as president for both organizations. He organized countless Chinatown parades, art exhibits, photo and opera exchanges.

Fred was a founding member of the Chinese Cultural Centre and the Chinese Canadian Historical Society of BC. He chaired the Chinatown Visioning Committee for Chinatown Revitalization. He founded the Friends of False Creek and the Chinatown Society Heritage Buildings Association.

On February 26, 2013, Fred Mah was recognized by the City of Vancouver and presented with Vancouver's Civic Merit Award for his tireless work in Chinatown and in the Chinese community in Vancouve

Harris Niu, president, Canadian Community Services Association, organizer of the Chinese Cultural Festival

Zili (Frank) Wu吴自力, founder, Canada China Sports Foundation

Mr. Frank Zili Wu was born in 1965. Graduated Qinghua University with a Master Degree in Sports Management, Mr. Wu has been actively involved in organizing sporting and charity events in local community, as well as promoting sports and culture exchange between Canada and China.

Mr. Wu is the co-founder of Canada China Sports Foundation and its subsidiary charity organization--CCSF Autism Foundation. Since 2015, Mr. Wu has spearheaded the organizing work for several major sports exchange programs, including Beijing Meets Vancouver: Olympic Host Cities Forum in 2015, and Canada China Women's Hockey Tournament in 2016. Currently Mr. Wu is working on "Run To Beijing Olympics", a project to promote Vancouver International Marathon in China as well as connect marathon host cities in China with Vancouver.

Mr. Wu is also the main driving force in Chinese Canadian community for charity work like fundraising for Pacific Autism Faminly Network, Vancouver General Hospital and Richmond Hospital.

"I want to be the bridge builder to connect BC's sports and tourism industry with their Chinese counterpart, in order to promote BC as the sports tourism destination in China, therefore bringing Chinese sports lovers to BC, creating jobs and economic activities for local communities." Says Mr. Wu.

Bill Yee 余宏榮, retired provincial lawyer and judge

Bill Yee was born in Guangzhou, Guangdong, PRC, immigrated to Canada in 1959, attended Strathcona Secondary School, Britannia High School, graduated from UBC Law School in 1973, married with three children, practised law in Vancouver and Richmond for 25 years, elected as Alderman for the City of Vancouver in 1982 and again in 1984, received Queen's Counsel designation in 1999 and was appointed as Provincial Court Judge in the same year, retired from the Court in 2015.

Bill has served as President of Vancouver Chinese Benevolent Association for many terms, former Vice-Chairman of Chinese Cultural Centre, former Executive Chair of the National Congress of Chinese Canadians, Vancouver Police Board member from 1992-1997, B. C. Hydro Board member 1997 – 1999, former Chair of Vancouver-Guangzhou Friendship Society, former Chairman of B. C. – Guangdong Business Council.

He is currently a member of the Advisory Group on Historical Discrimination Against Chinese People for the City of Vancouver, the National Chairman of the Yee Fong Toy Society of Canada and Honorary Citizen of Guangzhou. **Jeffrey Yu**余彥君, President, New Vista Society and Operations Manager, Chinese Taoism Kuan-Kung Association, Tien Jin Temple

Jeffrey graduated from SFU with a BA in Economics and obtained a Nutrition Manager designation from Langara college. Raised in a family that values community involvement and tradition ethical values, Jeffrey has been involved in the community as a volunteer at Kuan Kung Association, a charitable non-profit organization, for the last 15 year promoting multi-cultural-ism and traditional Chinese ethics. Purpose and Rationale

The Premier's Chinese Canadian Community Advisory Committee will assist the Province of British Columbia in strengthening social, economic and cultural ties among members of the Chinese diaspora in this province and around the globe.

The advisory committee will:

- Advise the Premier on government initiatives of interest and concern to members of the Chinese Canadian community in British Columbia
- Recommend strategies for building on B.C.'s economic and cultural connections with China and Chinese communities throughout the world
- Propose new programs and projects for government consideration to enhance the contributions of the Chinese Canadian community to the province

Goals

The goal of the advisory committee is to:

- Identify and actively engage with members of the Chinese community
- Ensure information from this community engagement is brought forward to the Premier for active consideration and implementation into the government agenda

Proposed Structure

The advisory committee will include:

- A committee of 15-20 members, selected for their expertise and community involvement.
- It is an open membership with no set terms
- There will be two co-chairs and one committee secretary. All three will be members of the committee and will be chosen by consensus of the committee.
