I've been following your pieces on fish farms the last few days and wanted to point out, in regard to the letter the current minister sent to Marine Harvest, that the language used was not particularly out of the ordinary. As a comparison, the former agriculture minister, in a 2015 update, used language along the same lines (copied and linked below).

# Salmon aquaculture update in British Columbia

Following the federal government's decision to issue aquaculture licences, the B.C. government has issued two new tenures under the Land Act for salmon aquaculture purposes, near Hope Island off the northern tip of Vancouver Island, and offered two more, one in the Clio Channel, east of Port McNeill, and one near Flores Island, north of Tofino.

The Hope Island sites are Heath Bay (Wanx Talis) and Bull Harbour (Ghi Ya) and will be operated by the Tlatlasikwala First Nation in partnership with Marine Harvest Canada. The Clio Channel site is at Sambo Point (Wa Kwa) and will be operated by Grieg Seafood BC, which has an impact-benefit agreement with the Tlowitsis First Nation. The Flores Island site at Yaakswiis will be operated by Cermaq which has an impact-benefit agreement with the Ahousaht First Nation.

The federal Department of Fisheries and Oceans issues the aquaculture licences, following a scientific review of any potential impacts the new operations could have on wild fisheries, fish health, the marine habitat and environment and the ocean floor. DFO also regulates all operational activities of aquaculture including farm size, species and production, fish health and fish containment.

The B.C. government, in its role as landlord, issues Crown land tenures in the form of leases or licences of occupation that allow businesses to operate on provincial Crown land, including water lots and any related activities on shore to ensure any potential impacts on other leases can be managed. As part of the tenure application review process, other agencies, First Nations, local governments and the public are consulted.

Provincial aquaculture tenure applications are reviewed and decided by provincial government employees who have been designated as statutory decision makers under the Land Act.

As indicated in the Minister of Agriculture's mandate letter, the government will examine the rules and restrictions that guide the application and approval process to ensure that aquaculture operations are socially and ecologically sustainable and can co-exist with British Columbia's wild fishery resource. Specifically, the government will:

Strike a standing Minister of Agriculture's Advisory Council on Finfish Aquaculture that will
include members from the aquaculture industry, non-governmental organizations and First
Nations, as well as the Ministry of Agriculture and the Ministry of Forests, Lands and Natural
Resource Operations.

- 2. Examine establishing a protocol for receiving advice from the Aquaculture Stewardship Council in regard to tenures for new aquaculture sites.
- 3. Examine the feasibility of improved microbe detection at aquaculture sites arising from the work being undertaken by Genome BC in tandem with the other scientific evidence already available to the Province.

While these actions are being undertaken, the Province will not consider any further approvals for new salmon aquaculture tenures.

The B.C. government remains committed to science-based decisions in its socially and ecologically responsible management of B.C. fisheries, including an environmentally and economically sustainable aquaculture industry for the benefit of all British Columbians.

Hey Rob,

Just saw your fish farms story go up. Wanted to ensure you had the full W5 transcript of the lead DFO researcher raising concerns. Minister Popham has also spoken with Dr. Miller, who again raised the concerns.

Have you been able to speak with Dr. Miller?

Here at the Department of Fisheries laboratory in Nanaimo, scientists first confirmed that HSMI, responsible for the Norwegian outbreak, was now in BC.

Akman: Kristi Miller is the lead researcher.

Akman to Miller: What would an outbreak of HSMI mean to the farm industry?

Kristi Miller: In Norway the HSMI is so prevalent right now. In the beginning it was just a nuisance, but the average, I'm told, from people who work on it there, is around 7% or 8% mortality. There's the odd time that they've observed up to 35%.

Akman: That's in farmed salmon dying off due to infection that weakens their heart muscles. But the virus has also been found in wild BC salmon, and that worries Miller.

Miller: I've never seen a heart with that much virus in it. For a farmed fish, it's an issue for production, but the issue is if that kind of disease were in wild fish, they don't have that same ability to recover, because if they're emaciated and slow, they're gong to be eaten by a predator.

Akman: Miller's recent discovery has called into question the entire regulatory process, because as far back as 2008 farmed salmon samples containing HSMI and PRV have been submitted to the government, but they never made it to DFO labs because the job of testing salmon is that of the BC government and it didn't raise any alarms.

BC's lead scientist Gary Marty first spotted the disease.

Akman to Marty: Have you found HSMI in farmed fish?

Gary Marty: The first time I reported abnormalities in the heart that looked like HSMI was in 2008. When I talk to our veterinarians, they tell me that we don't have the serious clinical disease that they have in Norway. So we don't use the term HSMI like they do in Norway. We prefer a more general term. To the public it'd just be a heart disease of unknown cause.

Akman: But those veterinarians he's talking about actually work for the fish farms, and their relationship goes further. Documents obtained by **W5** reveal that Gary Marty was also working with Marine Harvest, coauthoring these scientific papers supporting the company's position that there was no HSMI on its BC farms.

Akman to Marty: Critics of these aquaculture farms in water, they say that that relationship is maybe too cozy.

Marty: If we have a good relationship with our industry, if they trust us, they will provide us with samples of dead fish, because every farmer understands they don't want a serious disease.

Akman to Miller: He has a relationship with Marine Harvest.

Miller: He has a relationship with the industry, and he also is the person doing the pathology associated with the regulatory programs. Even if it

isn't a conflict of interest, it certainly has the appearance of one.

The Provincial Ministry of Forests, Lands, Natural Resources and Rural Development is responsible for renewing tenures for fish farms. There is currently a moratorium on the issuance of new tenure. The Federal Department of Fisheries is responsible for renewing licenses.

The relationship between the Provincial and Federal Ministries means that both Licences and Tenures are usually administered in a harmonized fashion as are decisions around renewal.

Essentially, fish farms need both tenure and license to operate. The province is talking with the federal government and First Nations on what these processes look like going forward.
