On behalf of the BC HEROS organization, we respectfully request a meeting with Minister Dix at his earliest opportunity, ref. the many shortcomings of how BC choses to delivery EMS prehospital care province-wide, with specially emphasis on critical and urgent care.

BC HEROS is a Canadian version of a US-style Political Action Committees (PAC). We are a donation supported action group that is dedicated to the modernization of EMS in BC. Our mission is to educate all, including all MLAs and the general public, to the seemingly endless shortcomings of the BCEHS and the Emergency Health Act.

We have already met with two of the three Green MLAs. As well, we recently met with Minister Mike Farnworth. Hence, we believe it only fair to meet with you as Min. Health (perhaps also the Min. James and hopefully Premier Horgan) as a courtesy, to make sure all senior stakeholders fully understand what information we will be making known to the general public (and all MLA) starting in mid-October.

To be clear, proceeding by way of 'the court of public opinion' is not our first choice in resolving this issue, however after decades (yes decades) of inaction in directly meeting with individual MLAs, even ministers, we have now chosen to go with the public education route. Again, we would prefer to work directly with the Greens and NDP to bring about the needed changes quietly, however, if there is no (or only limited) support within the NDP, we will have no choice but to proceed with the multimedia education campaign. FYI, have successfully raised sufficient funds to carry out a sustained multimedia campaign throughout all areas of British Columbian.

As mentioned above, this is not our first choice as it will open 'old emotional wounds' for those families that have lost loved ones to completely treatable conditions in the prehospital setting over the last 43 years (since the Dave Barrett NDP government legislated the EHS Act based on the Foulkes Commission report).

To that end, and in case you don't know, there is no question that the 1974 EHS Act directly contributed to the deaths of thousands (yes thousands) of treatable condition patients in the prehospital setting, it also contributed to 10s of thousands of permanent injuries and or patients which ended up in long term care; this must stop and it is the mission of the BC HEROS organization to urge MLAs of all parties to join together to: make the necessary changes to the EHS Act, and; strike another Royal Commission, one which will have

a mandate to make binding recommendations to review of all aspects of how the BC government choses to deliver EMS care to all residents and visitors.

FYI, moving BC to a truly modern EMS model will save BC society billions (yes, again, you read correctly) billions moving forward and of course many thousands of lives and permeant injuries and long term care patients.

- Can the Ministry of Health / BCEHS assure all BC residents that their chosen ambulance attendantled 'Scoop and Run' prehospital care model yields better (best) possible patient outcomes over the decades long in service 'Franco-German, Stabilize and Transport' doctor-led EMS provision model?
- When a person is in the process of dying, (or at risk of permanent injury or ending up in long-term care) in the prehospital setting in BC, why is it legal for only BC Ambulance Service personnel to provide EMS care beyond First Responder level of care (FR is only 42 hours of training). It is not common sense to allow ALL appropriately trained and licenced medical personnel to come to the aid of such patients in their time of dire need, in what could be the worst, or last day of their lives? Why is it illegal for even a fully licenced doctor, registered nurse, firefighter, police officer, Search and Rescue personnel, private or non-profit, fully trained and licenced in the province of BC, individual to come to the aid of such critical ill patients outside of a hospital while at work to provide them with care to their full level of training?

- If it's legal for a private person to take a patient to a hospital emergency room, why is it illegal for police officer or fire department or Search and Rescue or non-profit or for-profit ambulance firm to do so in BC?
- Why does the BC Ambulance Service not treat patients in severe pain with drugs like all other 'first world' EMS jurisdictions have been for decades?
- BC has a geographic area almost the size of both France and Germany combined and has 4.77
 million residents over 944,000 sq. km with a 27,000 km coastline and very challenging topography,
 yet BCEHS only employs 3,700 attendants, with almost 2,350 attendants being only part-timers and
 with only 240 Advanced Life Paramedics of which 38 are part timers (that a ratio of 1:20,000 ALS

paramedics to population). By comparison, there are 9,327 EMTs working right next door in Alberta, with over 2668 Advanced Life Paramedics (that a ratio of 1:1,500 ALS paramedics to population). In addition Alberta also has: 3,893 Basic Life Support attendants and 2,766 Emergency Medical responders, with many thousand more First Responders, yet Alberta has 283,000 sq. km less land area, no coast line with remote villages, and has both northern and southern level 1 one trauma centers. Most importantly, every single appropriately licenced EMT in Alberta is 'legally allowed' to assist any dying (or injured) person in Alberta which is NOT the case in BC; Why is that? How do legal restriction like that assure a best possible patient outcome for British Columbians?

- In a province where one would be hard pressed to find an SUV, pickup truck, even high end sport car that is NOT all wheel drive, in BC only 9 of BCEHS' circa 500 ambulances are four wheel drive; Why is that? Don't the folks at BCEHS know it snows in BC, in some areas, it snows a lot! Furthermore, and at last check, only half of BCEHS ambulance use actual snow tires in the winter, with the rest us all season tires; why is that?
- Many people each year die from blood loss due to trauma in BC. In many cases, their condition is highly treatable and would not result in death if their injury occurred near a hospital or if the BCEHS ambulance carried universal donor whole blood. Did you know that NOT ONE BCAS ambulance carries universal donor whole blood, not even our air ambulance helicopters; why is that?
- In most first world nations and for many decades now, prehospital critical care needs patients are treated by multispecialty emergency medicine doctors at the scene which can be at their workplace or their home, yet that is illegal in BC and has been for 43 years, it was legal before the 1974 EHS Act was passed by the NDP but not afterwards; why is that? How does such a legal restriction assure best patient outcome for British Columbians?
- Why does BC only have 4 air ambulance helicopters? None of which are doctor-staffed. Highly specialized doctors have been working on Medical
 Air Rescue helicopters in Europe for over 50 years, but not here in BC, why is that? By comparison, Alberta has 6, Ontario has 11.
- Why are fully trained (EMS) and appropriately licenced Fire Rescue crews not legally allowed to
 provide full spectrum EMS care to patients they respond to, even though they are typically 'on
 scene' many minutes sooner than BCAS crews? Why is that? How does that approach assure best
 possible patient outcomes?
- Why are hospitals in BC still decommissioning helipads? Why are new hospitals not building helipads at the time of construction when all other first world jurisdictions have incorporated them as a matter of course for decades?
- Why are only two of BC's 4 medical helicopters staffed with ALS paramedics 24 hours a day and the other two are not?
- Why do BCEHS ambulances NOT use automatic tire chains, like every fire truck in BC?
- Why are BCEHS response times many minutes longer than international bench mark ambulance response times of 7 minutes 59 seconds? Why does BCEHS measure their response times in '50th percentile' and not 90th percentile, like all other first class EMS service providers worldwide?
- Why does BCEHS have 534 Emergency Medical Responder attendants (15% of all BCAS attendants), which only have a grand total of 105 hours of training; 512 of which are part timers? Did you know that a lifeguard in BC only has 8 hours less training?

- Why does BCEHS only have 2,850 Basic Life Support attendants (77% of all BCAS attendants), of which 1,787 are part-timers? To be a Basic Life Support attendant in BC one only need circa 680 hours of training. Alberta has almost 3,893 BLS attendants.
- Did you know that of BCEHS' 3,700 ambulance attendants, only 240 are Advanced Life Support Paramedics (that's only 6% of all BCEHS attendants), of which 38 are part-timers? Did you know that of those 240 ALS paramedics, none work outside of major cities in BC?
- Did you know that of BCEHS' total 3,700 ambulance attendants, 64% are part-timers?
- Did you know that the most salvageable patients in the entire healthcare system present as 'time sensitive patients' in the prehospital setting? In fact, many 'time sensitive' patients are relatively easy (and low cost) to save but our chosen EMS model all but assures a negative outcome for rural and remote region critical / urgent care needs patients in the province.
- Did you know that Germany alone has 138 emergency medicine / anesthetist, doctor-staffed Medical Air Rescue Helicopters? That works out to a ratio of approximately one EMS helicopter per 600,000 people. BC has 4 dedicated EMS helicopters, that works out to a ratio of one EMS helicopter per 1.157 million people (and not one is even staffed with a GP). Why does BC not have more EMS helicopters, especially given our vast distances and challenging topography and resulting extreme ground ambulance response times couple with every low attendant care abilities?
- Did you know that in Germany they have well over a thousand specialty doctors that work on EMS ground cars? BC doesn't even have one doctor working prehospital. Under existing BC law (namely the 43 years old, NDP enacted Emergency Health Act), it is still illegal for a doctor to work outside a hospital unless they are transporting a patient between hospitals; why is that, how does that approach assure best possible patient outcome?
- Why is it that the BC Coroner Service investigation findings are NOT allowed to assign at least a
 portion of the blame for person's death to slow and inadequate prehospital care delivery by the
 BCEHS? Isn't that the very reason for a Coroner Service investigation in the first place to find ways
 to save lives in BC? Clearly, residents and taxpayers are not getting full value for money spent (\$11
 million dollar per year) or actionable information which could prevent future deaths. Coroner
 Service investigations should determine ALL factors contributing to a person's (out of hospital)
 death in BC, not just some factors.
- Did you know that if a person dies inside a hospital in BC, the BC Coroner Service typically does not investigate? So if an attending BCEHS crew is not an Advanced Life Support crew, (e.g. is BLS or EMR crew), given the low level of medical training they have, they must continue to perform CPR/ventilate the patient until a doctor certifies the patient as dead. What that means in the real world is that the 'patient death' then becomes an 'in hospital death' as that is typically where the patient is seen for the first time by a doctor, hence, the BC Coroner Service does not investigate. This systemic failure could potentially lead to hundreds of uninvestigated deaths per year in BC. How does such a flawed investigative process help in the prevention of future deaths? In fact such a flawed systemic process actually skews BCEHS care provision statistics in terms of 'in care death statistics'.
- It appears to us that BCEHS does not seem to track patient outcomes or length of stay within the chain of care / chain of survival; if they did, they would know (very well) that many patients in their care died from treatable conditions. So why does BCEHS management not make the necessary policy recommendations to the political masters? How can they justify 'business as usual' if they either don't know or don't care that people are dying from treatable conditions while in their care.

How does such as systemic flaw within BCEHS ensure best possible patient outcomes for tax dollars spent?

- Did you know the BC Ministry of Health bills back other organization for medical cost incurred while on the job and while driving? Did you know that these billed back costs all contribute to the increased cost of living in BC? Did you know that the last two ICBC rate increases of almost 10% were due to increased medical costs?
- Did you know that WorkSafe BC is billed back by the M/Health for all work related injuries / health related costs? This costs employers vast sums of money each year. As we live in a socialized society, we all pay for these ever increasing health care related costs via higher product costs and lower wage increases.
- Did you know that BC First Nations health care costs are billed back to the First Nations Health Authority, which is a 100% taxpayer funded organization? Did you know that First Nations people have a 4 times higher incidence of trauma? Did you know that many First Nations have extremely slow access to the prehospital care system? Why should non-First Nations British Columbians care; because we pay for all the added costs incurred (not to mention the humanitarian costs to First Nations people in BC). Sooner provision of definitive EMS medical care will not only save more (many) First Nations lives but will also lower everyone's annual taxes; it is in everyone's best interest, First Nations or not, to provide sooner definitive medical care to all people for this exact reason.
- Did you know that many potentially fatal conditions are time sensitive? Meaning that if they are treated in time, they will NOT cause death, yet in BC hundreds, perhaps thousands, die each year from completely treatable but time sensitive conditions, including: trauma (even relatively simple trauma can lead to shock, which can be fatal), heart attack, stroke, anaphylaxis, drowning, bleeding, breathing issues and more. We know how to treat and save a high percentage of such patients but BCEHS is not staffed, trained or equipped to do so by choice! This systemic failure, which causes such patients to die, can be traced directly back to a lack of political will on the part of successive BC governments.
- Several decades ago a highly respected BC trauma surgeon, Dr. Norman Hamilton, carried out a province-wide prehospital death pathology review of all patients which died from trauma prior to arriving at a hospital. Since Dr Hamilton's review BCs population has grown considerably and BCEHS attendant numbers and or care provision abilities, have NOT kept up with population growth, hence, the indicated statistics are likely low, in fact, perhaps much lower than actual. Dr Hamilton's finding were as follows: Greater Vancouver: 12%, Rural Vancouver Island: 45%, Interior: 59%, Northern BC: 75% (Northwest BC 82%). These stats would be much higher still if all 'time sensitive conditions' were added considered (remember these stats ONLY reflect prehospital trauma deaths). Notice how much lower the Lower Mainland prehospital death rate is vs the rest of the province; that is due to sooner access to definitive medical care and not due to a lower incidence of trauma per population number.
- Did you know if a young person in BC wants a career as an Advanced Life Support Paramedic (ALS/ACP) they cannot simply go to school and do their three year / 1,780 hours course and go to work for the BCEHS which is so desperately short of ALS/ACP? The BCEHS' seniority system will NOT allow a new hire ALS paramedic to work to their license level; the union contract will not allow that. They can only provide EMS care to a maximum of Basic Life Support until they have the seniority to practice as an ALS/ACP paramedic; how does this approach assure best possible patient outcomes in BC? If that same young person wanted to become a nurse or doctor, the same Ministry of Health would welcome them into the healthcare system with open arms and on day

- one, they could work to their license. So who is in charge of our EMS prehospital care system / ambulance service, the government or the union?
- Did you know that vast majority of BCEHS personnel is not legally allowed to treat for pain using highly effective drugs? All first-class EMS systems worldwide treat for pain using more than just laughing gas, not only for patient comfort (especially on long return to hospital drives which are inherent in BC) but to help prevent the onset of shock which can cause death.
- Did you know that in most U.S. states, the vast majority of EMS attendants are actual ACP/ALS
 Paramedics? In many states over 75% are ALS/ACP attendants. Almost all work for professional Fire
 Rescue Departments; did you know that it is illegal for any Fire Rescue Department in BC to
 operate even one ambulance? The only notable exception is Kitimat, BC, go figure!?
- Did you know that the 'single (EMS) service provider' model used by BCEHS is mutually exclusive to
 ever having even on ALS paramedic working outside of a major city in BC? However, if the BC govt
 were to regional EMS services, then ALS paramedics could be trained and stay in their home
 regions/towns.
- Did you know that the BCAS still does NOT encourage hospital boards to build hospital helipads? In fact some regional health authorities are still encouraging local hospitals to shut down existing helipads. In fact there are regional higher level treatment hospital have closed helipads! News flash for all those at BCEHS, for critical and urgent care needs patients, seconds count, minutes kill. There is a reason why they are called the 'platinum 10 minutes' and the 'golden hour' in trauma care. All other first class EMS system know this, why not BCEHS?
- Did you know that Norway, a country of only 5.3 million people, have no less than 26 dedicated, short notice air ambulance / air rescue resources? They also have a fleet of dedicated ambulance boats, we have one on contract and BC has a longer coastline than Norway.
- Did you know that a doctor-staffed Medical / Air Rescue Helicopter can legally bypass a local
 hospital to take patients directly to the best suited hospital for their condition? This has been a
 standard approach for all 'state-of-the-art' EMS systems worldwide, why; because it saves critical
 lifesaving / limb-saving time for critical care needs patients. Given that all of BC's level 1 treatment
 centers are located in the southwestern most corner of the province, such use of doctors and bypass protocols, are ideally suited for use in BC.
- Did you know that BCEHS relies heavily on local volunteer Search and Rescue organizations to bring patients to at least a well maintained forestry service road? Such delays can easily turn out to be deadly / leave the patient in long-term care / leave the patient with permanent injury.
- Did you know BCEHS ambulance attendants are not allowed to retrieve a patient if they are down a slope of more than 30%. Local volunteer Search and Rescue groups must first be found, marshalled, brought to the patient site, and then only they can bring the patient up the slope even it's only a few meters long.
