The two day event was very informative and is relevant both provincially and territorially. Basically if you are aware of the exercise of the privilege walk, this would the continuum from the other end of the spectrum. Dr. Felitti discovered that of people had four or more of 10 adverse childhood experiences there were more like to have more health determinants like obesity, auto-immune, strokes and were likely to die about 15 years earlier. Hey Stephanie,

As promised, here is a quick summary of some of the things we talked about earlier. Once you've had time to think over whether you have time for the extra workload, I will e-mail Tim and Becky, and get them to share the contact information for the staff that work on the various elements of wildfire task force materials, with the objective of helping them get to a single, integrated presentation for task force meetings by providing secretariat or administrative support, although we are glad to help their staff through any unfamiliar process items for the interim. Over time we will seek support from Cab Ops or TBS for the task force. The Ministries will continue to make the meeting arrangements, room bookings, AV and catering etc. You will not be taking minutes, but either you or I would be glad to produce a few bullets to summarize meeting outcomes for the chair to report out at other committees.

I think it would be helpful to briefly address the task force processes at the meeting. When there are decisions that need to go to Cabinet / PA, we will certainly arrange for that to happen. When there are updates that are social or economic in nature and that would be useful for a larger group of Ministers to have a more in-depth briefing on than is always possible at Cabinet / PA, these items are routed to other committees. We will continue to work with Tim / Becky to make sure this is functional for the task force.

As we talked about, here are some initial thoughts (for you and I) of some of the content we might look to get into the materials for future task force meetings.
