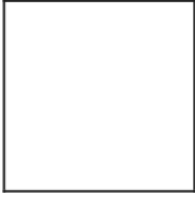

I just wanted to suggest a few different setups for our session ender presser on Thursday. These might be unlikely, but I am interested in keeping the discussion going about having something unique for a setup for this presser, because I think that a uniquely different visual for the media is a good thing for this, if we are not going to go with having cabinet or caucus stand with him (I'm still in favour of that by the way).

Two really professional drawings are attached. Both have the Premier seated in the middle of a table, flanked by Ministers James and Eby, with the table on a riser. They would each have table mics. This would be in the Hall of Honour facing the same way we normally do when we do a presser there from a podium.
