Hi Bob,

Here is the timeline. We made two advance requests. The second request was based on updated cost estimates and advice from Public Safety Canada that we could request up to 50% of our estimated federal share for this event. I've attached the BC letter requesting the additional \$75M advance and the federal letter approving the \$175M advance.

Sept 18, 2017 – BC requested \$100M advance for 2017 Wildfires.

Dec 13, 2017 – Based on revised total DFAA eligible costs, BC requested an additional \$75M advance for this event (see letter attached).

Dec 15, 2017 – Feds issued an Order in Council authorizing DFAA for this event.

Dec 31, 2017 – BC rec'd two EFT payments (\$100M and \$75M).

Jan 26, 2018 – BC rec'd letter from Feds approving \$175M advance (see attached letter).

Okenge and Pierrette:

The Canada-B.C. Workforce Development Agreement was signed by Minister Hajdu today. As Minister Mark signed the agreement on March 8, the WDA is now final. Attached is the full agreement for your reference.

In total, the agreement guarantees B.C. \$685 million in labour market funding over six years, which includes \$116 million in incremental funding.

BC achieved its key negotiating priorities:

- Incremental funding – ensure B.C. receives the maximum incremental funding available (\$116 million),
- Broadened eligibility – ensure all British Columbians can access programs and services needed to obtain a good-paying job,
- Increased flexibility – ensure B.C. has the flexibility to design and deliver locally responsive and inclusive programs and services,
- Simplified data and reporting – minimize new administrative requirements to maximize investments, and
- Focus on outcomes – ensure agreement outcomes align with B.C.'s priority to deliver quality skills training and employment programs.

The WDA does not have an end date and will continue in perpetuity; however the incremental funding ends after six years.s.13,s.16,s.17

Cultivating a clear understanding of the historical and cultural realities of Indigenous people is one of the necessary steps to support the change needed to achieve our Diversity and Inclusion objectives in the BC Public Service.
