Hello Everyone,

As per the commitment of the previous government regarding the deletion of emails, the Deputy Minister to the Premier has requested I send an email to provide direction to the Office of the Premier staff.

Background:

In October 2015, then Information and Privacy Commissioner Elizabeth Denham, conducted an investigation pertaining to records retention and disposal practises by the provincial government. ([OIPC Investigation Report](#)). The provincial government retained former Information and Privacy Commissioner, David Loukidelis to respond on behalf of government where he established 27 recommendations. ([Recommendations to the BC Government](#)).

Current Direction:

As per the previous government's commitment to specific recommendations concerning emails, the Deputy Minister has requested that current staff continue to comply with the following:

- *Triple deleting of emails is prohibited.*
- *Ministers and political staff must retain sent emails, keeping in mind the recommendation of former Information and Privacy Commissioner David Loukidelis that "government should retain only that which has value in law or policy." For greater clarity, former Information and Privacy Commissioner Elizabeth Denham noted that "the routine destruction of transitory records is necessary to reduce the volume of government records and the cost of managing records." Sent emails should be a priority for careful management to ensure that records of value are retained.*

As well, the Deputy Minister has requested that *no staff set up their Outlook to have emails automatically deleted.*

Upcoming Release of Apple iOS 11

The Office of the Chief Information Officer (OCIO) anticipates Apple will release the next version of the iOS operating system (iOS 11) in September. iOS 11 (OS) supports the iPhone 5s and newer versions, as well as various iPads. [The Apple website](#) provides a list of all devices supported by iOS 11.

Until the OCIO has completed a full technical assessment, we advise clients **not** to download

iOS 11. We will also assess compatibility of iOS 11 with AirWatch, the back-end application used to manage iOS devices by the Mobile Device Management Service (MDMS). Upgrading before assessments are complete may result in loss of work data, as older application versions can falsely report your device as compromised.

Once a Security Threat and Risk Assessment (STRA) and an MDMS assessment are complete, the OCIO will provide further information, including how to update devices.

Action Required

iPhone 5, 5c, iPad (fourth generation), iPad Mini (first generation) and earlier devices are unable to upgrade to iOS 11. If these device versions are still in use, clients should upgrade to newer models. Over time, devices not supported by the most recent OS are at a significantly increased risk of being compromised.

Attached please find a copy of our 2016 Economic Impact Study that lays out how the forest sector contributes to the BC economy. It was produced by PWC and commissioned by COFI, Coast Forest Products Association, BC Lumber Trade Council and the Interior Lumber Manufacturers Association. The report was released this morning. We provided an advance copy to both Minister Donaldson and Ralston's offices along with their Deputy Ministers and will be distributing MLA's, BC MPs and Mayors.

The study provides a snapshot of the industry in 2016. Some of the highlights include:

- The sector generates a total 140,000 jobs in BC (direct, indirect and induced)
- 60,000 direct jobs in forestry in BC
- 1 in 4 manufacturing jobs in BC are in forestry
- The industry contributes:
 - \$12.9 billion to provincial GDP
 - \$8.6 billion in labour income
 - \$4 billion in government revenue
- The forest sector makes up 1/3 of all provincial exports and are valued at \$13.7 billion
- BC is a leader in sustainable forestry
 - Three seedlings planted for every tree harvested
 - 259 million seedlings planted in BC in 2016 alone
 - Less than 1% of BC forest land is harvested annually.
