As you may know, the City of Vancouver is issuing an official apology to Chinese Canadians for historical discrimination on April 22<sup>nd</sup>. A number of government MLAs are attending. The City reached out for a public statement of support. If the below statement works, we will also share it with the Chinese Canadian Advisory Committee (also invited to the Sunday event).  
Premier of British Columbia on Apology by the City of Vancouver to Chinese-Canadians  
April 22, 2018  
Today's apology to Chinese Canadians from the City of Vancouver is necessary and important. We must recognize, remember and the condemn the historic discrimination which so many members of the Chinese community endured.  
Members of the Chinese community were denied basic human rights, including the right to own property and live in a neighbourhood of their choosing. Families were broken apart by the head tax. They were denied the right to vote, and to hold public office. They were restricted to working in dangerous and undesirable jobs, and they couldn't freely pursue an education.  
In 2014, the province apologized for 160 wrong and discriminatory policies and laws that targeted the Chinese community. As part of that apology we committed to stopping racism and intolerance in our communities today.  
That means recognizing the role members of the Chinese community played in the history of our province, and it means celebrating their achievements both past and present.  
As part of that work we created plaques and monuments at historically significant locations around the province to commemorate the contributions Chinese Canadians have made to B.C.'s history, culture and prosperity.  
In March of this year, our government also published a special book which honours the achievements of over 90 British Columbians of Chinese descent. We look forward to that book being in public schools and cultural centres throughout the province this fall.  
Together with the City of Vancouver we recognize the historic wrongs suffered by the Chinese community and commit to working every day to stop racism and discrimination so we can make sure these wrongs are never repeated.

**Government announces \$134M to re-grow B.C.'s forests and support communities**

PRINCE GEORGE – Communities and wildlife will benefit from \$134 million being awarded by the Forest Enhancement Society to 71 forest enhancement projects around the Province, Premier John Horgan announced today.

"In the wake of the 2017 wildfires, our government has a responsibility to restore damaged forests and support communities," said Horgan. "These investments in reforestation will benefit ecosystems, workers and communities that rely on forestry for their livelihood." NOT APPROVED

Over \$99 million is being awarded in the Cariboo, with the majority focused on forest enhancement and restoration of public forests impacted by the 2017 wildfires. Approximately 30% of the work will involve or be led by First Nations and their partners.

The funding for the Cariboo also includes \$65 million for the Forest Carbon Initiative, which is a key part of the Province's commitment to climate action. The Initiative supports projects such as increased planting density, incremental reforestation, improved utilization and enhanced fertilization to grow and store forest carbon, reduce emissions and deliver greenhouse gas benefits.

*"Forestry supports tens of thousands of workers and families around the province," said Forests, Lands, Natural Resource Operations and Rural Development Minister Doug Donaldson. "Today's funding will help support B.C.'s economy and our environment."*

In addition to the \$99 million for projects in the Cariboo, the following amounts are being granted to other regions of the province as follows:

- \$4.47 million to Thompson-Okanagan
- \$5 million to South Coast
- nearly \$3.4 million to West Coast
- nearly \$1.7 million to Skeena
- nearly \$1.5 million to Omineca
- \$803,050 to Northeast
- \$2.1 million to Kootenay-Boundary
- over \$15 million to projects that are provincial in nature.

"We're pleased to be able to award funding toward our five purposes to projects around the Province that will benefit forest workers and communities, ecosystems and wildlife habitat," said Wayne Clogg, Chair, Forest Enhancement Society of B.C. "The funding provided by FESBC helps to restore and enhance B.C.'s Crown forests, providing a tremendous benefit for future generations."

The Forest Enhancement Society of B.C. was set up specifically to advance the environmental and resource stewardship of British Columbia's forests by:

- preventing and mitigating the impact of wildfires;
- improving damaged or low value forests;
- improving habitat for wildlife;
- supporting the use of fibre from damaged and low value forests; and

- treating forests to improve the management of greenhouse gases.
