The Honourable Janet Austin Lieutenant Governor



Prior to assuming the role of Lieutenant Governor for British Columbia, Janet Austin spent 15 years as Chief Executive Officer of YWCA Metro Vancouver, one of B.C.'s largest and most diversified non-profits. There she oversaw operations that delivered services to tens of thousands of people annually from more than 40 locations.

Under her leadership, the reach and scope of services offered by the YWCA increased significantly, and the social enterprise model she championed has secured the organization's financial security for the foreseeable future. She has positioned the YWCA as a leading voice on women's equality and she has fostered collaborative relationships with non-profits, the business community and all levels of government.

An active community volunteer, Janet Austin has served on the boards of TransLink, the Greater Vancouver Board of Trade, the Canadian Paediatric Society, MOSAIC, Dr. Peter AIDS Foundation, and many others. Her commitment to helping others has earned her accolades, including an Honorary Doctorate of Laws from Kwantlen Polytechnic University, the Business in Vancouver (BIV) CEO of the Year and the Queen's Golden and Diamond Jubilee Medals. She was invested as a Member of the Order of B.C. in 2016.

Raised in Calgary, Alberta, she is a graduate of English from the University of Calgary. She spent her early career in public sector roles in Calgary, working in regional planning, public consultation and communications. She later moved to British Columbia, where she worked with BC Housing and served as Executive Director of Big Sisters of BC Lower Mainland.

The Lieutenant Governor's Role

The Lieutenant Governor is the representative of Her Majesty The Queen of Canada in the Province of British Columbia, and as such, takes precedence over everyone in the province except the Sovereign. The Lieutenant Governor personifies the Crown, which is both the apex and the unifying link in the constitutional and political structure of the province — executive, legislative and judicial. All legislation must receive Royal Assent before it becomes law. It must therefore be signed by the Lieutenant Governor. All Orders-In-Council and official proclamations are also signed by the Lieutenant Governor in the name of The Queen.

The prime responsibility of the Lieutenant Governor is to ensure that at all times there is a First Minister in the province and, after the selection of the First Minister, any time when the position is vacant because of death or resignation, or after defeat in a provincial election, or as a result of a non-confidence motion in the Legislature, the Lieutenant Governor must either dissolve the House or call upon someone else to become the First Minister and try to form a viable government.

It must be remembered that in no way is the Lieutenant Governor of the province subordinate to the Governor General of Canada in any matter falling within provincial jurisdiction. The Lieutenant Governor, although not elected to speak for the majority in our democratic Parliamentary system, cannot wield political power in practice, yet it must be realized that the Lieutenant Governor is the source of the power of the government of the day.

Although the government in office can decide how the power of the state is to be used, that power never really passes to the government — it always remains with the Crown. Thus the power of the state is held in a non-partisan office, above the conflicts and divisions of the political process, and as a consequence it is a unifying force because it represents equally all of the elements which make up the state.

Installation of the Lieutenant Governor

The Constitution Act, 1867, provides that for each Province there shall be an officer, styled the Lieutenant Governor, appointed by the Governor General in Council by instrument under the Great Seal of Canada. This is reflected in the Commission of Appointment of the Lieutenant Governor, printed in this program.

Each Province is responsible for developing a ceremony with due solemnity that includes participation of the Chief Justice and the members of the Executive Council, reading of the Commission of Office, and administration of oaths. On the advice of the federal government, the ceremony normally takes place within the Legislative Building of the Province, rather than the official residence of the Lieutenant Governor, to reinforce the solemnity of the occasion and the role of the Executive Council in oversight of the arrangements.

The Role of the Executive Council

The Executive Council, commonly referred to as the Cabinet, is composed of the persons appointed by the Lieutenant Governor on advice of the Premier. The Premier of British Columbia is President of the Executive Council. The members of Cabinet are formally referred to as Ministers of the Crown and are all members of the Executive Council.

The installation of the Lieutenant Governor is an Executive Council event. Members of the Executive Council serve as witnesses to the installation by the Chief Justice of British Columbia.

THE ORDER OF BRITISH COLUMBIA

The Order of British Columbia represents the highest form of recognition the Province can extend to its citizens. Established by statute on April 21, 1989, it recognizes those persons who have served with the greatest distinction and excelled in any field of endeavour benefiting the people of the Province or elsewhere. Her Honour, the Lieutenant Governor is the Chancellor of the Order of British Columbia.

Nominations for next year must be received by the first Friday in March (March 1, 2019).



THE COLLAR OF OFFICE

The collar displays the insignia of the Order of British Columbia and the Coat of Arms of the Province. It is linked by the provincial floral emblem, the Pacific Dogwood, and the shield of arms and is the symbol of the authority of the Chancellor.



GREAT SEAL OF BRITISH COLUMBIA

The tradition of using seals to indicate sovereign will was passed down from the British colonial system of government. The Keeper of the Great Seal is the Attorney General who receives it from the Lieutenant Governor when he or she is sworn into office, and returns it to the Lieutenant Governor when he or she leaves office.







This is reflected in the Commission of Appointment of the Lieutenant Governor, which is printed in your commemorative program.

Each Province is responsible for developing a ceremony with due solemnity that includes participation of the Chief Justice and the members of the Executive Council, reading of the Commission of Office, and administration of oaths. On the advice of the federal government, the ceremony normally takes place within the Legislative Building of the Province, rather than the official residence of the Lieutenant Governor, to reinforce the solemnity of the occasion and the role of the Executive Council in oversight of the arrangements."

Cabinet Secretary then announces: "I would now like to ask you to please rise for the entrance of the Premier of British Columbia, the Chief Justice of British Columbia and the Speaker of the Legislative Assembly and remain standing for the entrance of the Lieutenant Governor-designate in a second procession."



Her Honour takes her seat.

"The Sergeant-at-Arms with the Black Rod will now enter the Chamber. The Black Rod is carried and used on formal occasions when the monarch or a vice regal representative is present in the Legislative Assembly of British Columbia."

The Sergeant-at- Arms enters the Chamber with the Black Rod on his shoulder, proceeds to the Throne in front of Her Honour; he bows, takes it into his two hands to show Her Honour, bows, and proceeds to his position on the floor.

"I am pleased to invite the Honourable John Horgan, Premier of British Columbia to say a few words."

The Premier rises and, from his place, delivers an address. (3 minutes)

The Cabinet Secretary remains at the Lectern.

Tuesday, April 24, 2018

- Ladies and Gentlemen, my name is Don Wright and I am the Deputy Minister to the Premier and Cabinet Secretary.
- Welcome to the Installation Ceremony of the 30th Lieutenant Governor of British Columbia.
- I wish to recognize and acknowledge the Lekwungen People, now known as the Esquimalt and Songhees Nations, on whose traditional territories we are gathering today.
- It is enacted in and by The Constitution Act, 1867, that for each Province there shall be an officer, styled the Lieutenant Governor, appointed by the Governor General in Council by instrument under the Great Seal of Canada.
- This is reflected in the Commission of Appointment of the Lieutenant Governor, which is printed in your commemorative program.

- Each Province is responsible for developing a ceremony with due solemnity that includes participation of the Chief Justice and the members of the Executive Council, reading of the Commission of Office, and administration of oaths.
- On the advice of the federal government, the ceremony normally takes place within the Legislative Building of the Province, rather than the official residence of the Lieutenant Governor, to reinforce the solemnity of the occasion and the role of the Executive Council in oversight of the arrangements.
- I would now like to ask you to please rise as you are able for the entrance of the Premier of British Columbia, the Chief Justice of British Columbia and the Speaker of the Legislative Assembly.


[Once the first procession has entered the chamber...]

 Ladies and Gentlemen, please remain standing for the entrance of the Lieutenant Governor-designate, Ms. Janet Austin and Mr. Ashley Chester and for the singing of God Save the Queen.

[Entrance of Second Procession and singing of God Save the Queen.]

 Ladies and Gentlemen, please remain standing while the blessing is delivered by Shirley Alphonse from the T'Sou-ke Nation.

[Following the blessing, return to the podium.]

- Thank you. Please be seated.
- We will now proceed with the ceremony.

- Lieutenant Governor-designate, Premier, Chief Justice, Mr. Speaker, Members of the Executive Council, Members of the Queen's Privy Council for Canada, Members of the Legislative Assembly, family and friends, distinguished guests, ladies and gentlemen,
- Janet Austin appears before the Executive Council
 of the Province of British Columbia today to present
 her Commission of Appointment and to be sworn in
 as the 30th Lieutenant Governor of the Province of
 British Columbia.
- Whereas it is enacted in and by the Constitution Act, 1867, that for each Province there shall be an Officer, styled the Lieutenant Governor, appointed by the Governor General in Council by instrument under the Great Seal of Canada;
- And whereas, by and with the advice of the Queen's Privy Council for Canada, the Governor General has in the Queen's name, by Commission under the Great Seal of Canada, constituted and appointed Janet Austin to be Lieutenant Governor in and over the said Province of British Columbia, one of the Provinces of Canada and thereby

authorized and empowered and commanded her in due manner,

- to do and execute all things belonging to her said command and trust according to the several powers, provisions and directions granted or appointed to her by virtue of the said Act, and of all other Statutes in that behalf, and of the said Commission, according to such instructions as were with the said Commission given unto her, or which might, from time to time, be given to her in respect to the said Province of British Columbia, under the Governor General's Sign Manual or by order of the Queen's Privy Council for Canada, and according to such laws as are or may be in force within the said Province of British Columbia.
- Now therefore, the Governor General by her instructions under her Sign Manual, by and with the advice of the Queen's Privy Council for Canada, declares her pleasure to be that the Lieutenant Governor of the Province of British Columbia for the time being shall, with all due solemnity, cause the said Commission under the Great Seal of Canada, appointing her Lieutenant Governor, to be read and published in the presence of the Chief

Justice for the time being or other Judge of the Supreme Court or as the case may be of the said Province of British Columbia and of the members of the Executive Council in the said Province.

[PAUSE]

 MADAM, is it your pleasure to have your Commission read and published?

[The Lieutenant Governor-designate replies: "It is my pleasure."]

 I call on Jerymy Brownridge, Private Secretary to the Lieutenant Governor, to come and read the Commission in English.

[Go to your seat during the reading of the Commission in English.]

[At the conclusion of the reading in English, return to the podium.]

 I call on Assunta Di Lorenzo, Secretary to the Governor General, to come and read the Commission in French.

[Go to your seat during the reading of the Commission in French.]

[At the conclusion of the reading in French, return to the podium.]

- The Governor General further declares her pleasure to be that the Lieutenant Governor shall take the oath of allegiance in the form prescribed by the Constitution Act, 1867, and likewise that she shall take the usual oaths for the due execution of the office of Lieutenant Governor, which oaths the Chief Justice of British Columbia shall and is hereby required to tender or administer unto her.
- The Honourable Robert Bauman has been requested and authorized to administer the Oath of Allegiance and the Oaths of Office to Janet Austin.
- MADAM, is it your pleasure to take the Oaths of Allegiance and Office?

[The Lieutenant Governor-designate replies: "It is my pleasure."]

• The Chief Justice of British Columbia is now requested to administer the Oaths.

[Go to your seat during the administering of the oaths.]

[At the completion of the oaths, the Chief Justice calls on the Premier to witness the signature.]

[Rise from your seat and move to the side of the table.]

[Standing on the left side of the table, indicate the signing locations.]

The documents are already in place in a signature book on the table. There is one document (a French version on the left side and English version on the right) in front of her; the Lieutenant Governor signs the oaths in the places indicated by you. (Four signatures in total)

The Lieutenant Governor steps aside from the table back behind the chair and witnesses the signing.

The Chief Justice then sits and attests the Jurat (two signatures – the Fr vers and Eng vers), and resumes standing.
[Chief Justice signs on green dot]

The Premier then sits down and signs the oaths (Fr and Eng), resumes standing.

[Premier signs on blue dot]

[Official photographs are taken. The Premier congratulates the new Lieutenant Governor and His Honour.]

[Push the chair back into place at the table.]

[The Chief Justice shakes hands with the new Lieutenant Governor and His Honour. Official photographs are taken of the congratulations. Their Honours, the Premier and the Chief Justice stand behind the table for a group photograph. The Chief Justice and the Premier return to their seats. Their Honours move back to their seats and remain standing.]

[Return to the lectern.]

 Ladies and Gentlemen, please rise for Her Honour, The Honourable Janet Austin, the 30th Lieutenant Governor of British Columbia, and His Honour Mr. Ashley Chester and please remain standing for the playing of the Vice Regal Salute.

His Honour ascends to stand in front of the chair beside the Throne and Her Honour ascends and stands in front of the Throne. Fanfare trumpeters, then Vice Regal Salute is played, 15 guns are fired.

At conclusion of the Vice Regal Salute, Her Honour, the Lieutenant Governor bows to the right and to the left. The Lieutenant Governor says "Pray be seated". They both sit down.

[Remain at the podium.]

 Ladies and Gentlemen, I am pleased to introduce the Vancouver Symphony Orchestra School of Music String Quartet, which will play Minuet from "Berenice" by G.F. Handel.

[Remain at the podium for Musical Interlude.]

- Thank you.
- The Attorney General, the Honourable David Eby, will now return the Great Seal of the Province of British Columbia to the Lieutenant Governor.
- The tradition of using seals to indicate sovereign will was passed down from the British colonial system of government.
- The Great Seal is entrusted to the safe keeping of the Attorney General who receives it from the Lieutenant Governor when he or she is sworn into office, and returns it to the Lieutenant Governor when he or she leaves office.

[Remain at the podium while Great Seal is presented.]

At the conclusion of the Great Seal presentation – the Lieutenant Governor returns it to the Attorney General.

- The Secretary to the Order of British Columbia Advisory Council will now present the Collar of Office to the Lieutenant Governor, the Honourable Janet Austin as the Chancellor of the Order of British Columbia.
- The collar displays the insignia of the Order of British Columbia and the Coat of Arms of the Province.
- It is linked by the provincial floral emblem, the Pacific Dogwood, and the shield of arms, and is the symbol of the authority of the Chancellor.

[Remain at the podium while the Secretary of the Order of British Columbia (Chief of Protocol) presents the Collar of Office to Her Honour and Her Honour takes her seat.]

- The Sergeant-at-Arms with the Black Rod will now enter the Chamber.
- The Black Rod is carried and used on formal occasions when the monarch or a vice regal representative is present in the Legislative Assembly of British Columbia.

[Once the Black Rod has entered the Chamber...]

 I am now pleased to invite the Honourable John Horgan, Premier of British Columbia to say a few words.

[Remain at the Podium while the Premier speaks.]

[At conclusion of Premier's remarks...]

- Thank you Premier.

[Step to the right of the podium to make room for the minister to stand behind the microphone. Remain standing.]

[At conclusion of Minister's remarks...]

[Return to your seat.]


