SURREY - Hundreds more Surrey students will soon be attending seismically safe schools.

Minister of Education Rob Fleming announced \$10.4 million in funding today for seismic upgrades at Mary Jane Shannon Elementary and Bear Creek Elementary.

This investment means an additional 850 students in Surrey will be safer in the event of an earthquake, giving families the comfort of knowing their children are learning in a secure, healthy environment.

Mary Jane Shannon Elementary, in the Guildford Park area, will have its two-storey classroom block and its gymnasium seismically upgraded at a cost of \$7.33 million. Construction is expected to begin in the fall of 2018. Portable classrooms will be used to temporarily accommodate students until the project's completion, in time for school opening in September 2019.

Bear Creek Elementary's seismic upgrades will cost \$3.11 million and will include the school's west block of classrooms and gymnasium. Construction is scheduled to begin in July 2018 with the classrooms completed by September 2018 and the gym a month later.

Currently, 21 of the 28 high-risk schools in the Surrey School District have been seismically upgraded. These two projects will see the district's highest-priority seismic upgrades completed.

Government is addressing the backlog of seismic and capital projects throughout B.C. This includes encouraging collaboration between the Ministry of Education, school districts and local governments to meet ambitious timelines and reduce the time it takes to plan and upgrade a school. Government will also work to cut wait times for school construction by accelerating the funding approval process.

Today's announcement follows government's recent \$33-million commitment to build 955 new student spaces in Surrey with a new elementary school in Grandview Heights and an addition at Pacific Heights Elementary school.

Government is working to approve funding for 50 seismic upgrade projects in 18 months.

"These projects represent a milestone because these are the only schools remaining in the district that are rated 'most vulnerable' for seismic risk. We look forward to seeing these building upgrades completed and thank students, staff and parents for their patience during construction."

### Quick Facts:

- \* Government has committed \$522 million over three years for seismic upgrades across B.C.
- \* Mary Jane Shannon Elementary school was built in 1958 with additions in 1962, 1965, 1968 and 1973. It is a kindergarten-to-Grade 7 school with 374 students.
- \* Bear Creek Elementary school was built in 1964 with additions in 1972, 1977, 1979, 1981, 1991 and 2000. It is a kindergarten-to-Grade 7 school with 495 students.

**Request:** Do you have any details of what the new labour model will mean for Site C? So this thing you sent me (link to the government Site C webpage: <a href="www.gov.bc.ca/sitec">www.gov.bc.ca/sitec</a>) says there were 18 apprentices on the job site in October. The Premier told me the low number of apprentices is "pathetic" so do we have new targets, and how will that work — I am guessing it only applies to new hires?

**Recommendation:** Have GCPE provide information on background by email.

#### Response:

- As we move ahead with completing Site C, we are putting in place a Site C turnaround plan
  which includes establishing new Community Benefits Programs mandated to make sure that
  project benefits flow to local communities, and increase the number of apprentices and First
  Nations workers hired onto the project.
  - Existing Community Benefits Agreements between BC Hydro and Peace Valley communities will be enhanced, to bring forward benefits for workers and others as construction on Site C continues.
  - To date, BC Hydro has reached agreements with the Peace River Regional District (PRRD), the District of Chetwynd, District of Taylor, the District of Hudson's Hope and the City of Fort St. John that will provide lasting benefits for residents of the Peace region. A regional legacy benefits agreement between BC Hydro and the PRRD will provide \$2.4 million annually to the PRRD and its member communities for a period of 70 years, starting when Site C is operational. The funding will be indexed to inflation.
  - In addition to these existing agreements, BC Hydro will work with its contractors and labour organizations to redouble efforts to create apprenticeship opportunities during construction to ensure that workers from the Peace Valley and other parts of B.C. receive the on-the-job training and experience they need to complete their training in high-skill, high-demand trades.

- Existing contracts will not be changed, but further opportunities for increasing apprentices and First Nations participation under them will be pursued by BC Hydro.
- New contracts will have mandatory requirements for apprentices.
- We're also going to explore options for relocating Site C worker accommodations, post-completion, to a local skills-training institution
- A new Project Assurance Board made up of BC Hydro, independent experts and government representatives – will provide enhanced oversight to future contract procurement and management, project deliverables, environmental integrity and quality assurance – all within the mandate of delivering the project on time and budget. The terms of reference for the board, including its members, is currently under development.
- EY Canada has been retained by BC Hydro to provide dedicated budget oversight, timeline evaluation and risk assessment analysis for the duration of the project.
- Whether or not there will be changes to the current labour model for Site C will be determined under this enhanced oversight.

Dear Premier Horgan,

On behalf of the Canadian Beverage Association (CBA), I wanted to share with you the Conference Board of Canada (CBOC)'s latest report on the Balance Calories Initiative – a voluntary, industry led initiative with the intended goal of reducing the calories from sugar that Canadians consume from liquid refreshment beverages by 20% by 2025.

The CBOC released their findings last week, and you'll see they've confirmed we are well on our way to meeting our goal and that in the first two years of the <u>Balance Calorie Initiative</u> the number of calories Canadians are consuming per capita/per day has gone down by 10.2 percent, totaling a reduction of nearly 30 percent since 2004.

In fact, the most recent Statistics Canada, Canadian Community Health Survey (2016) corroborates the reduction, clearly showing a significant decrease in consumption of almost 30 percent.


