## B.C. Wine Month Launch Questions and Answers

#### **B.C. WINE MONTH**

#### Q: What is B.C. Wine Month all about?

- When B.C. wine makers were targeted unfairly, we made it clear we would be there to support our wine-making community.
- B.C. wines and the people who make them deserve to be celebrated and supported.
- This month, we are going showcase our award winning B.C. wine sector to British Columbians, and encourage them to responsibly enjoy the great wines we produce.
- B.C. winemakers make a great product, and contribute jobs and economic activity to many communities, and the hard working people in this industry deserve our support. That is what Wine Month is all about.

#### Q: What are you hoping to accomplish during B.C. Wine Month?

- We are going to shine a spotlight on the work they do and the wine they make.
- From the winemaker to the tasting room associate to the picker who goes out to harvest ice wine at below freezing temperatures. We are going to tell their stories, to help connect B.C. wines and B.C. wine drinkers.
- To kick things off the B.C. Government has officially proclaimed B.C. Wine Month for the month of April.
- We then committed \$100,000 to the B.C. Wine Institute to promote B.C. wines to British Columbians.
- At the same time, our tourism marketing agency Destination B.C. is launching a \$150,000 campaign to promote wine and food tourism this spring.
- We're also working with the institute on opportunities to expand their international sales, and I look forward to the results of those cooperative efforts as well.

#### Q: Alberta's wine ban is over. Is it really necessary to still have a B.C. Wine Month?

- Building markets for B.C. products is always a good idea, and one our government is always working on.
- When B.C. wineries were unfairly targeted, our government chose to stand in support of B.C. wineries, and to support this industry.
- B.C. Wine Month is an opportunity to celebrate and support B.C.'s grape growers and winemakers.
- We know the last few months have been challenging for the B.C. wine sector, and the B.C. Government has their back. Together we're going to make it happen.

#### Q: Are you worried about possible complaints about trade agreement violations?

• Like all jurisdictions do with their products, we will continue to promote B.C.'s high-quality wine industry in Canada and throughout the world.

#### WINE FACTS:

- British Columbia is home to 929 vineyards, including more than 350 licensed wineries.
- There are 4,130 hectares of wine grapes grown in B.C.
- More than 60 grape varietals are produced in the province, including Merlot, Pinot Gris, Pinot Noir, Chardonnay, Cabernet Sauvignon, Gewürztraminer, Cabernet Franc, Syrah, Riesling and Sauvignon Blanc.
- In 2016, B.C. wine exports increased 4% over the previous year to \$9.7 million, and were shipped to 17 international markets.
- The top international markets for B.C. wine in 2016 were China (54%), Taiwan (23%) and the United States (11%).
- B.C.'s wine industry employs about 12,000 people, and contributes approximately \$2.8 billion per year to the B.C. economy.

#### SUPPORT FOR AGRICULTURE SECTOR

# Q: What is your vision for B.C. agriculture? What are you going to do for other farmers and sectors?

- I think we can all agree we have something special when it comes to B.C. food and beverage products, and our government is committed to supporting that.
- We're bringing back Buy B.C., a strategic and coordinated approach to help B.C. farmers and food producers across the spectrum identify their products in the marketplace as being from here.
- As I saw on my trade mission to Asia, B.C. products are in demand internationally as well, and just as I did then, we are going to continue to promote them as the high quality and trusted products they are.
- By partnering with the sector and the network and relationships the B.C. government is building overseas, we are going to see an increase in B.C. exports of B.C. food and beverages, and an increase in opportunities and incomes for British Columbians working in farming, ranching and processing.
- One thing our government has demonstrated is that we are there for British Columbians
  when they need it, and agriculture is no different. We provided support to B.C. farmers
  and ranchers to help them recover from the wildfires of last summer, we provided \$5
  million to the tree fruit sector here in the Okanagan for a Competitiveness Fund, and we
  are supporting B.C. winemakers and grape growers through B.C. wine month.

#### **RECREATIONAL MARIJUANA**

#### Q: Do you envision a Marijuana month in B.C. or a Buy B.C. Pot Marketing campaign?

- There are currently no plans for a B.C. government-led marijuana month or any other marketing campaign.
- There are still many federal government decisions regarding the production and distribution of recreational marijuana that need to be made, and that's where our attention on the topic currently is.

- Many British Columbians have expressed a concern that the ALR and the ALC, in their current state, needs help, and I agree with them.
- The B.C. government is committed to food security and has also established the ALR committee review which is part of the minister's mandate to increase food production.
- B.C. farmers, communities, and the public are shaping the revitalization of the ALR.
- The revitalization is looking at ways we can make it easier and more efficient for the Agricultural Land Commission to fulfill their mandate of protecting farmland and encouraging farming.
- British Columbians have until April 30 to submit their feedback on revitalizing the ALR by visiting the government website (<a href="http://engage.gov.bc.ca">http://engage.gov.bc.ca</a>)
- I encourage everyone to provide their input and comments on this, and other topics of discussion. The information is there because we want to hear from British Columbians.

#### **FISH FARMS**

Q: Another topic, salmon returns in the XXXXX River have been down for the last couple of years, what is the status of the fish farm review on the coast?

- In B.C., the primary regulator for open net pen Atlantic salmon fish farming is the federal department of Fisheries and Oceans.
- The Province is concerned about protecting wild salmon and the migratory routes that they use and is interested in moving to closed containment where feasible.
- The Province has recently begun a government-to-government conversation with five bands and six First Nations in the Broughton Archipelago regarding their concerns with Atlantic salmon open net fish farms. It is too early in the process to presuppose the outcomes of those discussions.

- Our public health-care system is meant to provide high quality care to everyone based on need, regardless of where they live or their ability to pay.
- In recent days, we announced steps we are taking to strengthen and create more access in the public system to get people the care and procedures they need faster.
- Under the BC Surgical and Diagnostic Strategy, 9,400 more surgeries – 4,000 additional hip and knee, 900 dental and 4,500 other surgeries – will be done across the province by 2018/2019 compared to the previous year.
- Funding of \$11 million will also see close to 37,000 more magnetic resonance imaging (MRI) exams done, which will help us achieve a total of 225,000 MRI exams in 2018-19.
- We believe fair and equitable public access to health care is at the cornerstone of making life better for people – no matter where they live throughout the province.
  - In fact, the great Tommy Douglas inspired the nation to embrace this philosophy; we all walk in his footsteps, it's our responsibility to protect and strengthen public medicare.
- Medicare is protected by law in B.C. and Canada under the Medicare Protection Act, Hospital Insurance Act, as well as the Canada Health Act.

- It is our expectation that those providing health care in B.C. follow the law and that our laws protect people.
- But we know that is not always the case:
  - B.C. has also been fined every year of the past five years by the federal government – approximately \$1 million in total – for allowing extra billing in violation of the Canada Health Act.
  - Insert historical details of audits
  - These audits leave no ambiguity that illegal extra billing is occurring.
- These past audits have also resulted in fines and reduced federal funding.
  - In fact, this March the federal government fined B.C.
     \$15.9 million for extra billing thought to be occurring in 2015/16.
  - o That would amount to approximately 53,000 MRIs.
- It is simply unacceptable that some people and organizations are purposefully breaking our health-care laws, creating an unfair system for patients and putting at risk federal funding.
- Previous health ministers and even premiers have said that they would act but have not.
  - Insert QUOTES

- Today we are taking steps to protect patients and our public health care system by bringing into force sections of the Medicare Protection Act, 2003 (the act).
- The act introduced by previous Health Minister Colin Hansen which passed initially, then was subsequently killed by the then premier, which left the enforcement measures sitting on the books ever since.
- With all sections of the act now in place, government has clarified the rules around extra billing for health-care practitioners, and set out clear consequences for breaking those rules.
- Practitioners who extra bill patients may now be required to refund the fee paid, face fines of up to \$10,000 for the first offence and up to \$20,000 for a second offence if convicted of wrongly charging patients and may be de-enrolled from MSP, making them unable to bill the public health-care system.
  - We know that most practitioners, bill appropriately, in accordance with the Medicare Protection Act, and they will never be fined.
- In addition, previously when patients raised concerns we could only refer them to an audit process. Now there are new protections for beneficiaries that establish they are not liable for extra billings and create an ability for the Medical Services Commission to refund beneficiaries and recover the charge.
- The provisions also take steps to guarantee fair access to surgery and other treatments by ensuring that people cannot buy priority access by getting private procedures – like MRIs –

jumping ahead of others waiting in line for publicly funded procedures.

- We have a publicly funded system that is delivered in large part by private providers – great family doctors, specialists, community health clinics who are private businesses...and each year the health authorities contract out \$15.7 million in service to private providers – we are not against this – what we are against is breaking the law.
- Our laws and the principles of health care in B.C. support a single payer model – the government.
- By stopping extra billing while making necessary investments in the public system, more people will have access to the services they need.
- With this action, I will be asking the federal government to reimburse B.C.
- It is government's responsibility to strengthen the system and focus on improvements that prevent the need for parallel systems where people feel the need to buy their way to the front of the line.
- Not only is that illegal, but it undermines the principles of medicare.
- This government has made it a priority to support and strengthen our public health-care system and the action we are taking helps us ensure that we have a health system that works for everyone – not just the wealthy and the well connected.

#### Secondary Surgical/MRI Facts

- Under the surgical strategy, 9,400 more surgeries 4,000 additional hip and knee, 900 dental and 4,500 other surgeries – will be done across the province by 2018/2019 compared to the previous year.
- The surgical strategy has four areas of focus:
  - Providing more surgeries in areas with long wait times, starting with hip and knee surgeries and incrementally tackling other surgeries with long waits;
  - 2. Investing to keep up with growing demand for all other surgeries;
  - Making surgical programs and operating rooms are more efficient across the province through better planning and scheduling and, establishing centralized booking and a single point of contact for patients; and,
  - 4. Making sure the right number of health professionals are in place to deliver the services needed to meet demand both now and into the future, including surgeons, anesthetists, nursing and rehabilitation health professionals.
- The additional surgeries will mean a 34% increase in hip and knee; a 15% increase in dental, and an over 3.5% increase in all other surgeries compared to 2016-17 levels.
- This will significantly reduce the number of patients waiting.

- In 2016/17 30% of people across B.C. waiting for hip surgery and 38% of people waiting for knee surgery waited more than 26 weeks.
- Under this strategy only 10% of patients will wait longer than 26 weeks for hip or knee surgeries by the end of 2018/19, falling to 5% in 2019-20.
- Funding of \$11 million will also see close to 37,000 more magnetic resonance imaging (MRI) exams completed and achieve a total of 225,000 MRI exams in 2018-19.
  - In 2017-18 health authorities are projected to complete approximately 188,000 exams.
- Reaching MRI targets will be achieved by:
  - operating existing machines longer to accommodate additional exams;
  - centralized intake at a regional level that will reduce duplicate referrals and appointments, preventing wasted operating time, while also offering patients the earliest appointment available in a region, as appropriate; and,
  - the installation of already planned MRI machines.

#### Province helping owners of manufactured homes protect their investment

PENTICTON – The Province is increasing security for owners of manufactured homes by increasing the compensation they will receive if they are forced to move because of redevelopment.

"People deserve to feel safe and secure in their housing. For too long, manufactured home owners have faced uncertainty due to rising land values and redevelopment, and they have not had adequate protections when evicted. No one should have to face financial ruin or potential homelessness when facing eviction from a manufactured home park," Premier Horgan said. "We are taking action to give people increased peace of mind by strengthening protections for owners of manufactured homes."

The Government of British Columbia is proposing changes to the Manufactured Home Park Tenancy Act that will create fairness for tenants when landlords choose to close or convert a park.

The proposed changes will provide stronger protections for people affected by manufactured home park closures by:

- ensuring the effective date of a 12-month notice to end tenancy is the same for all tenancy agreements under the Act;
- increasing the amount of compensation landlords pay tenants who have been given a notice to end tenancy' to convert a park;
- increasing the amount of compensation a landlord owes a former tenant if the landlord gave notice but did not do the conversion;
- providing additional compensation if a manufactured home cannot be relocated; and
- clarifying that a tenant who is unable to relocate their manufactured home is not responsible for disposal costs of the home.

Legislation will be introduced to enact the changes later this month.

Current compensation is too low to cover a tenant's moving costs, or loss of equity and loss of affordability that happens when tenants can't find a place to move their home. The proposed amendments will assist displaced tenants to move their home to another site, if possible and compensate them for the loss of their home if they are unable to move it.

These changes to better protect manufactured home owners are part of Government's 30-Point Plan for a fairer housing market.

"Manufactured homes are an important source of affordable housing often used by vulnerable groups, including seniors, people with disabilities and those on fixed income. The current laws are not strong enough to protect these people, and we are taking action to give tenants the security of knowing they will be fairly compensated if they have to find new homes."

# Amendments to the Residential Tenancy Act to Provide Stronger Protection for Manufactured Home Park Tenants Questions & Answers March 20, 2018

Advice to Minister of Municipal Affairs and Housing

#### **Proposed Legislation:**

#### What is being proposed?

- Our government will make changes to the Residential Tenancy Act to address issues related to redevelopment of manufactured home parks.
- The changes will allow:
  - government to increase compensation to tenants when a landlord ends a tenancy to redevelop or close a park to address moving expenses, inconvenience and loss of affordability;
  - a tenant to apply for additional compensation if they cannot move their manufactured home,
  - o a landlord to end fixed term and periodic tenancies 12 months' after giving a notice to end tenancy to redevelop or close the park;
  - A tenant with a fixed term tenancy who has been given a notice, the ability to end the tenancy before the fixed term ends;
  - Government to increase compensation owed to a tenant if a landlord closes or converts a park and does not close or convert the park like they said they would; and

#### Q1: Why are these changes being proposed?

Compensation for lost value:

- Closure and redevelopment of manufactured home parks, displaces vulnerable people who may be unable to relocate their home.
- Current compensation is too low to cover a tenant's moving costs, or loss of equity and loss of affordability that happens when tenants can't find a place to move their home to.
- The proposed changes will assist displaced tenants to move their home to another site, if possible and compensate them for the loss of their home if they are unable to move it.

Deterring landlords from closing parks for unlawful purpose:

- Government will be able to increase compensation owed to a tenant if a landlord ends a tenancy to redevelop or convert a park, but does not accomplish the reason for ending the tenancy.
- The director of the Residential Tenancy Branch will be able to excuse the landlord from paying this amount if there were extenuating circumstances preventing the landlord from accomplishing that purpose.

#### Q2: How will these changes affect landlords and tenants?

- Tenants will receive increased compensation when a manufactured home park is closed.
- Landlords will have certainty with respect to closure costs, and be able to end all tenancies on the same date.

#### Q3: Do other jurisdictions have similar compensation requirements?

 No, the proposed amendments to compensation, and the prescribed amounts will be unique to B.C.

# Q4: When will changes to the Manufactured Home Park Tenancy act take effect?

 The changes will come into effect as soon as possible after the legislation has been introduced, debated and passed.

#### Q5: Do these changes impact local government relocation policies?

- While many local governments have manufactured home park redevelopment policies, they have limited authority to enforce these provisions (except Vancouver under the Vancouver Charter).
- The proposed changes will establish a province-wide standard and will work in conjunction with local government policies.
- The Ministry will notify all local governments so they may ensure their local policies are aligned with these changes and avoid any duplication.

#### Q6: Will this discourage landlords from redeveloping?

- In some areas, the additional compensation requirements may impact redevelopment.
- In many areas, redeveloping a park is extremely lucrative with significant increase in value from rezoning.
- We're asking landlords to set aside some of that profit for tenants who
  have the hardship of losing a home, and having to move.

# Background Note Penticton Lakeside Resort Wood Innovation/Engineered Wood

- BC is home to one of the world's most sustainable and globally competitive forest sectors. Forestry directly supports more than 57,000 families in communities throughout B.C. and represents one-third of our total exports.
- For BC's forest sector and BC wood products to continue to succeed in the global economy, we need to maximize the value of our forest resource, hone our existing competitive advantages, and meet emerging opportunities through continued innovation and focus.
- BC is known globally for its innovative wood products and strong support for showcasing engineered wood and wood-based building systems.
- Globally, engineered wood products and wood-based construction systems are continuing to advance, with new and innovative wood buildings being announced, planned and developed in cities around the world – from Vancouver to Tokyo, from Portland to Paris – to Penticton.
- BC is proud of our Wood Culture, and has consistently shown leadership in pioneering acceptance of wood construction and the use of engineered wood.

#### **Penticton Lakeside:**

- The Penticton Lakeside Resort was completed in June 2017, with engineered wood supplied by Structurlam, a local BC supplier.
- The new 70-unit hotel is constructed of mass timber, and as of 2017 is believed to feature the most extensive use of cross-laminated timber (CLT) of any building in the Okanagan Valley.
- The property is located on a floodplain in Penticton, and most new buildings in the area need to be built on pilings, so the light weight nature of wood was a definite advantage. By using CLT, the overall building weight was reduced,

allowing them to use a more traditional concrete foundation instead of pile foundations, saving money and time.

#### • <u>STATISTICS</u> for the Project:

- 1,175 metric tonnes of carbon dioxide stored in wood of the building
- 455 metric tonnes of greenhouse gases were avoided equivalent to taking 345 cars of the road for a year, or operating 172 homes for a year.
- 1,500 cubic metres of wood products were used for construction

#### Benefits of Growing our Engineered Wood Sector

- By growing opportunities for our engineered wood sector, British Columbians can get more value from our forest resource, ensuring BC forest products contribute to shared prosperity for people across British Columbia.
- Shared Prosperity: Advancing engineered wood products for domestic and export markets supports B.C.'s forest economy and drives business investment and diversity. It opens up economic opportunities for rural and indigenous communities.
- Climate action: These products continue to store some of the carbon absorbed naturally by trees, and outperform other common construction materials in terms of embodied energy, greenhouse gas emissions, and air pollution. By using more engineered wood products, B.C. can reduce its carbon footprint, facilitating B.C.'s transition to a low carbon economy.
- Safety and Affordability: Engineered wood products offer exceptional stability
  and strength, as well as safety and performance for a range of conditions
  including fire, seismic and wind. Wood structures are versatile, adaptable and
  easy to renovate, making wood is an affordable, aesthetic and safe building
  material for BC housing and infrastructure.

#### What Government is doing to support the sector:

• This government is committed to build on our forest sector leadership and find new and higher-value uses for our forest resource.

- We are actively working across government on expanding our innovative wood products sector through addressing the regulatory and capital barriers hampering the growth of engineered wood production.
- This work includes looking at our BC Building Code a place where we are already seen as a leader in innovation for future opportunities to further expand the use of wood within the building code.
- The Building Standards and Safety Branch (Ministry of Municipal Affairs and Housing), responsible for the BC Building Code, is currently reviewing opportunities to enable engineered wood use for six-storey wood frame commercial buildings, which will open up new market segments for engineered wood.
- Providing tangible, credible examples of market acceptance for engineered wood products here in B.C. provides significant legacy value for the province.
- Public sector leadership is big part of this advancing the use of engineered wood. We are actively looking at opportunities to showcase B.C.'s engineered wood products in our public capital projects, including in our government buildings, our schools, our public housing and in public projects in communities across the province
- Our Sector Labour Market Partnerships program (Ministry of Advanced Education, Skills and Training) is supporting the B.C. Wood Specialties Group to develop a detailed labour market information report which will explore recruitment challenges and potential new training opportunities for the advanced wood manufacturing sector.
- Since March 2017, The Sector Labour Market Partnership program has contributed \$96,400 towards projects in the advanced wood manufacturing sector.

### Working together to establish a national park reserve in South Okanagan

OSOYOOS – With rolling hills and sweeping valleys, the South Okanagan offers a stunning landscape ranging from near-desert to rich forests of ponderosa pine and Douglas fir that support an incredible range of rare animals and plants.

The South Okanagan is one of Canada's most unique habitats and has sustained Syilx/Okanagan communities for thousands of years.

Today, three Southern Communities of the Syilx/Okanagan Nation, alongside the governments of Canada and British Columbia, announced a renewed commitment to work together to establish a new national park reserve in the South Okanagan. The Minister of Environment and Climate Change and Minister responsible for Parks Canada, Catherine McKenna, B.C. Minister of Environment and Climate Change Strategy George Heyman, and Chief Clarence Louie of the Osoyoos Indian Band, representing the three Southern Communities of the Syilx/Okanagan Nation, made the announcement at the Nk'Mip Desert Cultural Centre in Osoyoos.

Three Southern Communities of the Syilx/Okanagan Nation, Parks Canada, and British Columbia's Ministry of Environment and Climate Change Strategy are resuming discussions to protect lands as a national park reserve in the South Okanagan. Planning discussions through this joint partnership will commence immediately.

"A new national park reserve in the South Okanagan would protect one of Canada's iconic natural and cultural landscapes and provide opportunities to share this inspiring place with Canadians and visitors from around the world," said McKenna. "By renewing our commitment to work together to establish a national park reserve in the South Okanagan, we can conserve this incredible landscape for future generations. In so doing, we also honour and recognize the important role of Indigenous Peoples of the region and their traditional use of these lands."

As climate change continues, it is important to take protective measures to safeguard the significant and diverse regions of Canada, such as the B.C. interior. The South Okanagan region represents an area of significant ecological, geographical, and cultural importance and offers a wide range of recreation and tourism opportunities. The Okanagan is one of the most ecologically diverse regions of Canada, and protecting this area would support recovery of over 60 federally listed species-at-risk.

"We know the South Okanagan is a unique place that many British Columbians want to see protected as a national park reserve," said Heyman. "We will work hard to make this happen, to preserve and protect the biodiversity of this special region, and for the positive contributions a national park reserve will make to the local economies."

The establishment of a national park reserve in the South Okanagan represents a valuable opportunity to advance reconciliation and for nation-to-nation engagement with the three Southern Communities of the Syilx/Okanagan Nation leading to a new partnership model for management of the proposed national park reserve. These discussions will also take into consideration the continuation of ranching and recreational activities in the region.

The Syilx/Okanagan people have a responsibility to take care of their lands, waters, plants and animals and have always done so through protocols of respect and reciprocity.

The Government of Canada is committed to expanding its network of protected areas and protecting Canada's biodiversity by conserving at least 17% of our country's land and freshwater by 2020 in collaboration with the provinces and territories, Indigenous Peoples, and other key partners.

### 1. What is the Province announcing about lands in the South Okanagan?

- The federal and provincial governments, alongside the Osoyoos Indian Band, Penticton Indian Band and Lower Similkameen Indian Band of the Okanagan Nation are working together to develop a new national park reserve in the South Okanagan.
- Parks Canada, the Ministry of Environment and Climate Change Strategy and the three member bands of the Okanagan Nation are resuming discussions to establish a national park reserve under federal jurisdiction in the region.

### 2. Why is a South Okanagan National Park Reserve being established?

 A national park reserve is proposed to be established because the South Okanagan region embodies significant ecological, geographic, cultural and recreational values, as well as a wide range of species at risk along with tourism opportunities.

### 3. In the past, the Province has repeatedly said it does not support a national park reserve – why is this option being pursued now? What about critics?

- We know the South Okanagan is a unique place that many British Columbians want to see protected as a national park reserve.
- As a new government, we are responding to the wishes of British Columbians who have expressed their desire to have a new national park reserve, one that incorporates a larger land area.
- We recognize that there are some people who have concerns regarding the impact a national park reserve could have on activities such as motorized access, hunting and ranching, and the Province looks forward to working with Parks Canada and the Osoyoos Indian Band, Penticton Indian Band and Lower Similkameen Indian Band of the Okanagan Nation to find solutions to these issues.

### 4. Why is it called a national park reserve and not a national park?

 A national park reserve is an area managed as a national park but where lands are subject to a claim in respect to Aboriginal rights, accepted for negotiation by the Government of Canada. Therefore, the use of the term 'reserve' is used to protect lands and waters without prejudice to unresolved Aboriginal land claims.

### 5. Has the Province engaged with Parks Canada on establishing a national park reserve already?

- Yes, discussions between the Province, Parks Canada and the respective bands of the Okanagan Nation Alliance to establish a national park reserve in the region, under federal jurisdiction, are resuming.
- Planning discussions through this joint partnership will commence immediately.

### 6. Will a national park reserve allow recreational uses to continue, including hunting and fishing?

 The opportunities for continued recreational uses such as hunting will be a key element of discussions between the Province, Canada and the member bands of the Okanagan Nation.

### 7. What geographic area would a national park reserve include?

- The lands to be included in a new national park reserve will be determined during the national park establishment agreement phase.
- Previous proposals identified approximately 28,000 hectares in the region (which
  included lands that are privately held- consideration of private lands will only be
  under a willing seller-willing buyer scenario)

### 8. Why is this South Okanagan area so significant?

- The South Okanagan region embodies significant ecological, geographic, cultural and recreational values, as well as a wide range of tourism opportunities.
- The Okanagan is one of the most ecologically-diverse regions of Canada, and protecting this area would support recovery of more than 60 federally-listed species at risk.

### 9. What species of wildlife and vegetation would this proposed national park reserve protect, and what species at risk are currently present?

- There are more than 60 federally-listed species at risk found in this area.
- The area contains 16% of B.C.'s red-listed species (any species or ecosystem that is at risk of being lost) and 22% of B.C.'s blue-listed species (any species or ecosystem that is of special concern).
- This includes wildlife and fauna such as: Bighorn sheep, Mountain Goat, Cougar, Black Bear, whereas smaller fauna include Western Rattlesnake, Spadefoot, and Tiger Salamander.
- With respect to endangered flora, the area contains several red-listed plants (such as the Lyall's Mariposa Lily, Grand Coulee Owl Clover, Spaldings Milk Vetch) and ecological communities (such as the Vasey's big sagebrush and big sage/bluebunch wheatgrass-balsamroot plant communities).
- Six vertebrate species that once lived in the South Okanagan the Pigmy Short-horned Lizard, White-tailed Jackrabbit, Burrowing Owl, Northern Leopard Frog, Sharp-tailed Grouse, and Sage Grouse have disappeared from the region largely due to habitat loss, development and persecution. A national park reserve would likely reduce further species and habitat loss.

### 10. What is being done to further protect species at risk in this region?

- The Ministry of Environment and Climate Change Strategy has committed to developing endangered species legislation to better protect British Columbia's species at risk.
- We will work with the federal government, South Okanagan communities and local First Nations to create a plan to protect the large number of endangered species in that area.

### 11. Who will be consulted about the establishment of a national park reserve?

- The Province will work with Parks Canada, First Nations, and stakeholders to establish a national park reserve.
- Planning is underway with the federal government and three Okanagan Nation communities (Lower Similkameen Indian Band, Penticton Indian Band and Osoyoos Indian Band) in a government-to-government process.
- Renewed discussions will be initiated with key stakeholder groups such as ranchers and the tourism industry.

### 12. What is the benefit to B.C. for a national park reserve rather than a provincial park?

- A national park reserve would be managed by Parks Canada.
- The necessary funding would be provided by the federal government to develop, operate and maintain the park.
- A larger area of protection (as national park reserve) enhances wildlife connectivity and survivorship for a range of species.

### 13. How much will this national park reserve cost B.C. taxpayers?

 Costs to the Province will be limited to the staffing and support costs associated with planning for new national park reserve.

### 14. There are some privately-owned lands within the proposed national park reserve. How are they affected?

- Private lands will only be considered for future park designations under a willing seller – willing buyer basis; no lands would be expropriated.
- Component areas referenced in the proposal also include large private conservation lands, which are owned and maintained by non-governmental organizations. These private conservation lands will not be considered as part of this proposal.
- Government will work with these organizations to seek complementary land management goals with respect to those areas.

### 15. When is the last time a national park reserve like this was created in British Columbia? How many federal parks will now be in B.C.?

- Canada and British Columbia negotiated a federal-provincial park agreement in 2001 to establish the Gulf Islands National Park Reserve.
- The establishment of the proposed South Okanagan National Park Reserve would signify the 21st location of a federal park, national historic site or marine protected area in B.C. (including seven other national parks or national park reserves).

### Province helping owners of manufactured homes protect their investment

PENTICTON – The Province is increasing security for owners of manufactured homes by increasing the compensation they will receive if they are forced to move because of redevelopment.

"People deserve to feel safe and secure in their housing. For too long, manufactured home owners have faced uncertainty due to rising land values and redevelopment, and they have not had adequate protections when evicted. No one should have to face financial ruin or potential homelessness when facing eviction from a manufactured home park," Premier Horgan said. "We are taking action to give people increased peace of mind by strengthening protections for owners of manufactured homes." NOT APPROVED

The Government of British Columbia is proposing changes to the Manufactured Home Park Tenancy Act that will create fairness for tenants when landlords choose to close or convert a park.

The proposed changes will provide stronger protections for people affected by manufactured home park closures by:

- ensuring the effective date of a 12-month notice to end tenancy is the same for all tenancy agreements under the Act;
- increasing the amount of compensation landlords pay tenants who have been given a notice to end tenancy' to convert a park;
- increasing the amount of compensation a landlord owes a former tenant if the landlord gave notice but did not do the conversion;
- providing additional compensation if a manufactured home cannot be relocated; and
- clarifying that a tenant who is unable to relocate their manufactured home is not responsible for disposal costs of the home.

Legislation will be introduced to enact the changes later this month.

Current compensation is too low to cover a tenant's moving costs, or loss of equity and loss of affordability that happens when tenants can't find a place to move their home. The proposed amendments will assist displaced tenants to move their home to another site, if possible and compensate them for the loss of their home if they are unable to move it.

These changes to better protect manufactured home owners are part of Government's 30-Point Plan for a fairer housing market.
