Assistant Deputy Ministers' Housing Committee DRAFT Terms of Reference

Mandate

The Assistant Deputy Ministers' Housing Committee (ADMHC):

- Develops and oversees a monitoring and evaluation framework for the housing investments announced in Homes for BC: A 30-point plan for Housing Affordability in British Columbia.
- Track progress on the plan's implementation and report out to the Cabinet Housing Working Group.
- Incorporates other housing commitments into the work of the committee and into the performance framework as needed.
- Provides information requested by Cabinet Housing Working Group.

Governance

- The Chair / Secretariat for ADMHC reports to the Deputy Minister, Municipal Affairs and Housing and provides regular updates to the Chair of the Housing Working Group.
- ADMHC may establish sub-committees and working groups to accomplish narrowly defined objectives - these sub-committees will report back to ADMHC.

Member Responsibilities

Members of ADMHC commit to:

- Make it a priority to attend ADMHC meetings in-person (preferable) or via teleconference.
- Avoid sending delegates. If this is necessary, attend with delegate to ensure that they will be prepared to make informed decisions.
- Identify only immediate priorities when secretariat canvases for agenda items.
- Proactively identify ministry proposals or initiatives with possible cross-sector affordable housing implications and present the information to the committee in a timely manner.
- Brief their respective ministry Executive on decisions and direction resulting from ADMHC meetings.

Secretariat Support

The Housing Secretariat (OHCS) will provide the following support to ADMHC:

- Planning and coordinating committee and sub-committee meetings;
- Tracking committee decisions, actions and follow-up items;
- Providing research or information-gathering services where possible; and,
- Other ad hoc secretariat support.

Meeting Frequency

- Meetings take place monthly, preferably two weeks in advance of HWG meetings.
- Quorum does not apply.
