To John Horgan, MLA for Langford/Juan de Fuca

I am prompted to write to you to express my disgust at what is happening currently with the CRD and <sup>s.22</sup>  
s.22

s.22

s.22 I **will** comment on what I see as unacceptable, politically motivated decisions that the CRD has taken.

1) They claim that they can't bring water to <sup>s.22</sup> because that would cause urban sprawl. They claim that they are acting for the best interests of the area in combatting urban sprawl. They are using denial of access to water as their tool. If they are so anxious to deter urban sprawl, why didn't they deny water to the communities of Westhills, Royal Bay, Bear Mountain, and Happy Valley (north)? All of these areas were green and undeveloped. Now, those communities are "urban sprawl." But the CRD gave them water, I guess because their urban sprawl is somehow acceptable. CRD approved their water without hesitation. But they deny water to <sup>s.22</sup> when there are already curbs to growth within our land use plans that would make urban sprawl near impossible.

2) On 28 July 2010, through Resolution 64/292, the United Nations General Assembly explicitly recognized the **human right to water** and sanitation and acknowledged that clean drinking water and sanitation are essential to the realisation of all human rights. In April 2011, the Human Rights Council of the United Nations adopted through Resolution 16/2 **access to safe drinking water and sanitation as a human right**: a right to life and to human dignity. Canada joined the international consensus and (after some reluctance) recognized the right to water at the United Nations Conference on Sustainable Development in 2012. The last time I looked, Canada was still a member of the United Nations. That means that the CRD is as well. There is an overriding principle at work here: all humans, even <sup>s.22</sup> residents, have the right to access to water.

3) The Directors of the CRD have managed to stall and deny us due process to have our needs addressed at the board level. They have intentionally created a committee that they know will deny us our rights. Our Director had to get into a public fight just to get a seat at the table where this discussion is going to take place. Mind you, he's not allowed to talk because that would require unanimous agreement from all CRD Directors and that's not going to happen because there's at least one person on the Board who is bound and determined that his view will be approved. They are denying a duly elected representative <sup>s.22</sup> the right to address a meeting where the rights of citizens that he represent can be heard. This is not democracy. This is horse-pucky.

So, here's the picture that I see happening in the CRD chambers. Blatant hypocrisy. Clear violation of United Nations resolutions. Slimy political machinations intended to disenfranchise the citizens <sup>s.22</sup> And all of this is happening in the riding that our premier represents. He has the power to put an immediate halt to the CRD's disgusting actions. I urge him to use that power to bring some integrity into that Board. It's very simple. Access to water is a fundamental right of all citizens of the world, even <sup>s.22</sup> . You'll have to stand up for us, John; some members of that CRD Board have gone rogue.
