Gowlland Tod Provincial Park, and the conservation development model established in the Highlands. For a long time I have believed that it is unfair that landowners who have conservation covenants on their property receive no acknowledgement in terms of reduced property taxes for their conservation efforts.

Many people in our Province believe it is a public benefit that individual landowners protect areas of natural value on their lands. This is especially important in a time of high land values, pressure for development, and the diminished ability of park agencies to create new parkland.

There is a strong land trust movement in B.C. These organizations work with landowners to assist with the placement of conservation covenants over their properties and assist with applications to Federal programs which provide income tax relief for land donations to conservation agencies.

These are important ways in which people wishing to leave a conservation legacy are assisted.

For those people who wish to conserve lands they own, there is the important issue of ongoing costs for property taxes. **The property tax assessment structure is a Provincial matter.** While special assessment categories have been established for farmland and managed forest land, resulting in relatively low property taxes, no similar assessment category exists for private conservation lands.

Instead, areas under conservation covenants on private lands are typically assessed as residential. At today's high land values, the taxes on natural areas, at the residential assessment rates, can be significant. **What we have in B.C. is a property tax system which discourages conservation.**

Municipalities seem unable to provide any property tax incentives for conservation, due to the Provincial assessment structure.

Ontario has a Conservation Land Tax Incentive Program, which allows conservation properties to receive a property tax exemption. (see <https://www.ontario.ca/page/conservation-land-tax-incentive-program>). This may be a model for B.C. to examine. On B.C. managed forest land, residential areas and managed forest areas are assessed separately. On lands with conservation

covenants, conservation lands could be similarly separated from residential portions. It may also be possible to incorporate elements of the private managed forest provisions, whereby, a tax recapture fee would be payable if a property were removed from the conservation assessment status.

I believe that the reform of this component of our tax assessment system is long overdue. I hope that your government, together with support from members of the Green Party, can enact the necessary legislative changes during your term in office. Many people in the Province would support you in doing this.

Subject: I support sustainable forestry jobs in BC

I am writing in support of strong action to protect BC's endangered old-growth forests and to support First Nations and second-growth forestry jobs. The new government made a commitment to sustainably manage old-growth forests. I applaud this commitment. Now it is time for action.

I am urging you to work with First Nations and stakeholders to implement a science-based Old-Growth Protection Act. This act should look to the science used in the Great Bear Rainforest as a model to safeguard endangered old-growth. It must be combined with strong support for First Nations governance and economic activities as well as improved management of second-growth forests.

The Old-Growth Protection Act must also include support for forestry workers to transition to sustainable second-growth forestry. Raw log exports have gutted rural communities as mills close. It is time for this practice to stop. Managing BC's forests sustainably means keeping these mill jobs in BC.

Lastly, I'm calling for immediate logging moratoria in a number of critical remaining intact old-growth forests on Vancouver Island such as the Central Walbran to prevent further loss of some of the most magnificent remaining old-growth stands. BC's coastal temperate rainforests are among the rarest ecosystems on the planet, but today nearly ninety percent of Vancouver Island's biggest old-growth trees have been logged. The rate of old-growth logging has now climbed to 9,000 hectares a year.

We need to protect the remaining ancient forest for wildlife, water, climate and a diverse economy including tourism and recreation.

The new government has promised to make BC's forests a priority. I am calling on you now to act in support of BC's globally rare, endangered old-growth forests and the people who depend on them.

I am reminded again of the tremendous burden of responsibility to future generations we all bear in these unsettled times, especially our leaders. Which brings me to my reason for contacting you.... Too many people including our federal leadership are acting like we have lots of time to deal with the problem of climate change. I believe you know Climate Change is real. What is happening to our planet is certainly not normal and will only get worse. The Auditor General has given Canada a failing grade on fighting climate change and several other countries are falling behind their Paris commitments. The Feds just extended the time for provinces to complete climate plans until end of 2018. They also postponed methane regulations on oil & gas operations until 2020 even though the industry wants them. This is not leadership! It is clearly up to the provinces to lead the fight. The alternative is just too dire to contemplate. Hopefully you will find this morning's announcement by the mayor of NYC interesting and inspirational. NYC is divesting from fossil fuels and calling the fossil fuel companies to account. https://www.facebook.com/NYCMayor/videos/10155832687561166/?utm_medium=email&utm_source=actionkit

People who have survived the devastating effects of climate change like super storm Sandy 5 years ago, certainly know that it is real. They know it is imperative for the future of their children and indeed for the planet, that we do all we can to fight it. I believe B.C. should take up the challenge and follow their lead.

Which brings me to some suggestions...

I believe you when you said approving the completion of site C was a very tough decision. It would be tough to abandon the \$4B sunk cost. However, the BCUC report said the demand will not be there for Site C power. Completion of Site C will result in a massive increase in power available to B.C. at a cost of approx \$.10/kwh, assuming it is on budget. The risk is that there will not be enough demand for the power and BC will end up almost giving away the expensive Site C power, as has happened with other big over budget hydro projects in Canada.....

THEREFORE...lets kill 2 birds with one stone! Lets subsidize EVs to reduce what we don't want (fossil fuel consumption) and kick start what we do want - EVs. Fuel cost alone is not enough. In Victoria we have had increases of as much at \$.10/L overnight and no one objects. Big vehicles still dominate our roads.

So, how to fund the subsidies? We should have extra carbon taxes on the *purchase* of big gas guzzlers and use those \$ to specifically and meaningfully subsidize the relatively smaller numbers of EV sales - creating a Green Taxation Shift. This would be revenue neutral to the government and no one remotely serious about fighting climate should be opposed. It will help force the shift we need.

Norway achieved massive adoption of EVs by means of a similar Green Tax Shift. Norway has about 30% of sales electric while Canada sits at the bottom of 20 countries at about 2%. <https://www.theguardian.com/environment/2017/dec/25/norway-leads-way-electric-cars-green-taxation-shift> They intend to abolish the sale of fossil fueled vehicles by 2025.

They are doing their part!

Without similar action, EV adoption will remain small in Canada. They are just too expensive and the manufacturers have no meaningful incentives on them. They are currently trying to sell 2017 EV models for very little less than 2018 while massively reducing big trucks prices! They try to trick consumers into believing they are reducing the price on 2017s by including the \$5000 BC incentive in advertised prices while excluding it on 2018s!

As a side note, I noticed Alberta does not have enough workers. So much for the pressing need for pipelines!

I am writing in support of strong action to protect BC's endangered old-growth forests and to support First Nations and second-growth forestry jobs. The new government made a commitment to sustainably manage old-growth forests. I applaud this commitment. Now it is time for action.

I am urging you to work with First Nations and stakeholders to implement a science-based Old-Growth Protection Act. This act should look to the science used in the Great Bear Rainforest as a model to safeguard endangered old-growth. It must be combined with strong support for First Nations governance and economic activities as well as improved management of second-growth forests.

The Old-Growth Protection Act must also include support for forestry workers to transition to sustainable second-growth forestry. Raw log exports have gutted rural communities as mills close. It is time for this practice to stop. Managing BC's forests sustainably means keeping these mill jobs in BC.

Lastly, I'm calling for immediate logging moratoria in a number of critical remaining intact old-growth forests on Vancouver Island such as the Central Walbran to prevent further loss of some of the most magnificent remaining old-growth stands. BC's coastal temperate rainforests are among the rarest ecosystems on the planet, but today nearly ninety percent of Vancouver Island's biggest old-growth trees have been logged. The rate of old-growth logging has now climbed to 9,000 hectares a year.

We need to protect the remaining ancient forest for wildlife, water, climate and a diverse economy including tourism and recreation.

The new government has promised to make BC's forests a priority. I am calling on you now to act in support of BC's globally rare, endangered old-growth forests and the people who depend on them.



Hi all,
Since Jarrett will be on site to manage the event, Marielle will handle media, and Nick and Joe are arranging AV, I thought I would loop you all in together. I've also included Bruce Fogg from The Premier's constituency office as he will be on site as well. Photos are below.

When the Leigh Road interchange was first proposed, the need for a pedestrian overpass was recognized and there was a request to the province to install one.

10. Spencer Road Pedestrian Overpass (File No. 5460-25 Spencer) MOVED BY: COUNCILLOR SIFERT SECONDED: COUNCILLOR SZPAK That Council direct staff to complete the proposed pedestrian overpass prior to closure of Spencer Road closing at Trans Canada Highway. CARRIED.

When the interchange opened in 2013, the overpass was still being promised by the Mayor:

"The opening of the new interchange will bring little joy to residents in the Spencer Road area used to walking across the highway to Spencer Middle School or downtown Langford. The Spencer Road intersection will be closed to both vehicles and pedestrians.

The original idea included building a \$2-million pedestrian overpass at Spencer, but Young said that's a provincial responsibility and won't be built until the province comes up with the cash.

Until the overpass is built, pedestrians and cyclists will have to cross the highway at either Millstream or Leigh.

"The province will have to pay 100 per cent for a pedestrian overpass. We've let them know that. It should have been built now. The province should have put the money in to build that pedestrian overpass. It's their responsibility. It's their highway," Young said."

Fast forward 4 years, the GVCC was contacted by someone in Langford asking about the status of the pedestrian overpass. I contacted Michelle Mahovlich at Langford. Here's some of the response I was sent:

"The Leigh Road Interchange (formally called the Spencer Road Interchange) opened in June 2013. The City opened the last phase of the Leigh Road Interchange which was the southbound off ramp in December 2015.

Upon completion of the Leigh Road Interchange in 2013, the Ministry provided information indicating that the proximity of the two interchanges was such that they were the closest two

on the island to one another and did not warrant an additional pedestrian/cycling overpass in between them at a cost of over \$2Million.

The overpass had been part of the City's Road Development Cost Charge bylaw, however when the City did the 5 year review of that bylaw in 2017 the pedestrian overpass was formally removed for the reasons stated above. That Bylaw 1700 was considered in open Council and adopted by Council and approved by the Inspector of Municipalities."

So, the overpass was discussed for years prior to the opening of the interchange and the closing of the Spencer Road intersection. When the interchange is finally opened, the province has a change of heart and says the overpass is not needed. Why was this reason not stated beforehand? This is what is confusing me.

There were a fair number of letters to the editor detailing the need for an overpass, and a news story on spencer middle school students that now have to detour to millstream or leigh to cross the highway.

Curious if Hans at John's office has any recollection of this, I imagine folks contacted the constituency office to voice their concerns given the construction of the overpass was a provincial responsibility.

A reminder that your IDIR password will soon expire. We are letting you know to ensure that you do not get locked out on the iPad/iPhone/Android/Blackberry and PC.
If logged on to a standard workstation on the BC Government network (or VPN), please change password through the usual process:

- Tap **Ctrl, Alt** and the **Delete key (Del)**. Select: **Change a Password**. Put in current password. Then new password twice and tap the arrow.
- If using a device other than a standard workstation (i.e. home PC), go to <https://www.pwchange.gov.bc.ca/> to change your IDIR password.

Now updated, you will need to change it on your mobile devices: (iPhone/iPad/Android/Blackberry). There

are normally a few locations the IDIR password needs to be changed:

- **AIRWATCH ActiveSync (iPhone/iPad/Android/Blackberry):** this is for email/calendar/contacts/tasks. **See below.**
- **WiFi (iPhone/iPad/Android/Blackberry):** if connected to Government WiFi (**BCNGN**). **See below.**
- **Microsoft Lync (Skype for Business - iPhone/Android):** if used



Updating IDIR Password on iPad/iPhone




1. On the iPad/iPhone Screen, Tap **Settings**
2. Tap on Wi-Fi on the Top Left. If you are inside a Government building, look to see if BCNGN is ticked. Tap on it and it should prompt you for a Username and Password. Enter with new IDIR password.
3. You should now have the active fan for WiFi in the top left corner of the iPad.  Now go to **Step 5.**
4. If the Wireless does **not** prompt you for a Username and/or Password then you will need to Forget Network and reconnect.



Tap on the Blue i in the circle. Choose “Forget Network” at the top. Close the window and then tap on the BCNGN to reconnect entering: **IDIR\username** and Password. If BCNGN is not available, then go to **step 5.**

5. In **Settings** tap **Accounts & Passwords** then tap on your government account under **Accounts** -> (i.e. **Exchange ActiveSync**) **THEN** tap on your email address.

Update your password and tap on **Done**.



6. Go back to your email view and do a sync.


Updating IDIR Password on BlackBerry 10

4. Type your new password in the '**Update Password**' field.



iPad/iPhone TIPS

If you are have an Exchange Password pop-up that you can't get out of see below to close all the apps. Then Hold down power button at top of iPad for 5 seconds until the prompt to Power Off appears. Power off wait for a few seconds and press and hold on-off button again to restart.

On your iPad tap the Home button 2 times quickly to show all the running applications. Then swipe up from bottom of app screen to close each app.
