Reference Case

Background:

- BC has presented a reference question to the BC Court of Appeal asking whether the province can implement a specific amendment to the Environmental Management Act.
- Andrew Wilkinson criticized the fact the legislation excludes tankers in spite of concerns expressed by government.
- Premier Notley said that AB will intervene in the reference and that they are convinced the court will not approve BC's request. She said that if such laws were allowed the national economy would grind to a halt.

Message:

- We submitted a reference to the BC Court of Appeal to affirm our right to protect BC's coast and inland waters from the threat of a diluted bitumen spill.
- A single spill of diluted bitumen would threaten tens of thousands of jobs and billions of dollars of economic activity.
- We've asked the courts to confirm BC's powers, within our jurisdiction, to defend BC's interests so that there is clarity for today and for generations to come.
- Our government will continue to stand up for BC's environment, economy and coast.

Gas Prices

Background:

- Gasoline prices in the lower mainland have hit record highs approaching 1.60/litre and the owner of www.GasBuddy.com says they could rise over \$2/litre if Alberta follows through on its threat to cut off gas.
- Saskatchewan has introduced legislation mirroring Alberta's and says they would use it to cut oil shipments to BC if Alberta acted first.

Message:

- I understand people's frustration about gas prices. It is one of many costs facing people and that is why we are working to make life more affordable.
- We are eliminating MSP fees, got rid of bridge tolls and we are investing in affordable housing and childcare.
- Recent gas prices have been driven by maintenance at the Burnaby refinery and a refinery in Washington state.
- We are working with our neighbours to the South to strengthen supply options and will continue to work every day to make life more affordable.

Wouldn't building the Kinder Morgan pipeline bring down prices?

- Alberta has been clear that building the pipeline is about exporting diluted bitumen.
- Nearly all of the additional capacity is already committed to shippers of diluted bitumen.

Housing Taxes

Background:

- The Opposition and the real estate sector have been organizing opposition to the increase to the school tax on homes over \$3 million.
- Andrew Wilkinson has also called for the speculation tax to be cancelled.

Message:

- s.13
- We are taking bold action with a 30-point housing plan to make housing more affordable.
- We are discouraging speculators with a new speculation tax that will not apply to more than 99% of British Columbians.
- And we are moderately increasing taxes on the top 2% of homes - over \$3 million - to curb out of control prices.
- We are investing in building tens of thousands of new units of affordable housing so that people can find a place to live.

Municipal and Regional District Tax (MRDT)

Background:

- Budget 2018 expands the allowable use of municipal and regional district tax (MRDT) – known as the hotel room tax – to include affordable housing initiatives.
- Effective on a date to be set by regulation, MRDT revenue collected by municipalities, regional districts and eligible entities such as tourism non-profits, can be used to fund affordable housing initiatives.
- Prior to this policy change, MRDT revenues could only be spent on tourism marketing, programs and projects.
- The week of April 23rd, Tourism Vancouver wrote to its members asking them to write to Minister James to express deep concern about the change.

Message:

- One of the concerns we've heard from communities is a shortage of affordable housing options – which affects tourism industry staff.
- Our proposed changes to MRDT municipalities can choose to continue doing exactly what they're doing today, but they also give municipalities the flexibility they need to support housing and a strong tourism sector.
- Creating flexibility in how revenues from MRDT may be used to allow communities to work with tourism operators, hotels and other business to address their concerns, including a lack of affordable housing.

Employer Health Tax

Background:

- The CFIB released a report April 27 claiming that 44% of businesses will pay the EHT in contrast to the government's statement that 85% of businesses will not pay. Their figures are based on a non-scientific survey of their members.
- The CFIB argues that the government's statement that 85% of businesses will not pay EHT is misleading because it includes businesses with 5 or fewer employees.
- The CFIB recommends changes to increase exemptions and "create a more even split between businesses and individuals".

Message:

- We are eliminating MSP fees saving families up to \$1800 each year. This is one of the biggest effective tax cuts in BC's history.
- Under MSP, someone making \$50,000 pays the same amount as someone making \$500,000. That's not fair.

- We are ensuring health care funding by introducing the lowest payroll tax rate anywhere in Canada and exempting small employers.
- We all benefit from a well funded public health care system - it is one of our key advantages in attracting and retaining talented workers.

Overdose Crisis

Background:

- Surrey is one of the B.C. communities hardest hit by the opioid crisis.
- On April 13, 2018, an overdose spike in Surrey prompted Fraser Health officials to issue an alert about dangerous drugs.
- Surrey RCMP are also investigating a possible fentanyl packaging site in Surrey.
- Across B.C., suspected overdose deaths in 2017 were 1,422, up from 993 in 2016.

Message:

- Our government continues to escalate our response to the overdose crisis to stem the tide of this emergency:
 - Last week, our government introduced legislation to toughen regulations on pill press machines to help keep opioids off our streets.
 - We launched the Overdose Emergency Response Centre which includes Community Action Teams in those communities most affected by the overdose crisis - including Surrey.
 - We have increased the availability of drug checking and naloxone kits which are now available through pharmacies.
 - As we reduce stigma for drug users - through campaigns like our partnership with the Vancouver Canucks - and connect them with services we expect to see fewer overdose deaths.
 - We know that there is not one single solution that will eliminate overdose deaths in British Columbia but we are working to implement a seamless and coordinated mental health and addictions system.

Salmon Aquaculture - Closed Containment

Background:

- On Tuesday April 24, 2018, the federal Commissioner of the Environment and Sustainable Development (in the office of the Auditor-General) released an audit of salmon aquaculture.
- The report found that the Department of Fisheries and Oceans (DFO):
 - “did not adequately manage the risks associated with salmon aquaculture consistent with its mandate to protect wild fish”;
 - and “did not adequately enforce compliance with aquaculture regulations to protect wild fish.”
- DFO is responsible for aquaculture licensing in B.C.
- This has sparked renewed calls in the media to move to closed containment from campaigners and Chief Bob Chamberlain.

Message:

- Our government is committed to protecting our wild salmon and the nearly 10,000 good-paying jobs that depend on it.
- This week, the federal Environment Commissioner released an audit of the Department of Fisheries and Oceans’s that found that DFO didn’t adequately manage the risks associated with salmon aquaculture to protect wild fish.
- The federal Department of Fisheries and Oceans is of course responsible for aquaculture licensing in B.C.
- This report underscores that this issue cannot be addressed without full engagement and leadership by the federal government.

UNDRIP and Free, Prior and Informed Consent

Background:

- An April 26 Vaughn Palmer column claimed the Premier sees First Nations unanimity as essential on Trans Mountain expansion but not on allowing Site C to proceed.
- Some critics have tried to frame the “free prior and informed consent” clause as a veto for First Nations on economic development that impacts their territory.

Message:

- Our government is focused on a new relationship with First Nations and all Indigenous people. One built on partnership and respect.
- This means that instead of fighting over projects in court for years that industry, First Nations and government work together from the start.
- This means certainty and predictability for industry over the long term and good, family-supporting jobs for indigenous and non-indigenous people alike.

Proposed Changes to Child, Family and Community Service Act

Background:

- Minister Conroy introduced proposed changes to the Child, Family and Community Service Act on Tuesday, April 24.
- Changes include but are not limited to:
 - Promoting routine involvement of Indigenous communities, through a written agreement, in child-welfare matters before a potential removal.
 - Enabling greater information-sharing between MCFD and Indigenous communities.
- The proposed changes will allow MCFD to share more information with Indigenous communities right from the start to help prevent children from coming into care in the first place.
- The First Nations Leadership Council has expressed disappointment over the legislation, stating that it doesn't go far enough in incorporating UNDRIP and TRC language as they requested.

Message:

- The system has failed Indigenous children and their families and our government has been clear that things need to change in the child-welfare system.
- The proposed changes support earlier engagement with Indigenous communities to keep their children out of care, safe in their community and connected to their culture.
- We agree with the First Nations Leadership Council that there is a lot more work to do.
- Cross-Ministry work to incorporate UNDRIP is underway, and in the meantime, this legislation will help us make a difference in the lives of children in the child welfare system today.

Cannabis

Background:

- On April 26, government introduced legislation for the legalization of non-medical cannabis including the details of the regulatory framework announced in February.
- Questions may be asked about selling in both private and public stores. The opposition leader's platform proposed only selling in private stores.
- There may also be questions about where people can smoke in public, as at least 4 jurisdictions have decided to not allow consumption in public places.

Message:

- Our priority is the health and safety of British Columbians, keeping marijuana out of the hands of children, and getting organized crime out of this business.
- But our goal is to ensure we reflect the views and values of all British Columbians, while keeping public health and safety top of mind - the legislation we introduced on April 26 does just that.
- These decisions reflect the feedback we received during our fall engagement with local governments, Indigenous communities, and more than 48,000 British Columbians.
- The date set by the federal government for cannabis legalization will just be the beginning.
- Our government will continue to monitor our regulations and make any adjustments necessary to meet our provincial goals.

When will non-medical cannabis be legal?

- The decision about when non-medical cannabis will be legal is still up to the federal government.

Where will non-medical cannabis be sold in B.C.?

- Adults age 19 and up will be able to purchase cannabis through privately run retail stores, and through government-operated retail stores and online sales.
- The operating rules governing public and private retail stores will be similar to those currently in place for liquor.
- Licensed retailers will not be able to sell cannabis in the same stores as liquor or tobacco.

When will stores open?

- The stores won't be open for business overnight.
- The BC Liquor Distribution Branch (LDB) is aiming to open the first government-operated retail store by late summer.

What if municipalities don't want cannabis sold in their communities?

- We won't cap the number of licenses that can be given out, but municipalities will have the authority to make local decisions based on the needs of their communities.

Where will people be able to smoke cannabis?

- Adults will be allowed to possess up to 30 grams of dried cannabis in public spaces.
- Like some other provinces, adults will be allowed to use non-medical cannabis in public spaces where tobacco smoking and vaping are currently permitted.
- To protect our children and youth and minimize exposure, smoking or vaping of cannabis will be banned in areas frequented by children, including community beaches, parks and playgrounds.
- Local governments will also be able to set additional restrictions on places of use, as they do now for tobacco.
- The use of cannabis in any form will also be banned in vehicles, for all occupants.

Surrey Hospital

Background:

- On December 18, 2018, Minister Dix announced that concept planning is underway for a new Surrey hospital to care for a growing population.
- A concept plan lays out the general proposal for a specific project and identifies potential locations.
- The concept plan stage will take approximately one year to complete. It is the first step for any new hospital in B.C. - the next step will be the business plan.

Message:

- Surrey Memorial Hospital delivers first class health care, but we realize that with a rapidly growing community that access to this care is becoming difficult for a great number of people.
- With this in mind, we are planning for the future, for a new hospital to meet the needs of people who live, work and play in Surrey.
- That is why we are working with Fraser Health on a concept plan for a new hospital in Surrey.
- We made a commitment to British Columbians to address this need and we are taking the first planning step in making sure people living in this region have better access to quality care.

Where will the new hospital be located?

- The location of the new hospital is dependent on the outcome of the concept plan.

Surrey Gang Violence

Background:

- Crime continues to be a significant issue in Surrey and gains extensive media attention.
- On Thursday April 26, 2018, a young man was the victim of a targeted homicide in Surrey. Investigators say he was known to police and associated with gang activity.

Message:

- People deserve to feel safe in their communities and in their neighbourhoods.
- s.13
- We're working closely with the Mayor and with the RCMP crack down on gang and gun violence in Surrey .
- We've invested another \$500,000 in the Surrey WRAP program to support the important partnership between the city of Surrey, the school district and the RCMP to help keep youth out of gangs in the first place.
- We are also providing:
 - \$14 million for the creation of a dedicated Anti-Trafficking Task Force at the province's anti-gang agency (Combined Forces Special Enforcement Unit) that will target mid-level drug traffickers.
 - \$5 million to Provincial Tactical Enforcement Priority projects to increase enforcement against high-level organized crime, including the trafficking of illegal firearms.
- We'll ensure BC gets its share of the \$327 million the federal government is investing to tackle gun and gang violence.

Vaisakhi Appearance

Background:

- A Surrey Now article published April 25, 2018 shows a photo of four MLAs on stage at Surrey Vaisakhi celebrations with a backdrop behind them showing the word “Khalistan”.
- In the article, BC Liberal MLA Marvin Hunt says Liberal MLAs did not go on stage because of the slogan.

Message:

- A number of our MLAs attended the Vaisakhi celebrations as we do every year, along with hundreds of thousands of British Columbians.
- This was the main stage and they were invited on stage to mark the celebrations.
- While they were not there to endorse any organization’s or individual’s views on international issues, we support people’s freedom of speech and the ability to express political views respectfully and without violence.

Electoral Reform Process

Background:

- Public engagement on the electoral reform process closed on February 28th with 88,547 people participating.
- The Attorney General is preparing a report with recommendations which will be shared with the public at the same time it goes to Cabinet.
- In Question Period the Opposition has asked about involvement of AG staff in developing the questionnaire, why there is no turnout threshold, and why it may not be a single yes/no question.

Message:

- s.13

- We saw some of the highest public engagement ever in our consultation and heard from British Columbians from all across B.C.
- We will ensure that British Columbians are presented with a clear question and that every British Columbian has an equal voice.

Ride Hailing

Background:

- A letter campaign has been launched by Uber to push for ridehailing to be allowed in 2018.
- A coalition to demand legal ridesharing in BC called “Ridesharing Now BC” has also been formed by groups including the Vancouver Board of Trade, BC Business Council, Canadian National Institute for the Blind and Lyft.
- A legislature committee tabled its report and recommendations on February 15th.
- The government has received a report from Hara on the taxi industry and is reviewing it with expectation that it will be released in the Spring.

Message:

- People in our province want modern options to get where they need to go and to protect jobs that currently exist.
- For five years, the previous government refused to act on ridehailing.
- We are reviewing the work of the all-party committee and the work of Dr. Hara.
- We continue to work on a made in BC solution that ensures a level playing field for all service providers and safety and choice for consumers.

Container Trucking

Background:

- The United Trucking Association is concerned about issues with labour mobility, and industry activities.
- Government has been working on an announcement of measures to address some of the concerns in the coming days and weeks.

Message:

- Our government has heard from container truck drivers that more needs to be done to make life better for them.
- The Minister of Transportation has been working closely with drivers and all stakeholders and we will see some new steps in the coming days and weeks.

- This is an important file for drivers and moving products throughout our communities and our province.
- We took action with a new truck tag policy at the start of the year and we've been listening to feedback on how the policy is working, and impacting the industry.
- The Commissioner will be undertaking a review of the policy in the fall and make any adjustments.

Childcare

Background:

- The Child Care Fee Reduction Initiative came into effect on April 1.
- Of the contracts that were reviewed as of April 20:
 - Of the 3,300 eligible facilities in the province, 2,027 facilities applied to opt in – representing 33,000 spaces
 - 1,431 facilities have already been approved (22,072 spaces)
 - 73 facilities were rejected.
 - Ministry is working with 523 other facilities to obtain more information (10,153 spaces)
 - In addition, 490 returned contracts have yet to be processed and are not included in the statistics above (staff have not confirmed whether they have applied to opt in).
- During estimates MCFD critic Laurie Throness asked the Minister of State if the Ministry would take into account the new employer health tax when determining if a fee increase is reasonable. Minister of State Chen said yes.

Message:

- Starting this month, tens of thousands of families are seeing reduced fees for child care.
- A majority of eligible facilities have applied to opt-in and there are many more contracts that have yet to be processed.
- This is a bold new initiative, and we know there will be issues to address along the way.
- We will continue to work to help providers pass savings along to parents to make life better for families across the province.

Local Election Campaign Financing Reform

Background:

- A regulatory amendment has been made to require “continuing” elector organizations to treat operational expenses as campaign expenses during an election year.
- Since corporate and union donations already cannot be used to fund a campaign, this regulation change reduces the risk of any big money donations being used to fund campaigns.
- Elector organizations will still be able to differentiate between operational and election expenses in non-election years.
- The regulation change was announced Friday, April 27.
- Rob Shaw asked Minister Robinson why the fix only bans these contributions in election years.

Message:

- This government believes that people should be at the heart of politics, not big money.
- British Columbians agree – and they’re happy we kept our promise to ban big money in provincial and local elections.
- The change we brought in on Friday ensures that funds from corporate and union donations are not available to pay for any operational expenses of a “continuing” elector organization in an election year.
- Our government is ensuring that British Columbians have the fair elections they want, free of the influence of donors with deep-pockets.

Surrey Modular Housing

Background:

- Construction began in late April for approximately 160 units of temporary modular housing.
- The Province contributed \$13 million in capital funding and \$1 million in operational funding.
- The housing was announced in part to help address the Whalley Strip tent city. Advocates associated with the camp have been quoted saying that campers will not move to the modular housing, as it is too institutional.
- The temporary modular housing should be operational by late spring.

Message:

- There are far too many people are living on the streets or in shelters in Surrey.
- This housing will include individual units with private bathrooms, meal service, counselling and medical offices, and life and employment skills programming.
- It was important to get temporary homes built for people so they don't have to live through another winter without housing.
- We are working to identify a location for approximately 250 permanent modular homes for people in Surrey.

Surrey Transit and TransLink Phase II Investment Plan

Background:

- TransLink is briefing media on their Phase II Investment Plan on Monday, April 30. The technical briefing is taking place at 10am, followed by a news conference at 11am.
- The project cost estimates for the Newton – Guildford Line have increased from \$920 million to \$1.444 billion. This number is being released ahead of public consultations for Phase II Investment Plan.
- The principal factors contributing to the cost increases include inflation, property value increases, the entire cost for an operations and maintenance facility being fully assigned to this line, and additional costs for bus exchanges at the terminus stations.
- In an effort to understand and mitigate these cost pressures, an independent due diligence panel was retained by Partnerships BC to undertake a thorough review of the draft business case.
- The due diligence report will be incorporated into the business case work as part of the final business case submission.

Message:

- Our government remains committed to funding 40% of the capital costs of each phase of the Mayors' Council's 10-Year Vision.
- Investing in improved and expanded transit and transportation systems makes life better for British Columbians, while helping the environment and reducing congestion.
- The business cases for both the Millennium Line Broadway Extension and the line connecting Newton and Guildford to Surrey Centre are currently being reviewed.
- We are committed to working with TransLink, the federal government and the Mayors' Council on this project.

Metro Vancouver Pay and Benefits

Background:

- Media attention has focused on the pay and benefits of the Metro Vancouver Regional Board after board members voted themselves a 15% pay increase and a retirement bonus that was retroactive to 2007.
- After coverage began, there was a huge public outcry, and board members voted unanimously on April 27 to rescind the pay increase and retirement bonus.
- Local governments, including the Metro Vancouver Regional Board are autonomous and neither the Minister of Municipal Affairs nor the Auditor General for Local Governments (AGLG) has the power to review pay and benefits. The AGLG can only review the process by which pay and benefits changes were made.

Premier announces new classrooms on the way for Surrey students

SURREY – A new elementary school, two additions to existing schools and the land needed to build another school, will help ease overcrowding and improve classroom conditions for students in Surrey, Premier John Horgan announced today.

“Surrey students and their families have been waiting too long for new classrooms for their growing school district. The wait is over. We’re getting it done,” said Premier Horgan. “We are delivering the safe and comfortable schools kids in Surrey deserve.”

The Ministry of Education is investing almost \$64 million to:

- build a new elementary school in the Douglas area of South Surrey;
- expand Frost Road Elementary and Coyote Creek Elementary schools in Fleetwood; and
- buy land for a future elementary school in Grandview Heights.

“We have been working hard to accelerate the approval of capital and seismic projects throughout B.C.,” said Rob Fleming, Minister of Education. “These three projects and the land purchase will relieve pressure on the surrounding schools in Surrey, reduce the number of students learning in portables, and make life better for students, educators and parents.”

The new \$24.3-million, two-storey elementary school will be built beside Dufferin Park, and will accommodate 605 students. It will have a Neighbourhood Learning Centre (NLC) with two child-care rooms, as well as project, media and technology spaces and outdoor washrooms. This school will help relieve enrolment pressure at nearby Hall’s Prairie Elementary, Pacific Heights Elementary and South Meridian Elementary. Construction is expected to start in March 2019 and be complete by December 2020.

“Our board has been pushing hard and working closely with Minister Fleming to obtain funding for new school spaces for our students, so it is wonderful to see the government making these investments,” says Surrey Board of Education chair Laurie Larsen. “I know our trustees join our students, staff and parents throughout the Surrey School District in welcoming the announcement, and we all look forward to the next one.”

The \$5.6-million addition at Frost Road Elementary school will create six classrooms, with space for 150 more students. Four portables currently at the school will be removed at the end of construction.

Coyote Creek Elementary school’s \$4.9-million expansion will add four classrooms, creating 100 new spaces for students. Two portables will be removed once the project is complete. Construction at both Coyote Creek and Frost Road is expected to begin in April 2019, with completion anticipated in June 2020.

These three projects, combined, add up to 855 new K-7 spaces in Surrey.

The Province is also investing \$28.9 million to purchase land for a future elementary school, at the southeast corner of 20th Avenue and 165th Street. The school will be needed to accommodate the growing number of students in the South West Grandview Heights area, and will relieve pressure at the existing Sunnyside Elementary. The Surrey School District is contributing \$1.4 million toward the site purchase.

Including today's announcement, government has invested \$107 million for two new elementary schools, three additions, two seismic upgrades and a site acquisition since September 2017. These include a new \$24-million, 655-seat elementary school in Grandview Heights, and a \$9-million, 300-seat expansion at Pacific Heights Elementary school.

Quick Facts:

- Budget 2018 invests a record \$2 billion in school capital projects over the next three years.
- As of September 2017, the Surrey School District has 70,736 students in K-12, the highest student enrolment in British Columbia.

Questions & Answers Surrey Schools

Q: What are you doing to reduce the number of portables in Surrey?

- We agree that there are far too many students going to school in portables in Surrey.
- The number of portables in this district increased significantly under the previous government's watch, and we are working hard to address the backlog of badly needed capital projects here in Surrey.
- We are working with the Surrey School District and the City of Surrey to accelerate capital investment in the district and fix this problem that was ignored for too long.
- In the past five months, this government has already invested over \$107 million for two new elementary schools, three additions, two seismic upgrades and a site acquisition.

Q: Why aren't you funding an addition at Sunnyside?

- We are working closely with the Surrey School District to address their capital needs as quickly as possible.
- The future elementary school to be built on the land purchased, along with the new Edgewood Elementary School (formerly called Grandview) and addition at Pacific Heights Elementary that were announced in December will help relieve enrolment pressures at this school.
- The ministry funds capital projects in the order they are prioritized by the school district. The Surrey School District prioritized the projects being announced today before the addition at Sunnyside.

Q: The additions at Frost Road and Coyote Creek are removing six portables – four at Frost Road and two at Coyote Creek. Will there still be portables in use at the schools once the additions are complete?

- These expansions will remove all the portables currently in use at the schools.

Q: Has the Ministry reached an agreement with the Surrey School District on cost-sharing?

- We are continuing to work toward reaching a cost-sharing agreement with Surrey that works for everybody – more details to come shortly.
- We are looking forward to moving forward on projects under a new agreement.
- I'm proud of the relationship we've built with the Surrey School District.

Q: Does the Surrey School District have to contribute to these projects?

- The district is contributing \$1.4 million in land capital toward the site purchase.
- Cost sharing requirements are determined on a case by case basis and the district was not required to contribute to the other three projects we announced today.
- We are continuing to work with the district on reaching a cost-sharing agreement that benefits everybody and look forward to sharing more details on that soon.

Q: Are these projects included in the previous government's announcement of \$217 million?

- That announcement was a promise made by the previous government as part of Budget 2017 – to approve \$217 million worth of projects over three years. There were no projects actually approved as part of that announcement.
- In fact, the only project that was actually approved and funded by the previous government as part of that \$217 million was a \$26-million elementary school in Clayton Village.
- In the past five months, this government has already worked together with the Surrey School District and the City of Surrey to actually approve \$107 million in funding for two new elementary schools, three additions, two seismic upgrades and a site acquisition.

Q: Why can't you fund all of the capital projects needed in Surrey right now?

- We want to see the number of portables reduced as quickly as possible across the province and especially in Surrey, and this is a great step toward that goal.

- We have established a Project Office to manage the large volume of capital projects in Surrey.
- We will work collaboratively with the City of Surrey and the school district to find solutions to speed up new school construction.

Q: Will the ministry fund the district's capital plan of 22 projects?

- We have reviewed the Surrey School District's capital plan, and are supporting them to move forward on their highest priority projects.
- We're open to changing policies that will allow us to spend and invest more quickly in getting new schools built, while at the same time ensuring that taxpayers are getting value for their investments.
- Right now, our focus is to get a lot more schools built more quickly.
- We're looking at how to do things differently than what has been done in the past with reasonable policies that make sense not just for Surrey, but for all of the growing school districts in the province.

Q: When will you fund the rest of the seismic upgrades that are needed in Surrey?

- The safety of students, teachers and support staff is our top priority.
- We have a goal to ensure every family in B.C. can send their children to seismically safe schools.
- We inherited a backlog of seismic projects that need to be expedited, and we are getting to work on that in Surrey and across the province.
- In Surrey, 75% of high-risk schools have had their upgrades completed.
- We have supported the Surrey School District to move forward on planning for four out of the five remaining seismic projects in the district.
- We are working with the Surrey School District to find ways to accelerate funding approvals and get to work on seismic upgrades.

Q: The Surrey School District has said they are not receiving enough funding to cover increasing portable costs, and other increasing operational costs in the upcoming year. What is your response to that?

- Education is a top priority for our government and we are moving forward on improving funding for B.C.'s education system.
- We have tabled a budget that is the largest single investment in K-to-12 education in the province's history, and that has the largest capital budget in B.C. to date.
- Operating grants for school districts in 2018/2019 are set to increase to almost \$5.2 billion – up over \$130 million from 2017/2018
- Surrey is expected to receive an estimated increase of \$22.4 million in operating funding next school year, bringing the total to \$650 million for 2018/19. This is in addition to \$37 million provided to the district through the classroom enhancement fund.
- Surrey school district will also see additional savings of \$2.7 million in 2018/2019 through MSP reductions, network savings and reduced pension contributions.
- The immediate 50% cut to MSP premiums, as well as pension plan changes, and NGN savings helped Surrey school district realize \$7.2 million in savings for this school year.
- We are making investments, like today's, to create more classroom spaces to support students in Surrey.
- We are reviewing the district's five-year capital plan and working closely with the Capital Project Office in Surrey to accelerate the pace of school construction from green light to ground breaking.
- This is a transitional year as districts work to implement the Memorandum of Agreement with the BCTF and there are some unique situations and challenges.
- One of those challenges has been an increase in the number of portables in the fall as districts create smaller classes to comply with the MOA.
- We are committed to making sure the use of portables to address growth pressures is not a long-term solution.

Q: Will Government create a policy that states non-temporary portables will be funded through means other than the operating budget?

- We are looking at all of our options and working with the District to find ways to eliminate the use of portables in a way that best benefits students.

Background Note

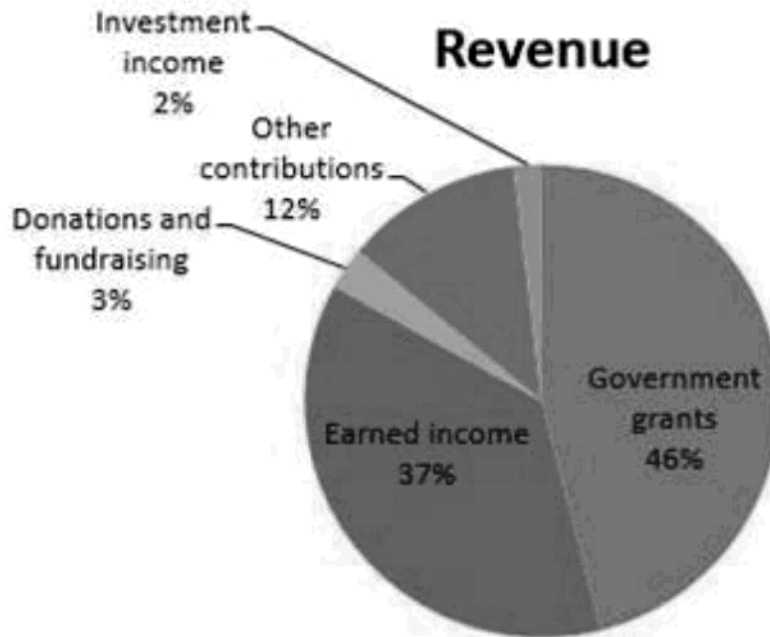
B.C. Neighborhood Houses

- Neighbourhood houses offer a variety of programs focussing on the social development of neighbourhoods.
- Neighbourhood houses operate as an “extended living room of the community”, and serve the most vulnerable people in the neighbourhood- often opening their doors to people that all other organisations have kicked out. Most programs are free, or pay what you can.
- Neighbourhood houses are place-based i.e. rooted in the local culture of the place they serve; committed to building social connections especially with those who experience social isolation; promote social justice; celebrate diversity and do not tend to be recreation focused.
- Neighborhood Houses often provide childcare services.

How Neighborhood Houses are funded:

- Budgets for individual neighbourhood houses in Metro Vancouver range from <\$500K to >\$6M.
- Funding comes from a wide range of sources. Government grants are generally program or project specific, although the City of Vancouver provides “operating” or core funding within the municipality on a three-year cycle.
- Earned income is generally comprised of fees (childcare, camping, adult day programs, etc.) and social enterprise within the charitable program (rental of surplus space, thrift stores, etc.).
- All neighbourhood houses raise the greatest majority of their revenue on one-to-three year granting cycles, short term projects or short term agreements for service. Like many non-profits, neighbourhood house staff spends an inordinate amount of time and resources seeking and securing funding.

- Provincial Government funding comes primarily from Gaming Grants. Most receive grants from MCFD, some operate social housing.
- Funding comes from the following Ministries: MCFD, SDPR, TAC, JTT, AEST, AG, MCFD, SDPR, MOH
- Below is an example of a typical Neighbourhood House funding model:



Childcare Fee Reduction Program:

- All eligible Neighbourhood Houses have opted-in. Most are in some stage of the approval process, some have just been approved, others have been asked for more information. Everyone is hopeful.
- There are over 2000 licenced childcare spaces (infant to school age) with all Neighbourhood Houses combined, and **more than 700 are eligible for the fee reduction program.**

“Our board has been pushing hard and working closely with Minister Fleming to obtain funding for new school spaces for our students, so it is wonderful to see the government making these investments,” says Surrey Board of Education chairwoman Laurie Larsen. “I know our trustees join our students, staff and parents through-out the Surrey School District in welcoming the announcement and we all look forward to the next one.”

The \$5.6-million addition at Frost Road Elementary School will create six classrooms with space for 150 more students. Four portables currently at the school will be removed at the end of construction.

Coyote Creek Elementary School’s \$4.9-million expansion will add four classrooms, creating 100 new spaces for students. Two portables will be removed once the project is complete. Construction at both Coyote Creek and Frost Road is expected to begin in April 2019 with completion in June 2020.

These three projects combined add up to 855 new K-7 spaces in Surrey.

The Province is also investing \$28.9 million to purchase land for a future elementary school, at the southeast corner of 20th Avenue and 165th Street. The school will be needed to accommodate the growing number of students in the South West Grandview Heights area, and will relieve pressure at the existing Sunnyside Elementary. The Surrey School District is contributing \$1.4 million toward the site purchase.

Including today's announcement, Government has invested \$107 million dollars for two new elementary schools, three additions, two seismic upgrades and a site acquisition since September 2017. These include a new \$24-million, 655-seat elementary school in Grandview Heights and a \$9-million 300-seat expansion at Pacific Heights Elementary school.

Quick Facts:

Questions & Answers Surrey Schools

Q: What are you doing to reduce the number of portables in Surrey?

- We agree that there are far too many students going to school in portables in Surrey.
- The number of portables in this district increased significantly under the previous government's watch, and we are working hard to address the backlog of badly needed capital projects here in Surrey.
- We are working with the Surrey School District and the City of Surrey to accelerate capital investment in the district and fix this problem that was ignored for too long.
- In the past five months, this government has already invested over \$107 million for two new elementary schools, three additions, two seismic upgrades and a site acquisition.

Q: Why aren't you funding an addition at Sunnyside?

- We are working closely with the Surrey School District to address their capital needs as quickly as possible.
- The future elementary school to be built on the land purchased, along with the new Edgewood Elementary School (formerly called Grandview) and addition at Pacific Heights Elementary that were announced in December will help relieve enrolment pressures at this school.
- The ministry funds capital projects in the order they are prioritized by the school district. The Surrey School District prioritized the projects being announced today before the addition at Sunnyside.

Q: The additions at Frost Road and Coyote Creek are removing six portables – four at Frost Road and two at Coyote Creek. Will there still be portables in use at the schools once the additions are complete?

- These expansions will remove all the portables currently in use at the schools.

Q: Has the Ministry reached an agreement with the Surrey School District on cost-sharing?

- We are continuing to work toward reaching a cost-sharing agreement with Surrey that works for everybody – more details to come shortly.
- We are looking forward to moving forward on projects under a new agreement.
- I'm proud of the relationship we've built with the Surrey School District.

Q: Does the Surrey School District have to contribute to these projects?

- The district is contributing \$1.4 million in land capital toward the site purchase.
- Cost sharing requirements are determined on a case by case basis and the district was not required to contribute to the other three projects we announced today.
- We are continuing to work with the district on reaching a cost-sharing agreement that benefits everybody and look forward to sharing more details on that soon.

Q: Are these projects included in the previous government's announcement of \$217 million?

- That announcement was a promise made by the previous government as part of Budget 2017 – to approve \$217 million worth of projects over three years. There were no projects actually approved as part of that announcement.
- In fact, the only project that was actually approved and funded by the previous government as part of that \$217 million was a \$26-million elementary school in Clayton Village.
- In the past five months, this government has already worked together with the Surrey School District and the City of Surrey to actually approve \$107 million in funding for two new elementary schools, three additions, two seismic upgrades and a site acquisition.

Q: Why can't you fund all of the capital projects needed in Surrey right now?

- We want to see the number of portables reduced as quickly as possible across the province and especially in Surrey, and this is a great step toward that goal.

- We have established a Project Office to manage the large volume of capital projects in Surrey.
- We will work collaboratively with the City of Surrey and the school district to find solutions to speed up new school construction.

Q: Will the ministry fund the district's capital plan of 22 projects?

- We have reviewed the Surrey School District's capital plan, and are supporting them to move forward on their highest priority projects.
- We're open to changing policies that will allow us to spend and invest more quickly in getting new schools built, while at the same time ensuring that taxpayers are getting value for their investments.
- Right now, our focus is to get a lot more schools built more quickly.
- We're looking at how to do things differently than what has been done in the past with reasonable policies that make sense not just for Surrey, but for all of the growing school districts in the province.

Q: When will you fund the rest of the seismic upgrades that are needed in Surrey?

- The safety of students, teachers and support staff is our top priority.
- We have a goal to ensure every family in B.C. can send their children to seismically safe schools.
- We inherited a backlog of seismic projects that need to be expedited, and we are getting to work on that in Surrey and across the province.
- In Surrey, 75% of high-risk schools have had their upgrades completed.
- We have supported the Surrey School District to move forward on planning for four out of the five remaining seismic projects in the district.
- We are working with the Surrey School District to find ways to accelerate funding approvals and get to work on seismic upgrades.

Q: The Surrey School District has said they are not receiving enough funding to cover increasing portable costs, and other increasing operational costs in the upcoming year. What is your response to that?

- Education is a top priority for our government and we are moving forward on improving funding for B.C.'s education system.
- We have tabled a budget that is the largest single investment in K-to-12 education in the province's history, and that has the largest capital budget in B.C. to date.
- Operating grants for school districts in 2018/2019 are set to increase to almost \$5.2 billion – up over \$130 million from 2017/2018
- Surrey is expected to receive an estimated increase of \$22.4 million in operating funding next school year, bringing the total to \$650 million for 2018/19. This is in addition to \$37 million provided to the district through the classroom enhancement fund.
- Surrey school district will also see additional savings of \$2.7 million in 2018/2019 through MSP reductions, network savings and reduced pension contributions.
- The immediate 50% cut to MSP premiums, as well as pension plan changes, and NGN savings helped Surrey school district realize \$7.2 million in savings for this school year.
- We are making investments, like today's, to create more classroom spaces to support students in Surrey.
- We are reviewing the district's five-year capital plan and working closely with the Capital Project Office in Surrey to accelerate the pace of school construction from green light to ground breaking.
- This is a transitional year as districts work to implement the Memorandum of Agreement with the BCTF and there are some unique situations and challenges.
- One of those challenges has been an increase in the number of portables in the fall as districts create smaller classes to comply with the MOA.
- We are committed to making sure the use of portables to address growth pressures is not a long-term solution.

Q: Will Government create a policy that states non-temporary portables will be funded through means other than the operating budget?

- We are looking at all of our options and working with the District to find ways to eliminate the use of portables in a way that best benefits students.

Background Note

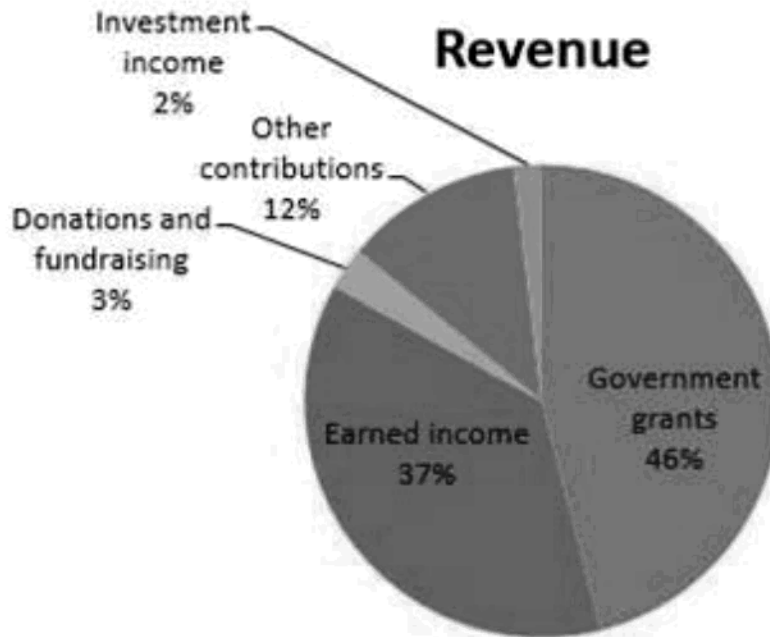
B.C. Neighborhood Houses

- Neighbourhood houses offer a variety of programs focussing on the social development of neighbourhoods.
- Neighbourhood houses operate as an “extended living room of the community”, and serve the most vulnerable people in the neighbourhood- often opening their doors to people that all other organisations have kicked out. Most programs are free, or pay what you can.
- Neighbourhood houses are place-based i.e. rooted in the local culture of the place they serve; committed to building social connections especially with those who experience social isolation; promote social justice; celebrate diversity and do not tend to be recreation focused.
- Neighborhood Houses often provide childcare services.

How Neighborhood Houses are funded:

- Budgets for individual neighbourhood houses in Metro Vancouver range from <\$500K to >\$6M.
- Funding comes from a wide range of sources. Government grants are generally program or project specific, although the City of Vancouver provides “operating” or core funding within the municipality on a three-year cycle.
- Earned income is generally comprised of fees (childcare, camping, adult day programs, etc.) and social enterprise within the charitable program (rental of surplus space, thrift stores, etc.).
- All neighbourhood houses raise the greatest majority of their revenue on one-to-three year granting cycles, short term projects or short term agreements for service. Like many non-profits, neighbourhood house staff spends an inordinate amount of time and resources seeking and securing funding.

- Provincial Government funding comes primarily from Gaming Grants. Most receive grants from MCFD, some operate social housing.
- Funding comes from the following Ministries: MCFD, SDPR, TAC, JTT, AEST, AG, MCFD, SDPR, MOH
- Below is an example of a typical Neighbourhood House funding model:



Childcare Fee Reduction Program:

- All eligible Neighbourhood Houses have opted-in. Most are in some stage of the approval process, some have just been approved, others have been asked for more information. Everyone is hopeful.
- There are over 2000 licenced childcare spaces (infant to school age) with all Neighbourhood Houses combined, and **more than 700 are eligible for the fee reduction program.**
