

The Meritorious Service Certificate is used throughout government to commemorate service milestones and is often given at the time of retirement to long standing employees. The certificates are ordered through Queen Printer by the retiring employee's ministry. They are signed by the employee's Deputy Minister and Minister and also the Premier.

In the past they have been signed by the DM, then sent along to the MO for signature with a request to move it along to the PO once signed. It would also have a note on it from the ministry indicating the date of the retirement and who it should be returned to once all signatures are in place.

I've had a question about one of these certificates and I just wanted to check with you to see if this process will work for the PO or if you would prefer a different approach. Is there someone in the PO that the certificates should be directed to in order to get them signed and returned as soon as possible?
