B.C. releases first decisions on cannabis regulation after public engagement

VICTORIA - After considering input from 48,951 British Columbians, and submissions from 141 local and Indigenous governments and a range of other interested stakeholders, the Province has announced a number of key decisions related to the anticipated legalization of non-medical cannabis in July 2018.

"Looking at the responses received, it's clear that British Columbians support the priorities of protecting young people, health and safety, keeping the criminal element out of cannabis and keeping roads safe, which will guide the Province in developing B.C.'s regulatory framework for non-medical cannabis," said Minister of Public Safety and Solicitor General Mike Farnworth.

The following policy decisions were shaped by the feedback provided by those who participated in the engagement:

### \* Minimum age

British Columbia will set the minimum age to possess, purchase and consume cannabis at 19 years old. A minimum age of 19 is consistent with B.C.'s minimum age for alcohol and tobacco and with the age of majority in B.C.

### \* Wholesale distribution of cannabis

Like other provinces, B.C. will have a government-run wholesale distribution model. The BC Liquor Distribution Branch (LDB) will be the wholesale distributor of non-medical cannabis in B.C.

## \* Retail of cannabis

The Province anticipates establishing a retail model that includes both public and private retail opportunities and will share details regarding the model in early 2018.

From Sept. 25 to Nov. 1, 2017, the public and stakeholders were asked to share their input and expertise on a range of issues related to the regulation of non-medical cannabis in B.C., including minimum age, personal possession, public consumption, drug-impaired driving, personal cultivation, wholesale distribution and retail models.

Furthermore, the policy decisions announced today reflect the feedback received from the local government members of the Joint Provincial-Local Government Committee on Cannabis Regulation (JCCR) and are endorsed by the Union of B.C. Municipalities executive.

"We thank all British Columbians who provided their input during the important public and stakeholder engagement process," said Farnworth. "We will continue to consider your opinions as we further develop policy and legislation that is in the best interests of this province, ensuring a made-in-B.C. approach to the legalization of non-medical cannabis that will keep our roads and communities safe, protect young people, and promote public health and safety."

B.C. still has a number of key decisions to make as it prepares for the legalization of cannabis. These decisions will be informed by the feedback collected through the public and stakeholder engagement, and on-going consultation with local and Indigenous governments and other key stakeholders.

Dear John Horgan,

I am a single mom of 4, college student, and I live in Sooke BC - your hometown!

I have never asked for help, and truthfully never needed it like I do now, and still I hate this.

Please let me explain our devastating situation we have been faced with (I'll do my best to keep it short).

I have a sweet little boy, his name is Landen Alexa and he is almost 7. He attends (when he can) Sooke Elementary.

This past spring, Landen rolled his ankle at a fundraising school event. A quick trip to emerg, we were told nothing serious, just a sprained ankle. If it didn't improve; we should return.

I've been a mom for 13 years. A sprained ankle was minor to me. We carried on our usual life and some Tylenol "fixed him" ... or so I thought.....

I'd love to tell you that it was weeks, or months and nothing came from that "sprained ankle" ... but unfortunately it was only 3 days before our entire world shattered faster then I could imagine. The rug was pulled from underneath us in a blink of an eye.

Landen was rushed to Victoria General Hospital on June 1 2017 with:

a fever of 103, body tremors unable to move limbs. Unable to walk. Unknown full body rash

He was admitted to acute emerg right away, and for the following TEN days - we had no answers. None. Zero. Zilch.

They talked about leukaemia, lymphoma, toxic blood, blood infection, the list goes in. I look back and don't know how we survived those days - They were desperate for answers like I was.

I met with every specialist I could have imagined, but still no answers. Landens chart was also sent to BCCH for consult.

I am certain Landen went thru millions of dollars in testing for those 10 days, and still - the doctors had no answers, I am forever grateful for those team of doctors, forever thankful. VGH has been amazing, as well as BCCH.

Watching my son suffer, be immobile and require the use of a paediatric walker was nothing short of devastating.

This was the boy, who could race a BMX faster then his dad, and in a blink of an eye, lost all capability to do so, let alone walk or use the washroom.

\*\*Landen was diagnosed June 14th 2017 with Systemic Juvinelle Idiopathic Arthrits\*\* (SJIA)

Landen now requires a medication called Canakinumab.

Cost per MONTH: \$19,000 Cost per YEAR \$228,000

MSP has denied my child who is suffering this medication.

MSP special authority has further denied my son this medication thru his specialist.

We, HAVE tried the "cheaper" drug since June 2017, and are at the point it's no longer working effectively and there is NO other option that is cheaper. Nothing.

We are in hospital several times per month. Our life is now planned around the hospital schedule. I wish that for nobody - let alone a child, who I feel was robbed by this disease.

I understand most people assume "sore joints" when told "Arthritis".

I was one of those people. I truly thought "what's the big deal".

I learnt the hard way. The very hard, unimaginable way.

It's a lifelong critical illness, less then 6 months ago, a little boy passed away from SJIA at BC Children's hospital.

Mr Horgan, this disease attacks itself, wreaking havoc on my son.

It has a fatal side diagnosis called MAS. Macrophaga Activation Syndrome. That word in itself, is my next largest fear as it could kill my son Landen.

Mr Horgan, this disease is life threatening, and very rare.

Mr Horgan, There is NO cure.

Remission is possible, but no medical professional can tell us "if or when".

Mr Horgan, this disease leaves my child with no immune system - making it potentially fatal from something as simple as a cold.

ANY illness Landen catches, he is admitted immediately on route to the hospital from Sooke.

I have never in my life written any sort of letter like this, but I am reaching a new level of desperation.

I simply don't have \$19,000 per month for medication, but please tell me; what Canadian does?

I also, never imagined in Canada I would be fighting for a drug this expensive.

And Mr Horgan, To make matters 100% worse, the packaging of this medication makes only HALF a useable dosage for Landen, and requires the other HALF, to be thrown in the garbage because the dose is simply too much. (I wish I was joking) it seems so cruel, and fraudulent. But you read correctly.

- 150mg Vial.

John I watched with interest your interview with Vaughn Palmer last night. Your performance was impressive and I would think politically successful in impressing voters.

That said , I wish Vaughn had followed up on your concern at the premier waging such a lengthy campaign, a copy of our American neighbors. I would have liked

Vaughn to have asked you whether you would repeal fixed election dates if elected. We might get back to elections when there is a clear issue requiring voters' attention. I think Stephen Harper was wrong to bring in a fixed election date law. We taxpayers paid for the long election campaign which incidentally got Justin Trudeau elected and Harper out of office. I suspect

the electors do not favour fixed election dates but favour far shorter campaigns.

The other issue I heard you on was proportional representation.

s.22 Ken Carty was later appointed by Gordon Cameron to act as an academic to help the citizens' committee on electoral reform. s.22

The citizens' committee came out for proportional representation which would give greater populated electoral boundaries to heavily populated lower mainland ridings, allowing voters to choose five or six members for these ridings. Smaller populated geographically larger ridings would get to choose two members. This discrepancy was voted down. Voters want to have their very own member. \$.22

For this reason I would support the old W.A.C. Bennett's single transferable ballot which got him elected. Once in office he repealed the system, arguing it took too long to count the ballots. It was just coincidence that keeping the system would probably have got him defeated in the next election!

Today with computers installed in every polling booth it would eliminate the length of the count, keep everyone with their own member and make every representative having over 50% or more majority. Not having a single member riding is in my view why the voters turned down the citizens' committee's proportional representation. As an afterthought I am not certain such a system is constitutional. Giving a citizen six members and another two members seems discriminatory. Since a vote is promised by the Charter and discrimination is outlawed maybe a court would find a charter violation.

Just a passing thought.

Dear Editors,

The op ed piece in Saturday's paper, written by former M.P. Lynn McDonald, raises some interesting points and voting systems for electoral reform. She mentions Scotland, Germany and New Zealand. I don't think any of those mentioned has a Charter or Bill of Rights.

Section 3 of our Charter gives every citizen of Canada the right to vote. The section has not seen much litigation but the Supreme Court of Canada has held that equality requires that no riding shall exceed or shrink, above or below, 25% of the average mean voter numbers within a province.

The proportional representation (P.R.) recommended by the Citizen's Forum and voted down by the electorate some time ago never faced a charter challenge.

While I don't propose to know the outcome, I question whether a P.R. system that gives only two candidates to vote for, in Smithers or Forts St. John, but 5 or 6 candidates to choose in Vancouver Centre or Surrey, can escape a Charter argument of voter equality. I do suggest, however, the argument is not specious.

Accordingly, I would hope that before government puts us to the cost of another referendum they find out what the courts say about their various schemes.

Premier W.A.C. Bennet's use of the old Coalitions single transferable or preferential vote resulted in him forming a minority government. The system gave a voter, in his or her riding, a second, third or fourth choice for the number of candidates running. That system later got the Premier a majority government. Thereafter he scrapped the system for obvious political reasons but successfully argued; using human counting, took too long to learn of the election's result. Today with computers located in every polling location, counting would not face that challenge. The system does give every voter an MLA in his or her riding at least 50.1% of the ballots casts.

Such a reform is likely Charter proof. I suspect the reason P.R. was turned down previously by a majority of referendum voters is many wanted their own member in their own riding. Such a system does not promote, as P.R. does, minority governments.

I am pleased to personally share with you the news that the Rio Tinto Board has approved the US\$473.6M investment to complete the Kemano Second Tunnel (T2) Project. Construction is expected to begin in Spring 2018 with some early works beginning as soon as possible in preparation. Fulfilment of the T2 project will ensure a sustainable and long-term power supply for the Kitimat smelter and certainty that Rio Tinto's operations will continue to support the economy in BC. This investment will enhance BC Works' position as a world-leading producer of low carbon aluminium through environmentally sustainable hydropower.

The second tunnel will create a back up to the original tunnel that was built over 60 years ago. This will allow us to conduct maintenance work without shutting down our operations and ensuring we can continue to responsibly manage the Nechako Watershed reservoir system. The tunnel will connect to the existing power station with no new generators being built. The T2 project does not require the use of any additional water than what is already allocated in our water license.

Rio Tinto sees the T2 project as another opportunity to ensure that our operations benefit the local regions in which we operate. # GREEN PARTY NOT THROWING IN THE TOWEL ON STOPPING SITE-C YET

The BC Green Party is not throwing in the towel yet on stopping the Site-C dam despite the decision this week by the NDP government to finish the project.

Party leader Andrew Weaver says his caucus will take the message of stopping Site-C directly to the Premier.

"We haven't given up yet our caucus is meeting with the Premier, Carole James, and George Heyman this afternoon. We are very concerned about the decision. We want to articulate again why the rationale simply does not hold water and why we are going to continue to do everything we can to get them to see the lost opportunity."

The meeting may be tense as Weaver says he is no mood to hear the government's excuses on building Site-C and may leave the talking to MLAs Sonia Furstenau and Adam Olsen.

"We want to hear directly from Carole James who will be there and George Heyman. I suspect I won't say very much here because I am frankly not in the mood to be engaging in a rationale discussion to be conned why this decision is going forward. I suspect my colleagues have a lot of questions they want answered and that is hopefully what will happen."

This week the provincial government announced it will finish building the now \$10 billion Site-C dam.
