Subject: Transition Contracts

Hi Don, most of the contracts (81% or 29 out of 36 contracts) were proactively released at the end of July. The proactive release for August and September included 2 and 5 contracts, respectively. No contract details were public released at the end of October. One outstanding contract with Nicola Hill is pending release for November. As per Core Policy 6.3.3 (e) (2),

Contracts must be in writing and signed and delivered by all parties prior to the commencement of the work or service (or, in the case of an emergency, as soon as possible thereafter).

Given the high volume of activity associated with the change in government, administrative staff tried to process the contracts expediently. Paperwork for a small number of contracts was temporarily overlooked. That has now been rectified and there are no other transition contracts that require processing.
