Hi Pierrette,

I asked Lisa Anderson (PSSG) for an update on the cannabis file, in case it comes up next week in St. Andrews. Her quick status summary is as follows:

- The federal bills are with the Senate and there will be a vote on Bill C-45 (the proposed *Cannabis Act*) on or before June 7th. We don't have a current update regarding Bill C-46 (impaired driving *Criminal Code* provisions), but expect the timing may be similar now, instead of Bill C-46 coming into force earlier.
- The federal government plans to establish a transition period following Bill C-45 receiving Royal Assent. Eight to twelve weeks is being considered, but this is unconfirmed.
- The actual day of legalization has not been determined. Best estimates are sometime from mid-August to mid-September, but subject to the federal government announcing an official date.
- In B.C., we expect legislation to be tabled in the coming weeks and we continue to work on developing the provincial regulatory framework to meet the federal timelines. (Off the record, Lisa mentioned last Friday that the expected date for tabling legislation was April 18<sup>th</sup> – the same day as the Steering Committee meeting. However, that was subject to change, and in any case her preference was to treat that date as confidential until it is made public. With the stakeholders we've been consulting with, we've said only "in the coming weeks".)
- Most other PTs have tabled legislation. Lisa wasn't sure, but she thought BC and NU may be the only ones that haven't.
