Province invests in new homes for women fleeing violence

VANCOUVER – More women and children fleeing violence will have a safe and secure place to go as the Government of British Columbia builds 1,500 new supportive homes throughout the province.

“People fleeing abuse need a safe and welcoming place to go, where they can find comfort and security to heal,” said Premier John Horgan “Our government is making the first significant investment in transition and supportive housing in 20 years, to give women and children escaping dangerous situations the security and support they need.” **NOT APPROVED**

As part of the B.C. government’s 30-point housing plan, the Province will invest \$734 million over the next 10 years to build and operate 1,500 new units of much-needed housing including transition houses, safe homes, second-stage and long-term housing. The new housing will include support staff that will provide a range of services, including emotional support and safety planning to make sure women and children receive the help they need during a difficult and stressful time in their lives.

“It’s heartbreaking to know that women and children who are in distress are being turned away from housing because there aren’t enough spaces available,” said Selina Robinson, Minister of Municipal Affairs and Housing. “Addressing this need is a priority for our government. We look forward to working together with our valued non-profit partners and municipalities to build this much-needed supportive housing in communities throughout British Columbia.” **DRAFT**

“Fleeing violence often results in poverty and homelessness for women and their children,” said Joanne Baker, executive director, BC Society of Transition Houses.

“Secure, stable housing can provide a foundation for recovery and economic empowerment. The reality or risk of homelessness frequently results in women

returning to violence – that means the Province’s investment in affordable housing that is dedicated to women and children escaping violence is crucial.”

The new women’s housing will be operated by non-profit providers who specialize in housing and supports for women and children who are experiencing or at risk of violence. BC Housing is sending out an expression of interest to select the non-profit operators.

The Province, through BC Housing, will select projects based on community need, with the goal of building at least 500 supportive housing units within the next three years, and 1500 over the next decade.

Quick Facts:

- Women’s transition houses are staffed 24/7 and provide safe, short-term shelter and supports – typically for 30 days – for women and children fleeing violence.
- Safe homes provide safe, short-term shelter and supports – typically for 10 days – for women and children fleeing violence in rural and remote communities.
- Second-stage housing provides safe short-term housing and supports for women after they leave an abusive relationship or situation. Women can stay for six to 18 months while they prepare for independent living.
- The Province has set a target of creating 114,000 new homes, including affordable market rental, non-profit, co-op, supportive social housing and owner-purchase housing through partnerships over 10 years.
- Budget 2018 launched the biggest investment in housing affordability in B.C. history – more than \$7 billion over 10 years.

In short: Bill 12 is unconstitutional and we will challenge it in the courts.

It is with the deepest concern that I learned that Legislative Assembly of Alberta will today pass Bill 12 (the "*Preserving Canada's Economic Prosperity Act*"). Bill 12 has been described by your colleague, Margaret McCuaig-Boyd, the Minister of Energy, as a device "to restrict resources to B.C., to inflict economic pain upon them." Statements by Minister McCuaig-Boyd and other representatives of your government make it clear that this attempt to restrict the flow of refined fuels, crude oil and natural gas across the Alberta-British Columbia border is intended to punish the residents of British Columbia because our government has asked the British Columbia Court of Appeal to provide guidance regarding the constitutional jurisdiction of provincial legislatures to regulate hazardous substances brought into their provinces by means of interprovincial undertakings.

On February 22, when our government's intention to bring a reference to the British Columbia courts was first announced, Premier Notley expressed her confidence that the Alberta government's constitutional position would prevail in court. At that time, she expressed, on the part of your government, a desire to resolve our disagreements through the legal process and suspended retaliatory measures against BC wine. Bill 12 is a step back towards trying to resolve differences through threats of economic harm, rather than by having the best argument in a court of law. While I of course respectfully disagree with Premier Notley's assessment of the legal merits of our proposed legislation, I strongly urge your government to take the course of submitting any disagreements to the courts of this country, rather than responding with threats of economic harm that can only hurt Albertans and British Columbians.

I am confident that the Constitution of Canada prevents any province from attempting to resolve a legal dispute by inflicting economic harm through trade sanctions. Bill 12 is manifestly unconstitutional. Section 92A (2) of the *Constitution Act, 1867* permits provincial laws in relation to exports to another part of Canada of the "primary production" of non-renewable natural resources, but only if such laws do not "authorize or provide for discrimination in prices .../2

or in supplies exported to another part of Canada." As a vehicle for such discrimination against British Columbia, Bill 12 is beyond the powers of the Alberta Legislature. Further, Bill 12 purports to restrict trade in refined fuels, which are not covered by section 92A. Bill 12 also violates the guidance of the Supreme Court of Canada in *R. v. Comeau*, 2018 SCC 15, which states that provinces can enact laws that have effects on interprovincial trade for legitimate reasons, such as the health and safety of its residents or the protection of its environment, but not for "punishing another province" (para. 111).

I would urge your government to commit not to proclaim Bill 12 into force until it has referred it to the Alberta courts to assess its constitutionality, as our government has done in relation to proposed amendments to our *Environmental Management Act*. In the absence of such a commitment, I intend to instruct counsel to bring an action challenging its constitutional validity in the courts of Alberta.

I further urge you to advise Minister McCuaig-Boyd to refrain from taking or directing any action under an unconstitutional statute that could irreparably harm British Columbians or other Canadians, until its validity can be judicially assessed. The legislation contains a provision that attempts to shelter Alberta public officials from legal responsibility for their actions. However, as you know, there are constitutional limits to the ability of a province's legislation to immunize those who deliberately inflict harm on Canadians in other provinces.

> EXECUTIVE SUMMARY
> The PECC was active today at level two to support the Central (CTL), South East (SEA), South West (SWE) and North (combined NEA/NWE) Provincial Regional Emergency Operations Centres (PREOCs).
>
> The Provincial situation has continued to deteriorate generally today, with additional States of Local Emergency (+2), Evacuation Alerts (-1) and Evacuation Orders (+1). The forecasted warm weather has maintained the snow pack melt rates which have resulted in the continued rise of water flowrates with overland flooding in a number of river systems.

The weather forecasts remain unchanged and indicate weekend temperatures will remain 6-10 degrees above seasonal norms with mountain freezing levels rising to 3000m or higher.

> Some river flows exceeded 1 in 100 year return periods. Emergency Social Services Reception Centres (Grand Forks and Midway) and temporary accommodation capacity is being provided regionally.

> As the flooding incidents continue to spread and river flowrates remain high the province is starting to observe and respond to some lake flooding in Osoyoos and Christina Lakes who are reporting the largest impacts to residents and local businesses.

EXECUTIVE SUMMARY

The PECC was activated today at level 2 in support of the CTL and NEA PREOCs. There were again very few new developments as cooler temperatures and lowered freezing levels have left most waterways in an equilibrium state. Streamflows that increased considerably last week peaked yesterday or are peaking today. The respite is not expected to continue. With a high pressure ridge building over the next few days, temperatures and freezing levels are anticipated to rise starting tomorrow. The longer range outlook is for an extended period of temperatures in mid-20 degree to high 20s across the southern BC through the weekend and into next week. Based on these conditions, the models forecast that streamflows across the province are expected to be stable or drop slightly this week and then rise again next week.

CTL Region did not conduct a coordination call today and continued community outreach and support to those currently affected by freshet as well assistance to others who are preparing for rising waters in the next two weeks.

NEA region continued with a daily coordination call today and is fully supporting regional communities. High water levels will be sustained for the at least the next two day in Baker Creek that flows into Quesnel and West Road (Blackwater) River, where 1 in 100 year returns have been exceeded. Aviation assets remain on standby to support communities in the Nazko Valley where there have been significant impacts to the road networks.

BCWS crew support has been tremendous but has reached capacity until additional crews arrive for training and employment. Contracted crews are being employed to provide additional capacity. The province has arranged for six additional sandbag machines from the province of Saskatchewan and additional flood protection assets are being procured to add to the provincial inventory. Regional staging areas in Prince George and Kelowna are being considered to facilitate the timely delivery of flood protection assets at short notice. The province is also continuing support additional FLNRORD Water Stewardship surveillance of watersheds and dams through BCWS aviation resources.

An Emergency Social Service call centre has been established in the PECC to provide advice to evacuees and vendors who provide support.

PROVINCIAL SITUATION (New information in this report appears in blue)

The EMBC Central Region (CTL) and North East Region (NEA) Provincial Regional Emergency Operations Centres (PREOC) are activated to support local government dealing with current flood and landslide events caused by a combination of increased temperatures, precipitation and snowmelt at higher elevations. Warming temperatures are forecast for later this week, and will lead to another period of increased snow melts towards the end of the week and into the weekend.

There are now 263 homes under Evacuation Order (Order) and a further 373 homes on Evacuation Alert due to freshet and flooding related events.

CENTRAL REGION (CTL)

- **CTL PREOC** remains activated to level 2 in support of regional EOC's response to flood and debris flow incidents
- **Regional District of Central Okanagan Declaration of SOLE** (expires May 5) There is also an **Evacuation Order** in place for 12 properties on Westside Rd North due to a landslide
- **The Lower Nicola Indian Band issued a BCR** in response to rising waters and potential flooding issues. An **Evacuation Alert** is in place for 58 properties
- **The Village of Cache Creek SOLE** (expires May 5th) Heavy machines are working in three different locations to help redirect water flow and mitigate further damages.
- **District of Summerland: A SOLE remains in effect due to the threat of flooding on Eneas Creek**
- **Regional District Okanagan-Similkameen (RDOS):**
 - **Electoral Area B:** has a **SOLE** in place (expires May 5th) Flooding is reported in numerous areas and debris has been reported potentially blocking Barcelo Creek located near Upper Bench Road. There is also a log jam reported at Keremeos Creek Bridge on Agur Road. The armouring of Cawston Dike is ongoing. Sandbagging continues with assistance from local FD and BCWS crews
 - **Electoral Area C:** A **SOLE** (expires May 7th) remains in effect due to the threat of flooding and debris flows. 18 properties remain under an **Evacuation Order** in the Sportsmen's Bowl Road and area and 115 properties are under **Evacuation Alert**. A reception centre is open in Oliver to support approximately 28 residents.
 - An **Evacuation Order** was issued for one property on Green Mountain Road due to an unstable slope above. An **Evacuation Alert** is in place for one property on Gold Tau Road
 - **Sportsman Bowl Road** water levels are holding, security issues concerns expressed in the area. Helicopter assessment of debris on Tinhorn Creek planned for May 1, 2018. Roads 6 and 9 are at flood risk and engineering assessment underway. FLNRORD, MOTI and RDOS met today to develop an action plan.
 - **Electoral Area D:** A **SOLE** (expires May 3) remains in effect due to the threat of flooding and debris flow around the area of Green Lake (south of Okanagan Falls). An **Evacuation Alert** remains in effect for 16 properties. Twin Lakes levels are rising 6" per day. Engineering assessment of the site were to be conducted today. Flood maps will be created upon receiving site survey data
 - **Electoral Area H:** declared **SOLE** and an **Evacuation Order** (Expires May 5th). There are approximately 148 properties in Tulameen under order and approximately 150 under an **Evacuation Alert**. An **ESS Reception Centre** has been established in Princeton. Tiger dams and gabion basket installation to be completed in Tulameen today. 24 hour security in place today for evacuated zone and tiger dams
- **City of Armstrong:** Deep Creek has breached its banks, threatening road infrastructure and potentially flooding 4 industrial businesses, 10 properties and access to an elementary school. Mitigation work on Meighan Creek has diverted water into a farming area, protecting 90 properties. Additional mitigation works on culverts is being completed today. Water rising 3cm/day on Deep Creek, Meighan Creek is stable
- **Columbia Shuswap Regional District:** New incident in Sorrento, land flooding on Neusome Creek

- **Thompson Nicola Regional District:** PREOC staff attended Stump Lake site with engineer. High inflows to the lake is overwhelming a culvert. Multiple homes are at risk. KWL Engineering will be submitting a plan to the TNRD

NORTHEAST REGION (NEA)

- **The Northeast PREOC** was activated today in support of Local Authority's and First Nation EOC's response to flooding.
- **Xat'sull (Soda Creek),** have an **Evacuation Alert** in place for 6 homes. Continuing to monitor Hawks and Johnny Creeks and Rose Lake. Dam safe level 50cm, currently 60cm (critical 105-150cm). Increased water levels observed on Mountain House Road
- **Upper Nazko area.** The Nazko Band Council issued a **BCR** and **Evacuation Order** for 51 civic addresses in response to flooding. There is a reception centre set up at the Quesnel Reception Centre. 52 individuals have registered with ESS. Also, the Cariboo Regional District has issued a **SOLE** and an **Evacuation Order** for the Upper Nazko area due to danger from flooding and potential loss of access routes. CRD **also** activated their EOC due to flooding issues in the Rose Lake, Titetown, Nazko, Kluskus, Canim Lake and 150 Mile areas. The **Nazko First Nation** water levels appear to have dropped; expected to be temporary. Continuing to prepare sandbags. Have stakes for measuring water level changes at different locations around the community. Have requested support for sandbagging. Children and elders have evacuated; members have remained to support sandbagging. FNHA confirmed community water system remains functional and source well not impacted by flooding. Boil water advisory for wells along the river.
- **City of Dawson Creek** has been issued a task number to deal with flooding to their infrastructure, road closures. Their EOC is activated, no evacuation alerts or orders in place
- **Williams Lake Indian Band** has activated their EOC and is providing 24 hr monitoring and sandbagging of the Borland Creek area. No evacuation alerts or orders are in place
- **Ulkatcho First Nation** has water rising over the bridge – technical assessment to be completed yesterday
- **Tl'etinqox (Anaham) Government:** Anaham Creek Dam Failure affecting Alexis Creek

SOUTHEAST REGION (SEA)

- **Regional District Central Kootenay (RDCK):** An **Evacuation Alert** remains due to the mudslide that occurred April 18th on Highway 3A east of Castlegar.
- **City of Castlegar:** An **Evacuation Alert** remains in place for eight homes in Castlegar due to a landslide that occurred in Bloomer Creek in May 2017.
- **Hedde Road RDCK** landslide and flooding, 16 properties placed under **Evacuation Alert**. A private road was impacted when culverts plugged. MFLNRORD geotech identified no immediate threats to public safety. Written report expected today.

SOUTHWEST REGION (SWE)

- **District of Kent:** A **SOLE** (expires May 3) and an **Evacuation Order** remains in place for six properties due to a rockslide which occurred on November 5, 2017. Three couples (6 people) are receiving ESS. The **SOLE** and **ESS** will continue until further assessment is complete.

Outlook:

With freezing levels forecast to rise this week, stream flows will rise with more rapid snow melt. Across the south, freezing levels will hit 3500m by Wednesday, and in the central interior, they will rise to 2500m.

Wednesday, a disjointed front is drawn across northern BC out to the ocean to indicate a weak frontal boundary stretched between two relatively weak weather systems. It's expected to generate some cloud but not a significant amount of rain activity, wind, or

uplift such as would occur along a frontal boundary. The south will see some cloud, with sunny breaks.

Thursday and Friday, the warming will continue as the ridge strengthens enough to bring the sunny skies back. This added solar input will give more heat and keep temperatures rising.

In the Central Interior (Cariboo), very high flows are being observed. At the West Road River near Cinema, flows are estimated to be 430 m³/s (50-year flow) and rising. On the Bonaparte River below Cache Creek, flows are estimated to be 40 m³/s (approximately a 5-year flow), with levels easing slightly since Saturday.

Modelling is indicating the potential for flows to increase slightly on Monday, May 7th in some watersheds before a general lowering through much of the week. Warmer temperatures are forecast for later this week, and will lead to another period of increased snow melt towards the end of the week and into the weekend.

Snowmelt rates are expected to be subdued for the first part of the week, then pick up later in the week due to higher temperatures.

- Highway 3A between Keremeos and Highway 97 Junction: Mud Slide 18.5 km east of Keremeos, the road is reduced to single lane alternating traffic
- Highway 8 both directions: Washout 24 km west of Merritt. The road is reduced to single lane alternating traffic
- Big Bar Ferry closed in both directions at Fraser River due to high water and debris. Aerial car is in operation for foot traffic only

SWE Region

- Highway 99 both directions: Mud slide 15 km north of Lillooet. The road is reduced to single lane alternating traffic

5. Livestock Impacts:

NEA Region

- Expect that there are other producers in CRD order area that are not registered in the Premises ID system
- Trout Lake IR17
 - 2 horses were reported as being swept away in flood waters
 - Approximately 30 cows on site, in middle of calving period
 - Some feed available (moved to higher elevation) at present but supply is limited and regular hay supplier is now inaccessible by road; lost some feed to water damage
- Outside Order Area expect road/culvert/bridge damage will impact access to other ranches which could impact ability to access feed in the long term. This includes confirmed ranch operation west of culvert damage on Batnuni Road, approximately 270 cattle
- Advanced planning for agriculture will look at registered operations in the Baker Creek and Quesnel River area
