BACKGROUND:

Pacific Traverse Energy (PTE) is a Canadian-focused infrastructure, logistics, and marketing firm owned by Spire HoldCo, LLC (Spire), based in the United States.

PTE is developing a project in Kitimat consisting of a rail loop and inland storage system, a 12 kilometre pipeline to a floating storage and offloading facility in Douglas Channel. Total storage will be 2.66 PJ at ambient pressure and -40 degrees Celsius, servicing 25-35 ships annually (1.2 million tonnes of Natural Gas Liquids - NGLs).

Hi Don,

Thank you again for giving me so much of your time today. I'm very grateful for it and for your thoughts regarding how the Nature Conservancy of Canada and I might help us all reach the B.C. Government goals we discussed. Informal as our chat was, it got me quite excited at the possibilities.

As promised, I looked into the question of purchasing (or at least accepting from a company and "retiring") fish quotas (wild salmon ITQs and fish farm/aquaculture licences). As I guessed with you, my most experienced colleague here at NCC doesn't see any reason why we couldn't do that. He agreed with my analogy of what we have done with oil/gas offshore drilling exploration rights (e.g., Lancaster Sound - <http://www.natureconservancy.ca/en/who-we-are/news-room/news-releases/ncc-shell-lancaster.html>) and land-based mining/oil/gas rights (e.g., Flathead River Valley - <http://www.natureconservancy.ca/en/where-we-work/british-columbia/featured-projects/the-flathead-river-valley.html>). In fact, he was quite intrigued at the idea; so, if it should take on some life, please let us know.

Given the importance of wild salmon in B.C., I also want to reiterate our significant involvement in protecting B.C. lands that include all parts of wild salmon's life cycle – from spawning beds to coastal areas (e.g., our restoration work in the Campbell River Estuary - http://www.natureconservancy.ca/en/where-we-work/british-columbia/featured-projects/campbell_river_estuary.html - which now sees Chinook and Coho fry and fingerlings – and, as we discussed, our anticipated restoration work with the Haida Nation in the Kumdis Estuary - <http://www.natureconservancy.ca/en/where-we-work/british-columbia/news/healing-a-hurt-land.html>).

Finally, I have to play the "new guy" card and clarify a couple of mistakes I made:

- I think that the island we discussed was not James Island, as I suggested and which we don't own, but Grace Islet (<http://www.natureconservancy.ca/en/where-we-work/british-columbia/featured-projects/grace-islet.html>), which we care for and manage. The same colleague I've mentioned was directly involved in negotiations and he thought (hopefully correctly) that all of the nine directly-impacted First Nations were quite happy with the results of NCC being brought in to help transition the

land – in fact, he mentioned a celebratory long house feast and blanketing of our President, John Lounds.^{s.22}

Dear First Nation Leader:

We are writing to invite you to partner with the Provincial Government in informing British Columbia's adoption of the United Nations' Sendai Framework for Disaster Risk Reduction.

As you may know, the Sendai Framework, to which Canada is a signatory, has been adopted by 187 countries. It sets out an all-of-society, long-term approach to reducing the impact of disasters based on local circumstances. It is a voluntary, non-binding agreement which recognizes that the State has the primary role to reduce disaster risk, but that responsibility should be shared across society. It is the global standard on how leading jurisdictions identify and manage risks from all but conflict-driven hazards. It recognizes the increasing impact of disasters as well as their frequency and complexity in many parts of the world, including here at home. Disasters know no boundaries and have a devastating impact on Indigenous and non-Indigenous communities alike.

The attached discussion paper has been prepared for you to share widely within your organizations. It closely mirrors a draft Cabinet submission that has been prepared and is awaiting input from your communities before it is submitted for formal Cabinet consideration. We trust that the discussion paper outlines the Province's intentions to engage in a true partnership with you on a topic that has such a profound impact on our communities. The objective is that together, we can make our people and communities more resilient in many important ways.*

We ask that you please write to inform us by April 30, 2018 if you support, in principle, British Columbia's adoption of the Sendai Framework and to please nominate a representative from your organization to take part in a more formal and structured engagement on the implementation of the Framework for the benefit of all British Columbians.

In closing, we are honoured to request your partnership in this important initiative.

You had asked for further info on International Year of the Salmon as well as the ministry's potential ideas that the province could take on.

As you heard from DFO's MO, plans are still in motion but here is what we have so far. I note this is on roundtable next week so we can discuss then.

International Year of the Salmon (IYS) Update:

- North Pacific Steering Committee & IYS Working Group Meetings took place last month. These meetings were held to review progress in 2017, and develop funding strategies for IYS Signature Projects and research theme projects.
http://www.npafc.org/new/science_IYS.html.
- In the current planning phase, an early decision was to expand beyond Pacific Salmon to include Atlantics. This is essentially what gave rise to the international focus of the initiative. *Steelhead is included.*
- Next event is a 2-day symposium in May 2018 in Russia.
- There will be a "major event" in Vancouver in October of 2018.
 - DFO just finished a BN for LeBlanc, who will be briefed next week. LeBlanc will be in attendance. Exact date will be planned around his availability.
 - NPAFC and PSF are funding and coordinating the event.
 - The event (described as a "celebration") will be to announce/launch IYS. It will be at Jack Poole plaza. FN will be in attendance.
 - Desire to have provincial government representation. Invite coming to BC, possibly from DFO Pacific or Ottawa \
 - There are simultaneous events being planned internationally (i.e., a coordinated international launch of IYS).
 - There is a planned "excursion" to Adams River for the salmon run right after the announcement. Minister LeBlanc and others to attend. (confirmed 2018 is

expected to be an “excellent” run. Not so much for 2019).

- The October 2018 event is a replacement for the initial symposium concept (i.e., the one that was to take place in either Vancouver or London).
- We expect Minister LeBlanc to flag collaboration opportunities with BC at the next call with Minister Popham.
- Other jurisdictions (i.e., the province) can freely launch their own events in tandem with the October event.
- A number of research projects are currently being scoped out. Examples include:
 - Dick Beamish’s excursion
 - A major international workshop on climate change and salmon
 - A new tagging method called “ROAM”
- In regards to developing our own provincial initiatives, there are shared criteria (attached) for affiliating with IYS (including use of the logo). Essentially, the project must align with one of five themes and comport with the logo guidelines.

Some ideas the team generated this morning:

- Support for the Beamish excursion.
- Funding to Pacific Salmon Foundation for community-based restoration projects.
- Contribute or organize a “State of the Salmon” symposium – invite researchers from across Pacific NorthWest to discuss trends and possible management strategies.
- Funding grant program for local enhancement activities such as the work of Chris Bose (south Island anglers Association) to raise chinooks for Southern Resident Killer Whales.
- Funding to the enhancement hatchery out of Jordan River, for which we funded a coded Wire tagging program in the past. The concept here would be larger in that BC could establish a grant program for local enhancement groups and partner with DFO and others to select projects for fish enhancement and tagging programs to determine return success rates. This is an area we have long voiced concern over regarding funding shortfalls. This would not be a habitat restoration program but exclusively a local salmon enhancement and tagging program delivered by AGRI and DFO.

- Outreach activities of various kinds. One example is a licence plate campaign similar to the one currently in place for BC Parks.
- Reach out to JTT and explore opportunities to collaborate around the tourism work being done at the currently local level around the Adams run – could provide more of a provincial focus and highlight the run beyond current local initiatives (e.g., <http://www.salmonsociety.com/> or <http://shuswaptourism.ca/do/arts-culture/festivals-special-events/adams-river-salmon-run-listing>).

OPEN LETTER: UBCIC Supports the 'Namgis Bringing Their Fight to Protect Wild Salmon to the Courts.

Dear Minister LeBlanc:

The UBCIC calls on the Department of Fisheries, Oceans and the Canadian Coast Guard to immediately deny the renewal of Marine Harvest's Marine Harvest permit to transfer and restock their potentially PRV infected smolts into the pristine waters of our coast. The Union of BC Indian Chiefs (UBCIC) condemns the Federal Government for its failure to live up to its responsibility for protection of wild salmon and praises the 'Namgis First Nation for its leadership.

The 'Namgis have a vested interest in the protection of their wild salmon which is of central importance to their culture and well-being, and which is currently under threat from environmentally destructive Atlantic Salmon net-pen fish farms. The 'Namgis, after issuing numerous letters over several months with no response, have turned to the court for relief. On Tuesday, March 6, 'Namgis filed a *Notice of Application* in Federal Court seeking a judicial review of the Minister of Fisheries and Oceans' policy to not test farmed Atlantic salmon for the blood virus, piscine reovirus (PRV), prior to transferring potentially infected smolts from Marine Harvest Canada Inc.'s hatcheries into open-net pen fish farm in 'Namgis territory. Then, on March 9, 'Namgis First Nation filed a motion for an interlocutory injunction to prevent the Minister from issuing a licence to transfer the smolts into Marine Harvest's open-net pens without first testing for the blood virus, PRV, pending resolution of the judicial review.

Marine Harvest continues to operate the Swanson Island fish farm in the immediate vicinity of 'Namgis' traditional territory and without their consent, violating their Indigenous Rights as affirmed by the *United Nations Declaration on the Rights of Indigenous Peoples (UN Declaration)*. This reprehensible operation presents a significant threat to the 'Namgis' efforts to rehabilitate the already critically low wild salmon stocks on which their community relies.

Wild salmon is a foundation species for all First Nations in our province and it is a tragedy that the Federal Government has again failed to live up to commitments to respect the rights of Indigenous Peoples, the principles of reconciliation, and its lawful obligations to protect salmon.

The UBCIC has a long history and an extensive mandate to protect and safeguard the future of our wild salmon stocks, to ensure the recommendations of the Cohen Commission are enacted, and to prevent all further impacts from the open net-pen fish farm industry.

It is no longer acceptable for the Federal Government to ignore its responsibility to protect this vital resource and to follow through on their political commitments to First Nations. The Government of Canada must take action to immediately move these operations to land-based closed containment systems to save the remaining wild salmon stocks so critical to many First Nations across the Province.

My colleagues from the BC First Nations' Emergency Services Society (FNESS) are meeting Minister Melanie Mark at her legislative office on October 3, 2017 at 11:30 am.

If possible, I respectfully ask that you join this dialogue session - subject to your availability. Furthermore, I will endeavour to contact Minister Scott Fraser's office to see if he can also attend.

FYI - FNESS representatives are meeting with Minister Mark on October 3, 2017 to discuss the following in relation to advanced education and skills development with a focus on UNDRIP and the TRC Calls to Action:

- **FNESS accomplishments and experiences in leading and implementing training for employment programs with various First Nations communities and Tribal Councils in BC.** FNESS skills development programs and delivery provide training and employment in the area of community protection (e.g., wildland firefighting, fuel management, emergency management) and information technology;
- **Local knowledge and human resources.** The *2003 Fire Storm Report* (aka. The Filmon Report) outlined that "(t)he Review Team also heard concerns regarding the use of local resources from First Nations in the province. Many members of First Nations communities were willing and qualified to assist provincial firefighters with their own equipment, but claim they were not approached to do so... The Ministry of Forests should explore ways to enhance the participation of First Nations in forest fire fighting and fuel load reduction activities." (pgs. 56 – 61 - http://www2.gov.bc.ca/assets/gov/farming-natural-resources-and-industry/forestry/wildfire-management/governance/bcws_firestormreport_2003.pdf);
- **Development of BC First Nations fire officer leadership development and training.** FNESS has a solid track record in fire officer governance training and skills development – which includes the research analysis and corresponding recommendations (funded by WorkSafeBC) about competencies needed for today's BC First Nations fire officers in managing, supervising and leading their respective BC First Nations-led structural fire departments, particularly in relation to occupational health and safety program/service delivery. FNESS identified leadership criteria to assist its structural firefighting membership in understanding the current and future leadership needs for the ranks of Fire Chief, Assistant Fire Chief and Deputy Fire Chief in BC; and (ii) developed an initial competency framework for BC Indigenous fire officers to aid in their recruitment and selection, performance management, learning and development and succession planning endeavours; and
- **First Nations-specific critical incident stress management (CISM).** FNESS collaborates with the Nicola Valley Institute of Technology to advance community-based intensive workshops to provide CISM and trauma support in First Nations communities in BC.

Finally, attached is a letter dated August 3, 2017 from FNESS with regards to its respective programs and services.

It is. The Friendship Centres host an annual BC wide meeting of Indigenous youths from across the province. About 1800+ youth attended 5-6 years ago.. the number could be much more now.

I believe the Premier would enjoy speaking to them.

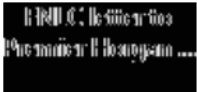
