Hi folks –

I just returned from a gathering of 70 business, healthcare, and community leaders pulled together by the Vancouver Foundation and YWCA to start organizing around Women Deliver. The conference itself is a gathering of 7000 people - supposedly the largest conference on the health, rights and wellbeing of women. It is being held in Vancouver **June 3-6, 2019**. It is expected that there will be a pre-conference focussed on Indigenous women and likely hundreds of side events.

The federal government – who has supported Women Deliver for 6 years – and is putting money towards the conference is considering naming 2019 the year of Women Deliver and they are working across Ministries to place a gender lens on all of their work. The Prime Minister will of course be speaking at the conference, and when he is here in a few weeks he will re-announce to local media the investment the federal government is making in the conference.

Based on the discussions this morning, there is a strong expectation from local leaders that the provincial government will play a significant role in the conference.

I'd like to propose the following:

- Importantly, we hold the date (June 3-6, 2019) in the Premier's calendar
- I'd like to brief PJH on the conference itself
- We make sure MLA's are aware of it and also have the date blocked off (they are very likely to hear from people about it)
- We consider a working group internally with people from both the political and civil service sides to explore the role we want /can play in the conference

Hey Layne, Sage and Roseanne,

Yesterday after the session Roseanne and I were chatting and she was talking about repurposing the PPT presentation I gave (which was really a PDF) for caucus. And potentially circulating materials.

I realized I had a one-pager/outline that I used originally to organize my thoughts that could serve as a useful reinforcer/written reminder to folks going forward. It contained a few more specifics than the slides.

It's attached. But I would appreciate you all vetting it for appropriateness for sharing and with whom!

I also included a couple of other documents that I used as 'notes' when I did the two one-on-one sessions with ministers.

There may be useful content there as well.

But here's what I'm wondering ... rather than lay all this on everyone all at once on paper (it's a lot of new content!), what do you think of the idea of using a technique that I used to use when I used to do a lot of training sessions at NOW, that I stole from the Harvard Business Review:

A 'tip of the day' email.

I have CRAPLOADS of content in my head and already written. And seventeen million different ways of saying the same thing to help make concepts stick in people's minds. (repeat, repeat, repeat)

I could very easily create a package of one paragraph tips that we can push out daily (or every other day or weekly, whatever you think is good)

It can go to all MLAs, and all political staff - and I'd include CAs, LAs, in that, too. They more people who know this stuff, the more successful we'll be long term. Maybe some of those GCPE folks that are doing political stuff - Karl and Matt's teams?

In my experience, this is one of best ways to reinforce training/learning. Keeping regular contact. Reminding people daily of the application of the principles they heard daily. Using examples and building up confidence in applying the concepts in their work every day.

Happy to discuss with you all or just leave this to you folks to decide what the best path forward is. I don't want my absence from regular attendance at the office to slow things down. And you all understand all the pluses and pitfalls of circulating this kind of stuff better than me.

When you have a recommendation we all agree on, I'm happy to do the work of writing a decision memo for Geoff to sign off on it.

A few specific thoughts from me on operationalizing this:

- My gut says evening emails, rather than morning. I think people won't even look if it's sent in the morning, they'll just blow right past it for 'real work'.
- I like the idea of keeping it just a couple of lines.
- At NOW when I did these, I made them appear to be just regular emails from me. Unformatted, chatty, like I was just speaking to the recipient personally. I like that technique and think it makes people read them and care what they say.
- We could create content so those messages come from different people depending on what the content is. Think of all the stuff you say in your job that you feel you repeat often to different people. It's good content, make it a 'tip of the day' and make sure EVERYONE sees it.

Below is a couple of sample Harvard Management Tips of the Day. They also do a 'weekly hotlist'. Their purpose is to share articles from their blog. But our purpose could be to tighten, focus and hone our performance, our collaboration, and our communications ... and build a better team.

VICTORIA - Premier John Horgan has issued the following statement about a violent attack in Las Vegas, Nev., where more than 50 people were killed and hundreds more were injured:

"The senseless acts of violence in Las Vegas are horrifying and incomprehensible. Our hearts are with all those affected by last night's shooting.

"Jordan McIllood of Maple Ridge was among those who lost their lives. He was 23 years old. The flags at the Parliament Buildings in Victoria and Provincial Government Buildings in Maple Ridge will be dropped to half-mast to honour him.

"To Jordan's family, and the family and friends of all those who have lost their lives, we offer our condolences and support.

"I want to express my heartfelt thanks to the first responders, who put themselves in harm's way by running toward gunfire in an effort to save lives.

"When dark acts seek to shake our faith in humanity, we look to those who have come forward to help. Their selfless acts of heroism are what build the strong and caring communities we all want to be a part of."
