Staff in my office recently met with representatives of the Coastal First Nations – Great Bear Initiative (CFN) to discuss the Fisheries Reconciliation Vision that CFN is proposing to Fisheries and Oceans Canada and Indigenous and Northern Affairs Canada.

Canada and British Columbia are strongly and mutually committed to reconciliation with Indigenous Peoples, including through adopting the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP), implementing the Calls to Action of Canada's Truth and Reconciliation Commission and taking all possible steps to support indigenous Canadians in achieving lasting social and economic equality.

I am excited about the potential that the CFN Fisheries Reconciliation Vision offers to advance economic reconciliation with participating First Nations while growing British Columbia's marine economy. From our initial discussions, British Columbia views the CFN proposal as a well-considered approach to pursuing economic reconciliation in thoughtful balance with existing license holders.

British Columbia is enthusiastic about sustainable growth of our Pacific marine economy in collaboration with indigenous communities and the Government of Canada. We look forward to working with your agencies, CFN, coastal communities and other parts of the sector as this proposal moves forward.
