Hello Geoff and Don,

GCPE is processing a request from a Researcher for the following: *All Internal analysis, drafts, emails, text messages, message logs, briefing notes and memorandum related to the Nov 15 letter from Dave Nikolejsin and Lori Wanamaker to the BCUC regarding the Site C Inquiry. (Date Range for Record Search: From 10/01/2017 To 11/28/2017)*

They have identified the attached records as responsive and are seeking our views concerning disclosure.

It appears the records are a synopsis of a Priorities and Accountability Cabinet Committee meeting. As such, the mandatory section 12 of the Act would apply. Section 12 allows protection of information that would reveal the substance of deliberations of Cabinet or a Cabinet Committee meeting. (Please note, information providing "background, explanations or analysis" *can* be released if the decision has been made public and/ or implemented.)

As well, we could consider applying section 13 of the Act. Section 13 allows protection of information that would reveal advice or recommendations developed by a public body or a Minister.

In my opinion, we should recommend withholding these records in their entirety under s. 12 of the Act. Can you please review to ensure you are in agreement and/ or if you see any potential release of "background" information contained within the records.
