Just left you a voicemail - I was given your number from Jon Robinson in the Premier's office.

My name is Andrea Barnett and I am contacting you on behalf of Ducks Unlimited Canada. My colleague Les Bogdan has been corresponding with Kirsten Neilson on a few matters, which I expand on in my email today.

We are scheduled to meet with Minister Heyman on May 28th, which we are grateful for and looking forward to.

Additionally, as you are likely aware, we are having a 80th/50th (National/ BC) anniversary of our conservation work in Victoria on May the 27th. This is a celebration and will <u>not be a fundraising event</u>. This will be a gathering of DUC volunteers, government, non-government, first nation and industry conservation partners as well as elected officials from all parties. Additionally, we are honoured to have the Honourable Janet Austin attending and providing an address.

We have Minister Heyman confirmed to attend, with the caveat that travel considerations may find him arriving late.

I have attached a copy of the <u>draft program for the evening</u>. You will note that we are providing a representative from each party with the chance to speak. As a celebratory event and given everyone's

mutual interest in wetland conservation, we are hoping that remarks are supportive of conservation partnerships and show commitment to moving forward with more conservation measures to help conserve wetlands in the future.

We want to set this up to be a positive event and provide the Minister and government with an opportunity to show leadership related to wetlands. You will note that, as per protocol, the government representative speaks first.

Mr. Wilkinson and Mr. Weaver are both attending and will speak.

We will provide each speaker with the following suggested range of topics:

- Support for enhanced planning, inventory, monitoring and policy measures, such as the
 development and implementation of a wetland policy for BC, that would help ensure that
 wetland values are retained in the context of development. (Development of a wetland policy is
 something that, as you know, we have been working with government on for several years with
 much support, and that we are hopeful can be a priority in the near future)
