Good morning,

As you may know, in Budget 2017 the federal government announced a new federal tax-free grant to families of first responders who die as a direct result of their duties. The objective is to recognize the service and sacrifice of Canada's first responders who die in the line of duty, including deaths resulting from occupational illness and from a psychological impairment (i.e. suicide). The grant consists of a one-time lump-sum payment of \$300,000 to the surviving families of first responders who die as a result of their duties on or after April 1, 2018.

The latest information provided by Public Safety Canada (PSC) is that the class of eligible recipients includes family members of all police officers (including RCMP), firefighters and paramedics, including all related volunteers, reservists and auxiliaries.

PSC officials will be travelling to Victoria on May 30, 2018, to meet with government officials. This is an opportunity for PSC officials to provide information on the Memorial Grant and to answer questions from provincial staff. Eligibility criteria under the Canada-BC agreement on French-language services:

Eligible projects must have a matching contribution from a provincial ministry, Crown Corporation, government agency or municipality worth at least 50% of the project's French component.

- The match can be in direct funds or in-kind, or be a combination of both
- An in-kind match must be assigned a dollar value
- Funding cannot be matched with a federal government revenue source
- In-kind contributions refer to goods and services required to deliver the project you'll provide in-house
- Funding for projects is usually provided on a one year basis
- Funding for additional years can be considered provided you submit a previous year project's evaluation report

Projects must support service development, planning and delivery in five priority areas:

- Health and Social Services
- Economic Development
- Arts and Culture
- Justice
- Communications

Founded by the "Man in Motion", this not-for-profit research organization focuses on creating more accessible and inclusive communities and supporting research aimed at better treatment and a higher quality of life for people living with spinal cord injuries. The Government proposes to provide renewed funding of \$23.6 million over four years, starting in 2018–19, through Western Economic Diversification, to support the Institute's efforts to achieve breakthroughs in spinal cord injury research and care.

The funding is allocated in \$6 million installments over four years (2018/19 through 2021/22).

Hi Bob,

Here is the timeline. We made two advance requests. The second request was based on updated cost estimates and advice from Public Safety Canada that we could request up to 50% of our estimated federal share for this event. I've attached the BC letter requesting the additional \$75M advance and the federal letter approving the \$175M advance.

Sept 18, 2017 – BC requested \$100M advance for 2017 Wildfires.

Dec 13, 2017 – Based on revised total DFAA eligible costs, BC requested an additional \$75M advance for this event (see letter attached).

Dec 15, 2017 – Feds issued an Order in Council authorizing DFAA for this event.

Dec 31, 2017 – BC rec'd two EFT payments (\$100M and \$75M).

Jan 26, 2018 – BC rec'd letter from Feds approving \$175M advance (see attached letter).

Dear Pierette

As you may be aware the Assistant Deputy Minister Committee on Emergency Management (ADMCEM) supports the Deputy Minister Committee on Emergency Management (DMCEM) who is responsible for a whole-of-government, strategic, and integrated approach to emergency mitigation, preparedness, response, and recovery efforts for all hazards and the ADMCEM leads executive-level prioritization and alignment of provincial emergency management policy, legislation, and operations to ensure that time and resources are directed towards, the most critical emergency management issues and initiatives. A number of working groups have been created to support this whole-of-government emergency management work and new ones are formed where needed.

A training and exercise working group (TEWG, TOR attached) is being established that will support the ADMCEM and lead cross-ministry coordination and collaboration related to emergency management training and exercises. This working group will also be expected to enhance operational preparedness to emergencies and disasters of provincial significance and provide regular updates and progress reports to the ADMCEM. For this TEWG, to be effective it is being recommended to have representatives from ministries who do not normally participate on ADMCEM. As such, I am asking if you are able to recommend a single representative from your ministry to participate on this Training and Exercise Working Group. Staff at EMBC have identified Manjit Khaira as a possible representative as he has worked with EMBC in other capacities.

The first meeting of this working group is scheduled for May 14th from 1:00- 2:00pm (Boardroom 3A – 940 Blanshard). Please let me, and those cc'ed, on this note who you recommend participate by May 8th so they receive any pre-meeting materials. If you have questions please contact Carol McClintock, who is the Chair of this TEWG.

Policy highlight:

Flags are not normally half-masted in British Columbia for the death of a current or former foreign or Commonwealth Head of State or Government as they are recognised by Federal jurisdiction; nor for Federal Ministers, Senators or Members of Parliament who are not from British Columbia. (However, the Premier has discretionary provisions in these cases.)
