I hope you are enjoying your Premier's Office experience again!

Senior folks at Shane's ministry encouraged me to reach out and alert you to a United Way proposal for year-end funding for a provincial program they are scaling to educate businesses on how to embed social impact / innovation in their core business.

The effort has been well received so far – it seems to be the right idea at the right time. I am advising the United Way on the initiative. To date we have engaged 125 businesses in Greater Vancouver, and now 8 companies are going through a process with us to define their social purpose and subsequently build it into their business.

The United Way has submitted a proposal to Shane for funding to scale this program in Metro Vancouver and communities across the Province. The vision is to create a social purpose ethic in business. We are engaging municipalities, Chambers and Boards of Trade on this idea, wherein they partner with the United Way to identify businesses to take the trainings. The Federal Government is interested in funding it too.

Hi Geoff,

I heard from your office that our call scheduled for tomorrow has been postponed until next Friday. I understand that you are heads down on the Throne Speech, but for a couple reasons outlined below, I hope we can speak sooner.

I am anxious to close the loop as best we can on the e-mail exchange we had Feb 1 when you were in Japan. In your reply, you indicated that you still needed to confirm internally (perhaps with the Premier as well) whether the Government of BC was in a position to match our \$5 million in private sector contributions with an additional \$5 million.

As you can imagine, this leveraging opportunity is potentially a very good news story. The BC business community getting behind the BC government's support for the legacy and leadership of Rick Hansen in the pursuit of building an inclusive British Columbia makes for a powerful storyline.

As well, as we continue pursuing private sector support, the "30 for 30" story is also resonating in a very special way which brings me back to our request to see if BC can move their gift from \$10 million to \$15 million (to be further matched by the private sector). The other question is whether you are considering elevating this for inclusion in the Throne Speech or in connection with an announcement (which we would need to map out in short order).

If we could speak sooner than next Friday that would be sincerely appreciated. Alternatively, Mike Reid, who heads up our private sector fundraising team, and I would be more than happy to come to Victoria to share

with you in person the power of the story we see emerging and the critical role the BC government plays in that.

> Dartmouth, Nova Scotia – The Government of Canada is committed to keeping our marine and coastal areas clean and safe for the benefit of current and future generations. That is why we are taking concrete action, under the Oceans Protection Plan, to protect our marine and coastal areas from potential oil spills.

> Today, the Honourable Scott Brison, President of the Treasury Board and Member of Parliament for Kings-Hants announced on behalf of the Honourable Dominic LeBlanc, Minister of Fisheries, Oceans and the Canadian Coast Guard, more than \$80 million in new science funding for new partnerships, improved knowledge and new technologies that will help mitigate and prevent marine incidents such as oil spills.

> As part of this funding, Minister Brison announced the creation of a new \$45.5 million research program to leverage collaboration among the best researchers across the country and around the world. The Multi-Partner Research Initiative will include a \$10 million-a-year research fund to bring scientists together to improve our collective

understanding of how oil spills behave, how best to clean and contain them, and how to best minimize their environmental impacts.

As part of this investment, Canada's Centre of Offshore Oil, Gas and Energy Research in Halifax, Nova Scotia, will increase its research capacity with more scientists and specialized equipment. > And finally, \$17.7 million will go towards enhancing ocean models of winds, waves and currents, so that emergency responders can accurately track spills and predict their path. Enhanced ocean modelling will also support safe marine navigation and help prevent spills from happening.

> These investments in ocean modelling, oil spill behavior, biological effects, containment and cleaning techniques will ensure that Canada has both the capability and capacity to provide the best scientific advice and tools to prevent, and respond to, oil spills.

> Geoff, In these heated times, I think it is important that Premier Horgan remind Alberta and the Canadian government that the federal government's own process, the Ocean Protection Plan, promised to B.C. as part of the mitigation of the marine risk, has barely begun.
> Public hearings have not yet been held and the justification for more anchorages in the barrier islands off the Port (Gulf Islands) has not been presented and reviewed.
> The emergency response capability (timeliness and effectiveness) for the whole Georgia Straight has not been presented and reviewed by the province, coastal communities and First Nations, many of whom have lands in the affected area.
> While the pipeline followed federal process, it did NOT cover the marine impacts of seven times more oil freighters. The seabed of the Strait of Georgia (as distinct from the Pacific Ocean) is provincial jurisdiction as determined by a Supreme Court decision.
>
> The federal government should not be out in front of its own Ocean Protection Plan process to determine emergency response, spill mitigation, increased traffic impacts in the Strait, and impacts of increased anchorages on coastal marine life and communities.

Doug Scott pulled LCLB, LDB and AGRI together following the DMs' meeting.

Our recommended approach is to move in partnership with BCWI on several of their proposals:

- 1) "activate the BC Liquor Distribution Branch, in concert with BC Liquor Stores (BCLS), to immediately implement a Buy BC: Eat Drink Local program.
 - This would include recommendations to purchase small lot wines, provide shelf space and SKUs, put up store front displays and increased advertising.
 - This could be paired with a proclamation of April as BC Wine Month
 - It would not include the recommendation for providing whole-sale pricing. This may be considered separately through the upcoming Liquor Advisory Panel
- 2) "Funding for a province-wide Buy BC: Eat Drink Local campaign to include BC agri-foods products and all certified 100% BC craft alcohol (i.e. grape wine, beer, cider, fruit wines, and (potentially) distilled products) and to bring attention to local BC products by leveraging media, creating unique events, etc."
 - AGRI has a current project in place for this. It will need to be determined whether additional funds should be provided to scale up efforts.
- 3) "Funding for programming support to increase BC VQA Wine export sales and expansion of international markets focusing on trade shows, food fairs, sales exhibitions and/or participation in events or missions."
 - AGRI has a current project in place for this. It will need to be determined whether additional funds should be provided to scale up efforts.

AGRI will draft a letter for Minister Popham that responds to BCWI's proposal and circulate to ministries for comment on Tuesday.

I spoke with Miles Prodan, BCWI, and he is positive on the proposed approach and understands why BC cannot move on some of the recommendations at this time. There is a strong interest from BCWI in partnering with LDB and AGRI on developing these initiatives. There is also a strong interest in partnering on communications.
