Hi Jen – here's your first correspondence-related item being run past you.

At the bottom of this email, you'll find a copy of an email that was sent to every MLA (all parties). He has since followed it up with an email (second one below) to cbc complaining that there was no response; therefore, the BC Gov't doesn't care about veterans. (He also didn't really wait very long before complaining about a lack of response – 5 days...)

The original email was not specifically addressed to the Premier – it went to everyone with a blanket greeting, so we would typically treat this as a cc & not generally action it. I did look into things, though, & flagged it to Kate.

This group seems to be very small, & the incident he is referring to took place at the same time as the Moose Hide event – that's why the MLAs were all walking past. I checked with the folks who book use of the Leg grounds, & this group did NOT have a booking for their event – it is their practice to not book multiple events going on at the same time. Because of it not being properly booked, it would not have appeared on the Leg intranet where they post the various events that will be taking place on the grounds for the upcoming days. And, as far as I'm aware, this group did not send any sort of notification in advance that they would be having an event.

His latest email notifying our office of the email to the cbc appears to have just been sent to our office, though.

Pls advise if you would like us to send some sort of response to his latest email.

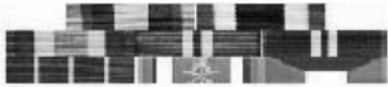

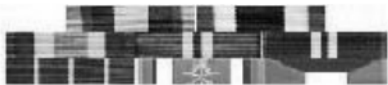

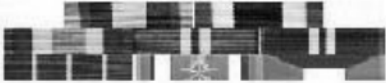
Evening MLA's

B.C. government shifts Family Day, beginning in 2019; better for business and families

VICTORIA - Starting next year, British Columbia's Family Day will be moved to the third week in February so families across the country can celebrate together, announced Premier John Horgan.

Family Day was established in British Columbia in 2013 following a consultation process that had recommended the holiday be on either the second or third Monday of February. The government of the day decided on the second Monday, even though it was inconsistent with other Canadian provinces and the United States.

In announcing the change for 2019, Premier Horgan says Family Day will now be better aligned for businesses and families.

"Moving Family Day is the right thing to do for businesses small and large, and is better for families who may be spread out across the country," said Premier Horgan. "This gives families an opportunity to schedule and spend more time with loved ones from other provinces."

Surrey Board of Trade CEO Anita Huberman welcomed the change.

"The misalignment of Family Day causes inconvenience, increased costs, and lost opportunity for businesses of all sizes and in various industries," said Huberman. "The economic benefit from this change will greatly assist our members, and especially small- and medium-sized businesses, across the province."

You're correct that, as part of a range of proposals to enhance spill preparedness and response, we announced a proposal to protect our waters by placing restrictions on the increase of diluted bitumen transportation until the behaviour of spilled bitumen can be better understood. That is – while we would convene an independent scientific advisory panel to make recommendations on how heavy oils can be safely transported and cleaned up if spilled.

This is part of a usual consultation process for regulatory proposals under the Environmental Management Act.

It's important to note that this is all still in the proposal phase while we consult. The consultation period would likely take us to the end of the year. If it went ahead at that point, the proposed temporary limitation would be a precautionary measure to help protect against possible spills while the panel does its work.

Help is on the way for B.C.'s lowest-paid workers

VANCOUVER - British Columbia's lowest-paid workers will earn a \$15-an-hour minimum wage by June 2021, Premier John Horgan announced today, endorsing the recommendations of the Fair Wages Commission.

"Regular, predictable increases to our minimum wage are one important way we can make life more affordable for people," said Premier Horgan.

"For too long, the lowest-paid workers in our province have been left to fall behind, with their wages frozen for a decade at a time. That's not fair and it's not right. Like all British Columbians, our lowest-paid workers deserve a fair shake and a fair wage."

The plan to reach \$15 an hour provides for an immediate increase of \$1.30 an hour on June 1, 2018, to a new minimum wage of \$12.65 an hour. Additional increases will take place on June 1 of each year for three more years. By June 2021, B.C.'s minimum wage will rise to at least \$15.20 an hour.

The next wage increase, on June 1, 2018, will benefit 94,000 minimum-wage earners, while increasing the minimum wage to over \$15 an hour on June 1, 2021, will benefit 400,000 workers throughout the province. The commission's scaled approach will allow businesses and employers to plan for predictable and stable increases to wages over time.

"Freezing the minimum wage for 10 years hurt people, and then increasing it in a sporadic and unplanned way hurt businesses. We are taking a balanced approach that will work better for everyone, by bringing in

measured and predictable increases over time," said Harry Bains, Minister of Labour. "I'm thankful for the incredible work done by the members of the Fair Wages Commission, who worked together to come up with a fair path forward."

The Fair Wages Commission was established in October 2017 as an arm's-length government body to help guide public engagement on how B.C. should achieve a \$15-an-hour minimum wage, and also the timeline for implementation. In a report delivered to government in January 2018, following public consultations and receipt of research and submissions, the commission recommended four minimum wage increases over four years.

The Fair Wages Commission recommended the following schedule of increases:

- \* June 1, 2018: \$12.65 an hour (\$1.30 increase)
- \* June 1, 2019: \$13.85 (\$1.20 increase)
- \* June 1, 2020: \$14.60 (\$0.75 increase)
- \* June 1, 2021: \$15.20 (\$0.60 increase)

Depending on economic conditions, the commission recommended that government consider of an additional hourly increase of up to \$.20, to \$15.40 an hour in 2021.

#### Quick Facts:

- \* Minimum wage was first initiated in B.C. in 1918.
- \* The current minimum wage is \$11.35 an hour, and applies to 4.8% of employees in B.C.
- \* Over 20% of all workers in B.C. earn less than \$15 an hour.
- \* Of those earning less than \$15 an hour, 52% are over age 25, more than three-quarters are not students, 61% are in coupled families, and over 51% have gone to college/university.
- \* B.C. has the lowest unemployment rate in Canada, the strongest job growth and a rising labour force participation rate. Total employment rose by 3.6% in 2017, twice the national pace. Private sector hiring is particularly strong, growing 4.4% last year. Yet, B.C. is a low-wage province and average wages are below the national average.
- \* 46% of minimum-wage earners work for small firms (under 100 staff), while 54% work for large employers.
- \* The four increases between 2018 and 2021 represent a 34% increase over four years.
